As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 1, 2022 and December 31, 2021, and for the period from January 1, 2022 to December 1, 2022 and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Emphasis of Matter

As discussed in Note 1(a) to the financial statements, the Plan Sponsor's Board of Directors approved a plan of liquidation with a termination date of December 1, 2022, and accordingly, determined liquidation was imminent. As a result, the Plan changed its basis of accounting as of December 1, 2022 and for the period from January 1, 2022 to December 1, 2022 to the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

(1) Description of plan

The following description of the Mills Products, Inc. 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on January 1, 1986 to provide retirement benefits for employees of Mills Products, Inc. (the "Plan Sponsor"). The Plan covered substantially all employees who were age eighteen or older and had completed ninety days of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan Sponsor's Board of Directors approved a plan of liquidation of the Plan with a termination date of December 1, 2022, and accordingly, determined liquidation was imminent. As a result, the Plan changed its basis of accounting as of December 1, 2022 and for the period from January 1, 2022 to December 1, 2022 from the accrual basis of accounting to the liquidation basis of accounting. Effective as of the date of termination, all participants were considered to be fully vested in their accounts. All participant account balances and Plan assets were transferred out of the Plan as of the termination date.

(b) Contributions

Participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or after tax in the form of Roth contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. In order to participate, employees were required to make a minimum contribution of 1% of compensation. Participant contributions were permitted up to 100% of compensation subject to certain IRC limitations.

The Plan included an auto-enrollment provision whereby all newly eligible participants were automatically enrolled in the Plan unless the participant affirmatively elected a different deferral rate or elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated investment until changed by the participant.

The Plan Sponsor made safe harbor matching contributions in an amount equal to 100% of the participant's contributions up to 3%, plus 50% of the participant's contributions over 3% that did not exceed 5%. Plan Sponsor and participant contributions could not exceed the maximum amount allowable for federal income tax purposes.

The Plan also provided that the Plan Sponsor could make profit sharing contributions each year for an amount authorized by the Plan Sponsor's Board of Directors; however, an annual contribution by the Plan Sponsor was not required. No profit sharing contributions were made in 2022 or 2021.

(c) Participant accounts

Each participant's account was credited or charged with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings (losses) of the investment options selected by the participant and an allocation of administrative expenses. Allocations were based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Prior to the approval to terminate the Plan, participants were immediately vested in their elective salary deferral and the Plan Sponsor's discretionary profit sharing contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's Qualified Automatic Contribution Arrangement non-elective and safe harbor matching contributions was based on years of continuous service. Participants vested after 2 years of credited service.

Participants could also become 100% vested upon full or partial termination of the Plan, or in one of the following ways, if incurred while employed: (1) death, (2) disability, or (3) reaching the normal retirement age of 65. Participants became 100% vested in all accounts upon the termination of the Plan as described in Note 1(a).

(e) Notes receivable from participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants were secured by the balance in the participant's account and bore interest at fixed rates ranging from 4.25% to 6.50%, which were commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution. If the value of a participant's account was less than \$1,000, the total balance was distributed as an automatic lump-sum payment in cash. For participant accounts greater than \$1,000 but less than \$5,000, the value of the participant's account was rolled into an individual retirement account on behalf of the participant, unless the participant elected to roll the funds into another qualified plan or elected to receive a lump-sum payment.

(g) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. There were no forfeited nonvested accounts as of December 1, 2022. On December 31, 2021, forfeited nonvested accounts totaled \$4,506. These accounts were used to reduce Plan Sponsor contributions or pay plan expenses. Forfeitures of \$8,823 and \$8,661 were used to reduce Plan Sponsor contributions or pay plan expenses in 2022 and 2021, respectively.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions and other administrative fees paid to service providers of the Plan are included in administrative expenses and charged directly to the participant's account. Fees incurred by the Plan for investment management and recordkeeping services were paid through a combination of direct payments and indirect payments which are included in administrative expenses or net appreciation (depreciation) in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

As described in Note 1(a) of the financial statements, the Plan Sponsor's Board of Directors elected to terminate the Plan, with the Plan being liquidated on December 1, 2022. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis to the liquidation basis as of December 1, 2022 and for the period from January 1, 2022 to December 1, 2022.

(b) Investment valuation and income recognition

Investments were stated at fair value (except for the fully benefit-responsive investment contract, which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determined the Plan's valuation policies utilizing information provided by investment advisers and Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC (collectively, "Great-West"). See Notes 4 and 5 for a discussion of fair value and contract value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year or period.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair (and contract) value of investments and notes receivable from participants held at December 1, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, interest income on notes receivable from participants, and interest and dividend income for the period from January 1, 2022 through December 1, 2022 and for the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Great-West.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The methods described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held mutual funds totaling \$3,380,167 which were classified as Level 1 investments in the fair value hierarchy as of December 31, 2021.

(5) Investment contract with insurance company

The Plan was party to a traditional fully benefit-responsive investment contract with Great-West prior to plan termination on December 1, 2022. Great-West maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for Plan withdrawals and investment expenses. The contract value of the investment contract was \$914,424 as of December 31, 2021.

The investment contract with Great-West met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as had been reported to the Plan by Great-West, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The interest crediting rate was based on the earnings of the underlying assets compared to the minimum interest crediting rate and prevailing market conditions. The interest crediting rate was reset quarterly.

The terms of the contract required all permitted participant-initiated transactions to occur at contract value. Since the contract was the obligation of Great-West, plan management believes that no event that limited the ability of the investment to transact at contract value occurred. The contract allowed participants reasonable access to their assets. The contract had no restrictions on the use of plan assets and there were no valuation reserves recorded to adjust contract amounts.

(6) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan, as amended, was designed and operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 1, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related party and party-in-interest transaction

The Plan's investment in the investment contract was managed by Great-West and, therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants, which also qualified as party-in-interest transactions.

(8) Risks and uncertainties

The Plan utilized various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility.
