Note 1: Description of the Plan

The following description of Assertio Management, LLC 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Assertio Management, LLC (Company) who have attained 21 years of age and are eligible to participate, as defined in the plan document. Effective January 1, 2021, the Plan was amended and restated. Effective with the restatement, the Plan is a 401(k) safe harbor plan, and the 401(k) safe harbor provisions will apply. The Plan was subsequently restated on January 1, 2022 and July 1, 2022.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. The Company has contracted with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) to act as the trustee of the Plan. The Company has appointed an Administrative Committee (Committee) to manage the operations and administration of the Plan.

Contributions

Participants may elect to have the Company contribute their eligible pre-tax or after-tax (Roth) compensation to the Plan up to the amount allowable under the plan document and current income tax regulations. The Plan also permits the automatic enrollment of eligible employees in the Plan with a contribution of 6% of eligible compensation, unless the employee affirmatively elects otherwise. Automatically enrolled participants' contributions will be automatically increased on or after each January 1 by 1%, up to a maximum of 15%. Contributions withheld are invested in accordance with the participant's direction. In 2022, the Company elected to make safe harbor matching contributions in an amount equal to 100% of participant contributions up to 5% of eligible compensation.

For the year ended December 31, 2022, the Company contributed \$181,293 to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the employer's matching and discretionary contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides that each participant direct the investment of his or her account in any combination into a number of investment funds. The Plan currently offers mutual funds and a common or collective trust as investment options for participants.

Vesting

Participants are immediately vested in their contributions as well as the Company's contributions under the safe harbor provisions plus actual earnings thereon. Participants are fully vested in the employer's non-safe harbor matching contributions allocated to their account after three years of credited service if hired after February 1, 2016. Participants hired before February 1, 2016, become fully vested after two years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. At December 31, 2022, the interest rates on the notes ranged from 3.25% to 5.50%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump-sum amount, monthly installments or partial withdrawals equal to the value of the participant's vested interest in their account as defined in the plan document. The Plan allows for the automatic lump-sum distribution of participant-vested account balances that do not exceed \$1,000 and for an automatic rollover distribution into a qualified individual retirement account of participant vested account balances that do not exceed \$5,000.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay plan administrative expenses or reduce future employer contributions. At December 31, 2022 and 2021, the Plan had \$3,367 and \$13,599, respectively, of forfeitures available for future use. During 2022, \$12,873 and \$7 of forfeitures were used to reduce employer contributions and pay administrative expenses, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in mutual funds are valued at quoted market prices of shares held by the Plan at year end.

Investments in the common or collective trust are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liability. The Plan's interest in the common or collective trust fund is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. The fund held various synthetic investment contracts in which the underlying investment consisted of units of various collective trust funds. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2022 and 2021.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are reported at unpaid principal balance plus accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Administrative Expenses

Administrative expenses may be paid by the Company, Plan or the participants, as defined in the plan service agreement. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan.

Note 3: Information Certified by the Trustee of the Plan

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021
- Investment income (loss) components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedules.

Note 4: Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The fair value of mutual funds is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Party-in-Interest

Certain plan investments are shares of mutual funds and units of a common or collective trust managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Investment-related expenses are included in net depreciation in fair value of investments. Administrative expenses paid by the Plan during 2022 totaled \$63,233.

Note 6: Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Note 7: Plan Termination or Modification

There were significant reductions in the Company's work force during 2021. Plan management determined that partial plan terminations occurred, and the affected participants became 100% vested in their accounts.

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Note 8: Risks and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Company's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, loan repayments of \$94 were not remitted within the required time period for the year ended December 31, 2022, and contributions of \$4,834 were not remitted within the required time period for the year ended December 31, 2020. The Company has corrected these late deposits in 2022 and 2023.

Note 10: Subsequent Events

Subsequent events have been evaluated through July 5, 2023, which is the date the financial statements were available to be issued.
