## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Polymer Solutions Group Finance, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 1, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to October 1, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of October 1, 2022 and for the period from January 1, 2022 to October 1, 2022 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Note 1 - Plan Description

The following description of Polymer Solutions Group Finance, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was a defined contribution plan covering substantially all employees of Polymer Solutions Group Finance, LLC, Flow Polymers, LLC, SASCO Chemical Group, LLC, and SASWAY Transport, LLC (collectively, the "Company") who had completed 60 days of service and are age 21 or older, except those under a collective bargaining agreement and nonresident aliens. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective October 1, 2022, the Plan was merged into the Aon Pooled Employer Plan. Accordingly for 2022, the period covered by the financial statements is as of October 1, 2022 and for the period from January 1, 2022 to October 1, 2022.

#### **Contributions**

The Plan provided for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allowed participants to contribute up to 100 percent of their compensation on a before-tax or after-tax basis. Participants could also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan utilized automatic enrollment upon reaching eligibility at 3 percent of compensation. The deferral percentage automatically increased 1 percent each year until reaching a maximum of 7 percent of compensation. The participant had the option to opt out of the automatic enrollment or change the deferral percentage.

The Plan provided for employer matching contributions in a discretionary amount to be determined by the Company. Effective January 1, 2022, the Company adopted safe harbor provisions with respect to their employer matching contributions. The Company, under safe harbor provisions, provides employer matching contributions of 100 percent of the first 3 percent of compensation and 50 percent of the next 2 percent of eligible compensation deferred by the participant. The Company matched employee contributions up to 7 percent of participant deferrals at a rate of \$0.50 on the dollar for the year ended December 31, 2021.

#### **Participant Accounts**

Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations were based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Participants could direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants were immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Effective January 1, 2022, participants were 100 percent vested in employer matching contributions contributed after January 1, 2022. Prior to January 1, 2022, vesting in the Company's discretionary matching contribution portion of their accounts, plus actual earnings thereon, was based on years of service. Participants vested in discretionary contributions made by the Company 20 percent after one year of service and another 20 percent per year thereafter until they became fully vested after five years of service.

### Note 1 - Plan Description (continued)

#### ***Benefit Payments***

Distributions were payable upon reaching age 59½, normal retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants could request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator was required to approve any such hardship withdrawals.

#### ***Forfeitures***

If a participant was not fully vested on his or her termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future company contributions or to pay administrative expenses of the Plan. The Plan used approximately \$25,900 and \$12,500 during the period and year ended October 1, 2022, and December 31, 2021, respectively, from the forfeitures account to reduce employer contributions to the Plan.

#### ***Termination***

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the trustees were to distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants would become 100 percent vested in their account balances.

#### ***Participant Notes Receivable***

Participants were allowed to borrow from their accounts subject to certain maximum and minimum amounts, as prescribed in the Plan and in the Internal Revenue Code. Notes receivable were collateralized by the participant's accounts and bore interest at a market rate.

#### ***Party-in-interest Transactions***

Certain plan assets were in investment funds managed by Empower Trust Company, LLC (formerly known as Great-West Trust Company, LLC) or its affiliates. Empower Trust Company, LLC was the custodian of the Plan; therefore, these transactions qualified as party-in-interest transactions, as defined under ERISA guidelines.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments were stated at fair value.

The common collective trust fund was valued at net asset value per share (NAV) (or its equivalent) of the fund, which was based on the fair value of the fund's underlying assets. All other investments were valued based on quoted market prices reported in active markets. See Note 6 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable were recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable were written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits were recorded when paid.

#### *Administrative Expenses*

Various administrative costs were paid by the Company. These transactions qualified as party-in-interest transactions.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including June 28, 2023, which is the date the financial statements were available to be issued.

### Note 3 – Plan Merger

During 2022, the Plan merged and combined with the Aon Pooled Employer Plan. Accordingly, all assets, participants, and their related account balances were transferred to the Aon Pooled Employer Plan on October 1, 2022.

### Note 4 - Certified Information

Empower Trust Company, LLC (the "Custodian") held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements were based solely on information certified by the Custodian.

### Note 5 - Tax Status

Prior to May 10, 2021, the Plan was a prototype plan. The prototype plan received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, was qualified for federal income tax-exempt status. The Plan did not individually seek its own determination letter. Beginning May 10, 2021, the Plan used a preapproved plan. The preapproved plan received a favorable opinion letter from the IRS indicating that the Plan, as designed, was qualified for federal income tax-exempt status. The Plan did not individually seek its own determination letter.

### Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

##### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances whereby inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
