Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hallrich Incorporated 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2022 (in liquidation), and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022, through date of liquidation, September 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of September 30, 2022, and December 31, 2021, and for the period from January 1, 2022, through date of liquidation, September 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Basis of Accounting

As discussed in Note 1 to the financial statements, plan management of the Hallrich Incorporated 401(k) Profit Sharing Plan approved a plan of liquidation and terminated effective February 23, 2022, and plan assets were liquidated through September 30, 2022. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on financial statements.

In performing an audit in accordance with GAAS, we:

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Hallrich Incorporated 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Hallrich, Inc. and North Coast Pizza, Inc. (collectively, the Company), who had completed one year of service and had attained twenty-one years of age, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Hallrich, Inc. 401(k) Investment Committee (Investment Committee) oversaw governance of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

Termination of Plan

Effective February 23, 2022, the Plan sponsor adopted a resolution to terminate the Plan and a plan of liquidation was adopted.

The Plan adopted the liquidation basis of accounting for the period from January 1, 2022, through the date of liquidation, September 30, 2022. Under the liquidation basis of accounting, assets are recorded at the amount expected to be collected and liabilities are recorded at amounts expected to be paid during the course of liquidation.

Subsequent to the election to terminate the Plan and on or before September 30, 2022, the Company paid distributions to liquidate all participant account balances. Participant account balances were distributed according to participant elections and Plan provisions.

Contributions

Each year, participants could make voluntary pre-tax and Roth contributions up to 100% of their eligible annual compensation, as defined by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants could direct the investment of their contributions into various investment options offered by the Plan. The Company could, at its discretion, authorize matching contributions. For 2022, no matching contributions were authorized. The Investment Committee could also authorize discretionary profit sharing contributions to the Plan. There were no profit sharing contributions authorized for the period from January 1, 2022, through date of liquidation, September 30, 2022. Discretionary matching and profit sharing contributions were funded in the year subsequent to their authorization. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

A separate account was maintained for each participant. Each participant's account was credited with the participant's contribution, rollover contributions, allocations of the Company's contributions, and Plan earnings or losses as defined by the Plan agreement. The Company's matching and profit sharing contributions were funded in the year subsequent to their authorization and were given only to participants employed at the end of the Plan year who had completed at least 1,000 hours of service during the Plan year. Allocations of the Company's profit sharing contributions were based on participants' compensation for the Plan year relating to the contribution. Plan earnings or losses were allocated daily based on each participant's account balance. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service, as defined. Participants vested 25% after two years of service and each year thereafter, resulting in 100% vesting after five years of credited service. Upon termination of the Plan in 2022, all participants became fully vested in all contribution types.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account. The loan interest rate, determined at inception, was set at Prime (3.25% at December 31, 2021) plus 1%, as defined, in accordance with the Plan's loan policy. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon termination of the Plan, participants received a lump-sum distribution equal to their account balance in accordance with the participants' election and the Plan provisions. Prior to the Plan termination, upon termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period, subject to certain limitations, as defined. If the participant's account balance was between \$1,000 and \$5,000, the plan administrator made an automatic rollover of the account balance to a qualified individual retirement account. If the participant's account balance was less than \$1,000, the plan administrator directed the custodian to make a lump-sum distribution. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions of a participant's 401(k) account balance could be authorized at any time by the plan administrator under certain hardship conditions.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (Continued)

Forfeited Accounts

Forfeited non-vested accounts could be used to reduce administrative expenses or to reduce future employer contributions. At December 31, 2021, forfeited non-vested accounts totaled approximately \$3,400. During 2022, approximately \$3,400 was used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting for the period from January 1, 2022, through date of liquidation, September 30, 2022, and on the going concern basis of accounting as of December 31, 2021.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits – in liquidation and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All Plan assets were liquidated by close of business on September 30, 2022. During 2022 prior to the liquidation and as of December 31, 2021, investments were reported at fair value as reported by Reliance Trust Company (Reliance), the custodian of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determined the Plan's valuation policies utilizing information provided by investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold during the year.

Assets of the Plan were held in separate accounts of a trust administered by Reliance as of December 31, 2021, representing investments in mutual funds and a stable value collective trust fund.

NOTES TO THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2021. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Plan Expenses

The Plan's administrative expenses were paid either by the Plan or the Company as provided by the Plan agreement. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Income Taxes

In accordance with GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any significant uncertain position that more likely than not would not be sustained upon examination by the IRS. As of September 30, 2022, and December 31, 2021, and for the period from January 1, 2022, through date of liquidation, September 30, 2022, the Plan did not have a liability for unrecognized tax benefits. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Subsequent Events

Plan management has evaluated subsequent events through June 26, 2023, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY CUSTODIAN

Information related to investments from participants disclosed in the accompanying financial statements and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022, through date of liquidation, September 30, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, the custodian.

NOTES TO THE FINANCIAL STATEMENTS

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2 Other significant observable inputs including: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 Inputs are significant and unobservable (including the Plan's own assumptions used to determine value)

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: The stable value fund is composed primarily of collective investment funds which invest in fixed income instruments, and fully benefit-responsive investment contracts. The stable value fund is valued at the NAV of units of the bank collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets measured at fair value were comprised of Level 1 mutual funds at December 31, 2021, totaling \$6,254,263, and a stable value collective trust fund, measured using NAV as a practical expedient, which totaled \$118,044 at December 31, 2021.

NOTES TO THE FINANCIAL STATEMENTS

4. FAIR VALUE MEASUREMENTS (Continued)

The Plan did not hold any Level 3 assets during the period from January 1, 2022, through date of liquidation, September 30, 2022.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Reliance and JPMorgan Invest Holdings, LLC (JPMorgan). Reliance was the custodian and JPMorgan was the recordkeeper, as defined by the Plan and, therefore, such transactions qualify as party-in-interest transactions.

JPMorgan provided certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and JPMorgan. JPMorgan received revenue from mutual fund service providers for services JPMorgan provided to the funds. This revenue was used to offset certain amounts owed to JPMorgan for its administrative services to the Plan.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

6. TAX STATUS

The Plan had adopted a pre-approved plan provided by the Great-West Trust Company, LLC (Great-West). Great-West had received an opinion letter dated June 30, 2020, from the IRS stating that the prototype plan, as then designed, is acceptable under applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees.
