Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Primco Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Plan Description

The Primco Inc. 401(k) Profit Sharing Plan (the "Plan") is a defined contribution plan covering eligible employees of Primco, Inc., (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information. The Company was acquired by Heritage Group in October 2021. Therefore, there were no longer any employees or contributions after that date.

Eligibility

To be eligible to participate in the Plan, employees must have been 21 years of age or older and have completed one year of service. Participants may have entered the Plan on January 1, April 1, July 1, and October 1 after eligibility requirements were met. Employees hired under a prevailing wage contract were eligible to participate upon date of hire.

Contributions

Participants could make voluntary pre-tax and Roth contributions of up to 100% of compensation limited to the applicable limit under the Internal Revenue Code. The Company could make a safe harbor contribution of 3% of participant eligible compensation. The Company could also make additional discretionary profit sharing contributions. The Company also could make prevailing wage contributions. There were no contributions for the period ended June 15, 2022 due to the Company sale and merger.

Participant Accounts

Each participant's account was credited with the participant's contribution, the Company's safe harbor contribution, prevailing wage contributions, an allocation of the profit sharing contribution (if any), Plan earnings and administrative expenses. Allocations of the Company's profit sharing contribution, Plan earnings and administrative expenses were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant could direct contributions into a variety of investment options offered by Charles Schwab Bank, the custodian of the Plan. All amounts in participant accounts are participant-directed. Participants may change their investment options daily.

Notes Receivable from Participants

The Plan allowed participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only two loans could be outstanding from the Plan per participant, one of which was available for general purposes and one for hardship or necessity. Loans were typically for terms up to 5 years, but may have been for a longer period, not to exceed 15 years, if the purpose of the loan is for the purchase of a principal residence. The loans bore interest at a fixed rate equal to 1% above the prime rate and were secured by the participant's interest balance in the participant's account.

Vesting

Participants were immediately vested in their elective (voluntary) contributions, the Company's safe harbor contributions and prevailing wage contributions. Participants became 20% vested in the Company's profit sharing contribution after two years of service and increased by 20% a year until they become 100% vested after six years of service.

Forfeitures

Participants who terminated employment prior to becoming fully vested forfeited a percentage of their profit sharing contributions. These forfeitures were used to reduce Company contributions or Plan expenses. Forfeitures used to reduce Company contributions and/or expenses amounted to \$0 for the period ended June 15, 2022. Forfeitures available to reduce future Company contributions were \$0 and \$8,894 for the period ended June 15, 2022 and the year ended March 31, 2022, respectively.

Benefit Payments

Benefit payments were payable as a single lump-sum payment or partial payments. The full value of a participant's account was payable upon retirement, death or disability. For termination of service due to other reasons, a participant may have elected to receive a lump-sum amount, a joint and survivor annuity or a pre-retirement survivor annuity. Participants may also have elected to receive in-service distributions upon attaining age 59 1/2.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 15, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is offset by the participant's vested account balances to the extent permitted by law. The Plan Administrator will treat the loan as repaid to the extent of any permissible offset and, pending final disposition of the loan, the participant remains obligated for any unpaid principal and accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Payment of benefits to participants is recorded when requested.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Certain distribution fees are paid by the Plan and allocated to each participant. Certain investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan Administrator has evaluated events and transactions for possible recognition or disclosure through June 13, 2023, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the custodian, Charles Schwab Bank, and was not subjected to any auditing procedures performed by the independent public accounts.

- a. Total investments as shown in the accompanying statements of assets available for benefits.
- b. Total investment loss, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividend income and net realized and unrealized depreciation in fair value of investments.

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at June 15, 2022 and March 31, 2022.

Money market fund: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

Mutual funds: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

Note 6. Income Tax Status

The Plan, which is a prototype plan, obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code (IRC) and therefore not subject to tax. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 15, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 7. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

The Company was acquired by Heritage Group in October 2021. As a result, the Plan Trustees approved a merger of the Plan assets into the Heritage Group Retirement Savings Plan, effective June 15, 2022. As a result, the Plan terminated and all assets were transferred.
