Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Henkels & McCoy Group, Inc. Profit Sharing/Employee Voluntary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 27, 2022 and December 31, 2021, and for the period ended September 27, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of Henkels & McCoy Group Inc., the plan's sponsor, voted on December 24, 2021 to terminate the plan effective December 29, 2021. Plan assets were fully distributed to plan participants as of September 27, 2022. As a result, Henkels & McCoy Group, Inc. Profit Sharing/Employee Voluntary Savings Plan used the liquidation basis of accounting in presenting the accompanying financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Henkels & McCoy Group, Inc. Profit Sharing/Employee Voluntary Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

(1) Description of Plan

The following description of the Henkels & McCoy Group, Inc. Profit Sharing/Employee Voluntary Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all eligible employees of Henkels & McCoy Group, Inc. (the Company). The Plan was originally established on July 1, 1982. To be eligible for participation in the Plan, employees must have attained the age of 18, completed three months of services, and not (1) be covered by a collective bargaining agreement; (2) be leased employees, as defined; or (3) be independent contractors. Employees were eligible to receive employer matching contributions after attaining 18 years of age and completing one year of service. Employees were eligible to receive profit sharing contributions after attaining 18 years of age and completing 1,000 hours during one year of service. Eligible participants had to be employed on the last day of the Plan year in order to receive an allocation of the profit sharing contribution, if one is made.

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee was responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

The Plan was amended and restated effective October 6, 2021 to comply with the Bipartisan Budget Act of 2018 and other regulatory changes.

Plan Termination

On December 24, 2021, the Company's majority shareholders and Board of Directors unanimously agreed to terminate the Plan effective December 29, 2021 (Plan Termination) pursuant to the terms and conditions of the acquisition of the Company by MasTec, Inc. on December 30, 2021. All participants affected by the Plan Termination became fully vested in their accounts. All participant balances were distributed as of September 27, 2022. Provisions described below are prior to the Plan Termination.

Contributions

Participants could contribute to the Plan up to 50% of their compensation, subject to the maximum allowable under Internal Revenue Code (IRC). Participants could elect to have their deferrals be either pretax or Roth contributions to the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions (rollovers) from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Plan included an auto-enrollment provision whereby all eligible employees who had not made an elective deferral election were automatically enrolled in the Plan on the first day of the month following the date the eligibility requirements were met, unless they had affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in the applicable target retirement fund, until changed by the participant.

The Plan included an auto-increase provision whereby on January 1 of each plan year, the participant was deemed to have made an annual election to increase their deferral by an additional 1%, up to a maximum of 12%, unless the participant had requested a deferral change within the six-month period ending on December 31 of the year before the increase. Automatically enrolled participants could elect not to participate in the auto-increase provision.

The Company made a matching contribution for each eligible participant in an amount equal to 50% of employee contributions not to exceed a maximum employer contribution of \$2,000. Effective May 1, 2020, matching employer contributions were discretionary. The Company could also make a discretionary annual profit sharing contribution to the Plan which was allocated to the participants in proportion to their eligible compensation, as defined, for the plan year. Contributions were subject to certain limitations. No profit sharing contribution was made for the period ended September 27, 2022.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company contributions, as well as an allocation of plan earnings. Participant accounts could also be charged with an allocation of certain administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their employee and employer matching contributions plus actual earnings thereon. Prior to the Plan Termination, vesting in the Company's profit sharing contributions, if any, was based on years of service according to the following schedule:

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balances in the participants' accounts and bore interest at rates that ranged from 5.25% to 7.50%, which were commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were paid ratably through weekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or their beneficiary could elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount, or in installments over a period of time, as defined. In-service withdrawals were available in certain limited circumstances, as defined by the plan document. Hardship withdrawals were allowed for participants incurring an immediate and heavy financial need, as defined.

Revenue Credit Program

The Plan instituted a Revenue Credit Program, which provided income in situations where recordkeeping revenue earned in connection with Plan services exceeded agreed-upon compensation, Fidelity Management Trust Company (Fidelity) would deposit any excess revenue, regardless of source, in a Plan level suspense account (i.e., Revenue Credit Account) in the Plan. The plan administrator could then direct Fidelity to pay qualified Plan level expenses or allocate unused credit to eligible participants via funds from this Revenue Credit Account. During 2022, \$35,066 was allocated from the Revenue Credit Account to pay expenses. The Revenue Credit Account had a balance of \$43,084 as of December 31, 2021.

Forfeited Accounts

If a participant terminated employment with the Company before becoming fully vested in the Company's contributions, the non-vested amounts were forfeited and used to first pay administrative expenses, if so directed by the Company, then reduce future employer contributions. Forfeited nonvested accounts as of December 31, 2021 are \$207,525. During 2022, administrative fees were reduced by \$71 from forfeited nonvested accounts. During 2022, forfeited nonvested accounts amounting to \$167,394 were allocated among the remaining participants as part of the Plan Termination, in accordance with plan provisions, prior to September 27, 2022.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenue and expenses during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 27, 2022 and December 31, 2021. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses incurred in connection with the administration of the Plan are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has performed an evaluation of subsequent events through December 20, 2022, the date the financial statements were available to be issued.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, as complete and accurate, except for comparing such information to information included in the Plan's financial statements. The following information was certified by Fidelity as complete and accurate:

- The investments at fair value at December 31, 2021.
- Fully benefit-responsive investment contract, at contract value, at December 31, 2021.
- Notes receivable from participants at December 31, 2021.
- Net depreciation in fair value of investments for the period ended September 27, 2022.
- Dividend income for the period ended September 27, 2022.
- Interest income on notes receivable from participants for the period ended September 27, 2022.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Registered investment companies: Valued at the daily closing price as reported by the fund. The registered investment companies held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust fund: Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV.

(5) Guaranteed Investment Contract with Insurance Company

The Plan entered into a benefit-responsive group annuity insurance contract with Prudential Retirement Insurance and Annuity Company (PRIAC). PRIAC maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal as well as interest at a specified rate that is guaranteed to the Plan. The portfolio is primarily invested in public bonds, commercial mortgages and private placement bonds.

Because the insurance company general account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets in liquidation available for benefits attributable to the insurance company general account. Contract value, as reported to the Plan by PRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed income fund reported at contract value totaled \$15,609,922 as of December 31, 2021.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract crediting rate is announced in advance and is guaranteed for a six-month period. The net crediting rate as of December 31, 2021 was 1.51%, which included an asset charge of 0.14% as of December 31, 2021.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include contract discontinuance, Plan termination or significant layoffs. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. There is no stated maturity date.

(6) Prohibited Transactions

During 2021, the Company failed to remit certain participant contributions to the Plan in a timely manner, as defined by ERISA. These transactions are considered prohibited transactions. The Company consulted with the legal counsel and refunded missed contributions to participants in November 2022.

(7) Related Party Transactions and Party-In-Interest Transactions

The Plan's investments include shares of registered investment companies managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investments.

(8) Tax Status

The Plan used a prototype plan document sponsored by FMR LLC (FMR). FMR received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
