**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Lincoln Manufacturing 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of September 9, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended September 9, 2022, and the related notes to the financial statements (collectively, the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Annuity Insurance Company of America as of September 9, 2022 and for the period from January 1, 2022 to September 9, 2022, and Massachusetts Mutual Life Insurance Company as of December 31, 2021 stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – PLAN DESCRIPTION

The following description of Lincoln Manufacturing 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2018 and is a defined contribution plan covering substantially all employees of the Company. The Plan is sponsored by Lincoln Manufacturing, Inc. and other adopting employers are Lincoln Manufacturing of Ohio, Inc., All American Inflatables, Inc., and U.S. Grant Management, LLC, all of which are collectively hereafter referred to as the “Employer” or the “Company”.

Effective March 31, 2022, the Company terminated the Plan (the “Termination”). In connection with the Termination, the Plan was frozen whereby new participants were not allowed to enter the Plan and all contributions were ceased.

During August 2022, the Company entered into an automatic rollover services agreement with Millennium Trust Company. Individual IRA accounts were set up for participants that maintained a balance in the Plan. On September 9, 2022, any remaining participant account balances were distributed out of the Plan and rolled over into individual IRA accounts for each respective participant. As of September 9, 2022, the Plan had no assets.

Prior to the Termination, the purpose of the Plan was to provide employees with retirement benefits. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Unless specifically defined otherwise in the Plan Document, employees became eligible to make salary deferral contributions upon the completion of sixty days of service and having attained the age of 18. Once an employee became eligible to participate in the Plan, the employee could enroll into the Plan on the first day of the month coinciding with or next following the date the employee became eligible unless the Company is notified otherwise by the employee.

Contributions

Prior to the Termination, participants could contribute from 1% to 100% of their pretax annual compensation, as defined in the Plan, through salary deductions; however, annual contributions may not exceed the maximum allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were able to contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

Prior to the Termination, the Plan included a Roth 401(k) feature which allowed employees to contribute funds on a post-tax elective deferral basis, in addition to, or instead of, pre-tax elective deferrals. The Roth 401(k) feature allowed for tax free growth and distribution provided the post-tax contributions had been invested for at least 2 years and the employee had reached the age of 59 ½.

Prior to the Termination, the Company, at its discretion, could make discretionary matching contributions equal to a percentage of the participant’s elective deferrals. Additionally, the Company could make discretionary profit-sharing contributions which would be allocated to participants based on the relative compensation of all participants eligible to receive a discretionary profit-sharing contribution. For the period ended September 9, 2022, the Company did not make a discretionary matching or profit-sharing contribution.

NOTE 1 – PLAN DESCRIPTION – CONTINUED

Participant Accounts

Prior to the Termination, separate accounts were maintained for each participant. Participant accounts were credited with the participant contributions, rollover contributions, and allocations of Company contributions and investment earnings and losses and charged with withdrawals and administrative fees. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Vesting

Prior to the Termination, participants were immediately vested in their voluntary contributions and rollover contributions, and actual earnings or losses thereon. Participants hired prior to the partial plan termination in 2020 were 100% vested in all employer contributions plus actual earnings thereon. For participants hired subsequent thereto, vesting in the Company's matching contributions and profit-sharing contributions and actual earnings or losses thereon were based on years of continuous service. A participant was 20% vested after two years of credited service, increasing 20% each year thereafter until becoming fully vested after the sixth year of credited service as defined in the Plan Document. However, if a participant died, or became disabled prior to attaining the normal retirement age, as defined by the Plan, the participant's account became 100% vested if still employed by the Company as of such date.

Investment Options

Prior to the Termination, upon enrollment in the Plan, participants directed the investment of their accounts among various investment options provided under the Plan. Participants were able to change their investment elections at any time, as well as transfer existing balances between investment funds.

Notes Receivable from Participants

Prior to the Termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Loan transactions were treated as a transfer between investment funds and the loan fund. Loan terms ranged from one to five years or longer for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Each participant could only have one loan outstanding at any time. Loan repayments were made by check or paid ratably through payroll deductions.

Payment of Benefits and Withdrawals

Prior to the Termination, upon termination of service due to death, disability or normal retirement, a participant or their beneficiary could elect to receive an amount equal to the value of the participant's full account balance, regardless of years of credited service. For termination due to other reasons, participants could receive the sum of their contributions and any earnings thereon, plus the vested portion of Company contributions. Payments of benefits were made, at the election of the participant, either in the form of a lump-sum distribution or payment in equal periodic installments.

Prior to the Termination, a hardship withdrawal, if approved, could be made on employee deferral contributions to satisfy certain immediate and heavy financial needs, as defined, up to the amount of the participant's vested balance. An unrestricted withdrawal could be made at the age of 59 ½ on the portion of the participants' vested account, or upon normal retirement age of 65 on all or a portion of the participants' vested account.

Forfeitures

At September 9, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$64, respectively. Prior to the Termination, these accounts could either be used to pay administration fees or to reduce future discretionary matching and profit-sharing contributions. For the period ended September 9, 2022, administrative expenses were reduced by \$64.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The net change in fair value of investments is reported in the statement of changes in net assets available for benefits in the period of the change.

Purchases and sales of securities were recorded on a trade-date basis. Expenses related to the purchase or sale of investments are added to cost or deducted from proceeds. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 9, 2022 and December 31, 2021. Prior to the Termination, if a participant ceased to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan Document.

Payment of Benefits

Prior to the Termination, benefit payments to participants were recorded when paid.

Expenses

Prior to the Termination, certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. Prior to the Termination, the Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measured fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Due to the Termination, the Plan did not hold any assets as of September 9, 2022. The following is a description of the valuation methodologies used for assets measured at fair value for the year ended December 31, 2021.

*Pooled Separate Accounts:* Investments in pooled separate accounts are represented by a “unit of account” and per unit values whose value is the result of the accumulated values of the underlying investments. These underlying investments are public investment vehicles valued using the NAV provided by the administrator of the mutual fund investments. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the Pooled Separate Accounts are valued using NAV as a practical expedient, disclosure of fair value levels is not required.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – ADMINISTRATION OF PLAN ASSETS

For the year ended December 31, 2021, the Plan’s assets were managed and certified by Massachusetts Mutual Life Insurance Company (“Mass Mutual”).

The Plan’s assets were managed and certified by Empower Annuity Insurance Company of America (“EAIC”) for the period from January 1, 2022 through September 9, 2022.

Mass Mutual and EAIC are collectively hereafter referred to as the “Custodians”.

Administrative functions for the Plan were performed by Loren D. Stark Company, Inc. (“LDSC”). Certain administrative expenses, including loan administration fees, are paid by the participants. Other administrative expenses, such as accounting and legal fees, are paid by the Company.

NOTE 5 – INFORMATION CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The following information included in the accompanying financial statements and supplemental schedule were obtained from data that has been prepared and certified to as complete and accurate by the Custodians.

NOTE 6 – PARTIES-IN-INTEREST

Prior to the Termination, the Plan’s investments were managed by the Custodians and, therefore, these transactions qualify as party-in-interest transactions which are exempt from being prohibited transactions by ERISA.

Prior to the Termination, the Plan incurred expenses related to general administration, recordkeeping, and investment advisory services. Fees paid by the Plan for these services totaled \$2,410 for the period ended September 9, 2022. These transactions are exempt from being prohibited transactions by ERISA.

NOTE 7 – RISK AND UNCERTAINTIES

Prior to the Termination, the Plan invested in various investment securities for its participants. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – FEDERAL INCOME TAX STATUS

Prior to the Termination, the Plan was a prototype plan sponsored by LDSC. LDSC received a determination letter from the Internal Revenue Service (“IRS”), dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Prototype Plan has been amended since receiving its determination letter. The Plan itself had not received a determination letter from the IRS. However, the Plan’s management and tax counsel believed that the Plan is currently designed and operated in complete compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s management believes it is no longer subject to income tax examinations for years prior to 2019.
