## Independent Auditors' Report

To the Administrative Committee of the

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of **Powertek Corporation 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ## Notes to Financial Statements

---

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Powertek Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Powertek Corporation (the "Company") who have completed three months of service, except for certain employees who are union employees, nonresident aliens, leased employees, and independent contractors. Employees may enter the Plan on the first day of the month subsequent to satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute up to 90 percent of their annual eligible compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a safe harbor 401(k) Plan where the Company matches 100 percent of the first three percent of eligible compensation and 50 percent of the next two percent of eligible compensation that a participant contributes to the Plan. The Company may make additional discretionary contributions. There were no discretionary contributions to the Plan year ended December 31, 2022. Profit sharing amounts are determined annually at the discretion of the Company. There were no profit sharing contributions to the Plan year ended December 31, 2022. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions, the Company's safe harbor contributions, as well as additional Company discretionary contributions, if any, allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings and losses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based upon the ratio of each participant's compensation to the total compensation of all eligible participants in the allocation group, with each participant being their own group. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions and the Company's safe harbor and discretionary contributions, plus actual earnings thereon. Vesting in the Company profit sharing contribution is based on years of continuous service of at least 1,000 hours per year. A participant is 20 percent vested after two years of service is completed and vests an additional 20 percent per year until full vesting after six years of service.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prevailing interest rates at the time of issuance. Principal and interest are paid through payroll deductions.

**Payment of Benefits:** Benefits are payable upon retirement at age 65, early retirement at age 55, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, substantially equal installments, and partial withdrawals.

**Forfeited Accounts:** At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$11 and \$11, respectively. These accounts will be used to pay Plan expenses or to reduce future Company contributions. During 2022, no forfeited non-vested accounts were used to pay Plan expenses or reduce Company contributions.

### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants represent participant loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events:** The plan administrator has evaluated subsequent events through July 7, 2023, the date the financial statements were available to be issued.

### NOTE 3 – CERTIFIED INFORMATION

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information related to investments and notes receivable from participants held at December 31, 2022 and 2021, and investment loss and interest income on notes receivable from participants for the year ended December 31, 2022, disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information prepared by Reliance Trust Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Funds:* Valued on the net asset value on the last business day of the Plan year provided by the bank holding the trust funds. The net asset value of the common collective trust is used as a practical expedient to estimate fair value and is determined by the trustee based on the fair value of underlying assets in the trust, less its liabilities.

Investments in all common collective trust accounts can be redeemed immediately at the current net asset value for participant transactions. Full redemption by the plan sponsor may require an advanced written notice to the custodian. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2022 and 2021.

There were no transfers between level 1, level 2, and level 3 investments during the years ended December 31, 2022 and 2021.

### NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

During 2022, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as exempt party in interest transactions.

The Plan established a plan expense agreement with ADP, LLC ("ADP"), under which ADP pays to the Plan a portion of the revenue earned by ADP under its service agreements with investment funds offered under the Plan. Income of \$7,524 was received under the agreement for the year ended December 31, 2022. As of December 31, 2022, the Plan has unallocated funds of \$7,794 that resulted from income earned under the agreement. These amounts are made available to the Plan to pay Plan expenses. These transactions qualify as exempt party-in-interest transactions.

### NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

Contracts which employed over 20 percent of the Company's employees ended at various times during 2021 and 2022. As a result, employees assigned on these contracts were terminated and the plan sponsor determined that a partial termination of the Plan occurred. All affected plan participants were fully vested in their account balances as a result of the partial plan termination.

### NOTE 7 – TAX STATUS

The Plan is a prototype plan which received an updated opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
