Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pacific Logistics Corp PLC 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2022 (date of Plan merger) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1 through September 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure under ERISA*. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a qualified institution, such as the bank or similar institution or insurance carrier, in accordance with 29 CFR 2520.103-5 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure under ERISA*.

Management has obtained a certification from a qualified institution as of September 30, 2022 (date of Plan merger) and December 31, 2021, and for the period from January 1, 2022 through September 30, 2022 (date of Plan merger), stating that the certified investment information, as described in Note B, to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As further discussed in Note A of the financial statements, Pacific Logistics Corp. signed a purchase agreement with Omni Logistics, LLC. on December 28, 2021, and the acquisition was completed on September 30, 2022. The Plan elected to transfer its remaining assets to Omni Logistics, LLC's 401(k) Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note A—Summary Description of Plan

The following description of the Pacific Logistics Corp PLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General—The Plan is a defined contribution plan covering all employees of Pacific Logistics Corp (Company) who have reached age 21 and have completed at least six months of employment. Eligible participants may enter the Plan on the first day of each Plan year quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration—The trustee of the Plan is John Hancock Life Insurance Company. The trustee also performs participant recordkeeping and other administrative duties for the Plan. The Company appoints a committee comprised of officers of the Company to administer the Plan.

Contributions—Participant contributions to the Plan (voluntary contributions) are deferrals of the participant's compensation made through direct reductions of compensation in each payroll period. Each year, participants may make annual contributions of pre-tax compensation limited to a maximum amount of the lesser of \$19,500 or 100% of the participants' compensation as defined by the Plan. For the purposes of the Plan for the period from January 1, 2022 through September 30, 2022 (date of Plan merger), compensation in excess of \$290,000 is not taken into account. Participants aged 50 and older may make catch-up contributions to the Plan, up to \$6,500 in 2022. The Company may make matching contributions, but has elected not to do so for the period from January 1, 2022 through September 30, 2022 (date of Plan merger).

Participant Accounts—Each participant's account is credited with the participant's contribution, employer contribution, plan earnings and forfeitures of terminated participants' nonvested accounts. Allocations are based on participant contributions or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a Wells Fargo common collective trust investment.

Notes Receivable from Participants—Notes receivable from participants represent the amount due to the Plan from the participants. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the employee's vested balance. The maximum number of loans a participant may have outstanding is two. Loan terms range from one to five years for a general-purpose loan, and six to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month before the loan originated. The interest rates ranged from 4.25% to 6.50% during the period from January 1, 2022 through September 30, 2022 (date of Plan merger) and for the year ended December 31, 2021. Principal and interest is paid ratably through monthly payroll deductions. Loans are offset against the participant's account and the related portion does not share in any income, expenses, gains, or losses (other than the interest on the loan) which are realized by the Plan. The entire unpaid principal amount of the loan will become immediately due upon either the participant's termination of employment or a default in payment of either principal or interest. Loans are recorded at their unpaid principal balance, plus any accrued but unpaid interest.

Vesting—Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service based on a six-year graded schedule.

Note A—Summary Description of Plan—Continued

Forfeited Accounts—Forfeited non-vested accounts are used to reduce Company contributions. Forfeitures are reallocated to participants in the same plan year. There were no forfeited non-vested accounts at September 30, 2022 (date of Plan merger) and December 31, 2021. There was no forfeiture activity during the period from January 1, 2022 through September 30, 2022 (date of Plan merger).

Payment of Benefits—Participants may withdraw a certain portion of their account while employed. The portion that can be withdrawn depends whether the employee is aged 59½ and upon the source of funds. The withdrawal cannot exceed the current value of the total account. Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period of not more than the participant's and/or beneficiary's life expectancies. For termination of service or other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution, as installment payments, or leave the funds in the Plan until a later date.

Administrative Expense—The Company pays the majority of administrative expenses associated with the Plan. The Company is not obligated to pay these costs in the future and may, at its discretion, elect to have the Plan pay these costs.

Note B—Plan Acquisition

On September 30, 2022, Pacific Logistics Corp. completed a definitive acquisition agreement ("Purchase Agreement" or the "Acquisition") with Omni Logistics, LLC. Existing Pacific Logistics, LLC employees who became Omni Logistics, LLC employees were eligible to participate in the Omni Logistics, LLC 401(k) Plan on October 1, 2022. Per the terms of the Purchase Agreement, the Pacific Logistics, LLC Board of Directors adopted a resolution effective August 24, 2022 to merger the plan, making liquidation of the Plan imminent. Effective September 30, 2022 (date of Plan merger), all balances of participants in the Plan were transferred to the Omni Logistics, LLC 401(k) Plan.

The following net assets were transferred as a result of the September 30, 2022 Plan acquisition with Omni Logistics' 401(k) Plan:

Note C—Summary of Significant Accounting Policies

Basis of Accounting—Management has prepared these financial statements in conformity with accounting principles generally accepted in the United States (U.S. GAAP) on behalf of the Plan.

Income Tax Status—The Plan used a prototype defined contribution plan document provided by Wells Fargo during 2016 and from January 1, 2017 through June 5, 2017. On June 6, 2017 the Plan was amended to change to the prototype defined contribution plan document provided by United Retirement Plan Consultants (URPC). URPC received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which states that the prototype defined contribution plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself had not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Note C—Summary of Significant Accounting Policies—Continued

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2022 (date of Plan merger) and December 31, 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value is the price that would be received on the sale of an asset or paid to transfer a liability in an orderly transaction between market participants on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recognized when earned.

Excess Contributions Payable—Excess contributions payable represents amounts owed to participants for contributions in excess of amounts allowed by the IRS which has been recorded as a reduction in contributions. There were no excess contributions payable at September 30, 2022 (date of Plan merger) and December 31, 2021.

Payment of Benefits—Benefits are recorded when paid. There were no benefits payable at September 30, 2022 (date of Plan merger) and December 31, 2021.

Risks and Uncertainties—The Plan utilizes various investments instruments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investments securities will occur in the near term, which could materially affect the amounts reported in the financial statements.

Use of Estimates—The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note D—Information Prepared and Certified by the Trustee

The following summary of unaudited information relating to the Plan was included in the financial statements, and prepared by or derived from information prepared by John Hancock, the Plan trustee, and furnished by the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

- a. Investments as indicated on the statements of net assets available for benefits as of September 30, 2022 (date of Plan merger) and December 31, 2021 and in Notes D and E;
- b. Investment income and net appreciation in fair value of investments indicated on the statement of changes in net assets available for benefits for the period from January 1, 2022 through September 30, 2022 (date of Plan merger);

Note E—Fair Value Measurements

In determining the fair value of assets and liabilities, the Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible. The Plan determines fair value based on assumptions that market participants would use in pricing an asset or liability in the principal or most advantageous market.

Note E—Fair Value Measurements—Continued

When considering market participant assumptions in fair value measurements, the following fair value hierarchy distinguishes between observable and unobservable inputs, which are characterized in one of the following levels:

Level 1—Quoted market prices in active markets for identical assets or liabilities. Level 1 assets include equity securities and mutual funds valued at the closing price reported on the active market on which the individual securities are traded.

Level 2—Observable market-based inputs, either directly or indirectly, but are other than quoted prices in actively traded markets. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and other observable inputs that can be corroborated by observable market data.

Level 3—Unobservable inputs that are supported by little or no market activity which are significant to the fair value of the asset or liability. Unobservable inputs reflect the best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The Plan utilizes a practical expedient, Net Asset Value (NAV) per share (or its equivalent, for measuring the fair value of investments in investment companies for which the investment does not have a readily determinable fair value. In some instances, the NAV may not equal the fair value that would be calculated under fair value accounting standards.

The following describes the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used as of September 30, 2022 (date of Plan merger) or December 31, 2021.

Pooled Separate Accounts—Pooled separate accounts are valued at net asset value (NAV) per share, or its equivalent of the funds, which is based on the fair value of the fund’s underlying assets less its liabilities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. There are no redemption restrictions or unfunded commitments on these investments. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no investments at fair value or NAV as a practical expedient as of September 30, 2022 (date of Plan merger).

Transfers between Levels—The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the period from January 1, 2022 through September 30, 2022 (date of Plan merger) and December 31, 2021, there were no transfers between levels.

Note F—Related Party Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company, the Plan trustee, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services totaled \$36,332 for the period from January 1, 2022 through September 30, 2022 (date of Plan merger).

Notes receivable from participants also qualify as party-in-interest transactions but are exempt from prohibited transaction rules under ERISA.

Note H—Subsequent Events

The Plan's administrator has evaluated subsequent events through June 30, 2023, which is the date the financial statements were available to be issued, and concluded that no material subsequent events have occurred that would require adjustment to the financial statements or disclosure in the notes to the financial statements.
