**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Coastal Sunbelt Produce Company 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined-contribution plan that covers employees of Coastal Sunbelt Produce, LLC, Coastal Sunbelt, LLC, East Coast Fresh, LLC, and Lancaster Foods, LLC (collectively referred to as the Company), provided the employee is at least 18 years old and attains certain minimum levels of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective September 23, 2022, the Plan merged into the SYSCO Corporation Employees' 401(k) Plan. Participants' account balances were automatically transferred into new accounts established with the new Plan administrator and mapped to the appropriate target date fund based on the participants' birth dates and assumed retirement age of 65. Participants were able to reallocate their investments once enrolled into the Plan.

**CONTRIBUTIONS**

Each year, participants may make pre-tax and Roth contributions up to the annual limitations defined in the Internal Revenue Code. In addition, participants may rollover distributions received from other plans. The Company provides a safe harbor matching contribution that matches 100% of participants' compensation up to 3% of the participants' compensation plus 50% of compensation that exceeds 3% up to 5%. The Company may also make discretionary profit-sharing contributions for active participants in the Plan who attain a minimum of 500 hours of service and are employed by the Company on the last day of the Plan year.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any Company contributions. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**VESTING**

Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions. A participant generally becomes fully vested in the Company's discretionary contributions upon four years of service, early retirement, disability (as defined by the Plan), or death of the participant.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions in various investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

**PAYMENT OF BENEFITS**

Upon termination of service, a participant is entitled to receive a lump-sum amount equal to the vested portion of the participant's account.

**FORFEITED ACCOUNTS**

At December 31, 2021, forfeited non-vested accounts totaled \$3,104. These accounts are used to reduce future Company contributions or pay administrative expenses in accordance with the Plan Document. At September 23, 2022 and December 31, 2021, the Plan expenses were reduced by \$108 and \$448 from forfeited non-vested accounts, respectively.

**ADMINISTRATIVE EXPENSES**

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF PRESENTATION**

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**BENEFIT PAYMENTS**

Benefits are recorded when paid.

**RISK AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

**NOTE 4 VALUATION OF INVESTMENTS**

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at September 23, 2022 and December 31, 2021.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 TAX STATUS**

The Plan received a determination letter dated March 31, 2008 wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan was amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of September 23, 2022.

**NOTE 6 RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management, administrative, custodial, and accounting fees to parties in interest. The Plan paid \$137,283 to parties in interest for the period ended September 23, 2022. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Coastal Sunbelt Produce Company 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined-contribution plan that covers employees of Coastal Sunbelt Produce, LLC, Coastal Sunbelt, LLC, East Coast Fresh, LLC, and Lancaster Foods, LLC (collectively referred to as the Company), provided the employee is at least 18 years old and attains certain minimum levels of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective September 23, 2022, the Plan merged into the SYSCO Corporation Employees' 401(k) Plan. Participants' account balances were automatically transferred into new accounts established with the new Plan administrator and mapped to the appropriate target date fund based on the participants' birth dates and assumed retirement age of 65. Participants were able to reallocate their investments once enrolled into the Plan.

**CONTRIBUTIONS**

Each year, participants may make pre-tax and Roth contributions up to the annual limitations defined in the Internal Revenue Code. In addition, participants may rollover distributions received from other plans. The Company provides a safe harbor matching contribution that matches 100% of participants' compensation up to 3% of the participants' compensation plus 50% of compensation that exceeds 3% up to 5%. The Company may also make discretionary profit-sharing contributions for active participants in the Plan who attain a minimum of 500 hours of service and are employed by the Company on the last day of the Plan year.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any Company contributions. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**VESTING**

Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions. A participant generally becomes fully vested in the Company's discretionary contributions upon four years of service, early retirement, disability (as defined by the Plan), or death of the participant.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions in various investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

**PAYMENT OF BENEFITS**

Upon termination of service, a participant is entitled to receive a lump-sum amount equal to the vested portion of the participant's account.

**FORFEITED ACCOUNTS**

At December 31, 2021, forfeited non-vested accounts totaled \$3,104. These accounts are used to reduce future Company contributions or pay administrative expenses in accordance with the Plan Document. At September 23, 2022 and December 31, 2021, the Plan expenses were reduced by \$108 and \$448 from forfeited non-vested accounts, respectively.

**ADMINISTRATIVE EXPENSES**

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF PRESENTATION**

The accompanying financial statements are prepared on the accrual basis of accounting.

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**VALUATION OF INVESTMENTS**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**BENEFIT PAYMENTS**

Benefits are recorded when paid.

**RISK AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

**SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through June 30, 2023, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE**

Fidelity Management Trust Company is the Trustee for the Plan. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. That information was not audited by the Plan's independent auditors. As of September 23, 2022 and December 31, 2021, certified investment information consisted of the following:

**NOTE 4 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at September 23, 2022 and December 31, 2021.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 TAX STATUS**

The Plan received a determination letter dated March 31, 2008 wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan was amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of September 23, 2022.

**NOTE 6 RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management, administrative, custodial, and accounting fees to parties in interest. The Plan paid \$137,283 to parties in interest for the period ended September 23, 2022. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net depreciation in fair value of investments.
