REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of the
StonePoint Materials, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of StonePoint Materials, LLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of December 12, 2022 and December 31, 2021, and the related statement of changes in net assets in liquidation for the period from January 1, 2022 to December 12, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 12, 2022 and December 31, 2021, and for the period from January 1, 2022 to December 12, 2022, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan's records and procedures were not adequate to support the historical build-up of net assets and participant accounts. Further, as a result of changes in systems, changes of ownership, record retention policies, and material weaknesses of the Plan's internal control, management was unable to provide sufficient appropriate audit evidence of the Plan's participant data including proper plan participant eligibility and enrollment, participant elected deferral amounts, proper definitions of compensation, reconciliation of payroll records to the Plan records, participant rollover contributions were made for appropriate amounts, and that contributions to the Plan were made for appropriate amounts in a timely manner.

Management was unable to provide sufficient appropriate audit evidence that distributions to participants were for appropriate amounts or complied with provisions of the Plan. Similarly, management was unable to provide sufficient appropriate audit evidence that employer matching contributions were made for appropriate amounts in a timely manner. As a result of these matters, we were unable to determine the completeness and inclusion of all eligible participants or that their accounts within the Plan were fairly stated. Additionally, as a result of these matters, we were unable to determine whether any adjustments might have been found necessary to properly state the Plan's net assets in liquidation as of December 12, 2022 and December 31, 2021, or the changes in net assets in liquidation for the period from January 1, 2022 through December 12, 2022.

Accordingly, we were unable to apply auditing procedures sufficient to determine the extent in which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Plan Termination and Liquidation Basis of Accounting

As discussed in the Notes the financial statements, the plan sponsor elected to terminate the Plan, effective April 8, 2021, and management determined that liquidation is imminent. As a result, the Plan's financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

NOTES TO FINANCIAL STATEMENTS

December 12, 2022 and December 31, 2021

A. Description of the Plan

The following brief description of the StonePoint Materials, LLC 401(k) Plan (the “Plan”), formerly known as VantaCore Partners, LP 401(k) Plan. It provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan was effective April 1, 1997, and most recently restated effective January 1, 2015 and was a defined contribution plan available to all employees of the Company and affiliate employers who attained age 18 and completed one month of service. All employees of the Company were eligible to participate in the Plan, except for union employees and employees that are nonresident aliens. Eligible employees could enter the Plan coinciding with or on the first day of the subsequent month after eligibility criteria are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan was to encourage the Company’s employees to save and invest, systematically, a portion of their compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

The Plan was previously sponsored by VantaCore Partners, LP. On December 11, 2018, VantaCore Partners, LP was acquired by StonePoint Intermediate Holding, LLC (the “Company,” “StonePoint,” or “Plan Sponsor”). The Plan was amended, effective January 1, 2020, to designate StonePoint as Plan Sponsor, rename the Plan as the StonePoint Materials, LLC 401(k) Plan, and to include multiple participating employers. The Company’s corporate offices are located in Philadelphia, Pennsylvania.

StonePoint was acquired by Arcosa Materials, Inc. effective April 9, 2021. As a result, the Board of Directors of StonePoint approved the termination of the Plan effective April 8, 2021. As of the termination date, all elective deferrals and employer contributions, excluding any contributions necessary to correct any prior compliance errors or issues applicable to the Plan for periods occurring before the termination date ceased, accrual of benefits ceased, no new participants were enrolled in the Plan, and all participants became fully vested in their accounts. Further information regarding the termination and liquidation of the Plan is described in Notes D and G. The description of the Plan below is qualified in its entirety by the termination of the Plan.

A. Description of the Plan – continued

Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. Eligible participants may make a rollover contribution to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to the limitations imposed by the Code.

The Company may make discretionary profit-sharing contributions to the Plan as determined annually by its Board of Directors. Participants must be: (1) 21 years of age, (2) have one year of service, and (3) employed on the last day of the year, and (4) complete 500 hours of service during the year; or have died, retired, or suffered disability during such year to be eligible to receive discretionary profit-sharing contributions. The Company made no discretionary profit-sharing contributions to the Plan for the period from January 1, 2022 to December 12, 2022.

The Company may make discretionary matching contributions to the Plan as determined annually by its Board of Directors. Participants must be 21 years of age and have one year of service. All participants that meet these requirements share in the allocation of the discretionary matching contribution regardless of service completed during the year or employment status on the last day of the Plan year. The Company made no discretionary matching contributions to the Plan for the period from January 1, 2022 to December 12, 2022.

The Company makes safe harbor contributions equal to 100% of each participant’s elective deferrals up to 3% and 50% of the elected deferrals from 3% to a maximum of 5% of the participant’s eligible compensation. Participants must be 21 years of age and have one year of service to be eligible to receive safe harbor contributions. The Company made no safe harbor contributions for the period from January 1, 2022 to December 12, 2022.

All participant and Company contributions to the Plan ceased as of the termination of the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of: (a) the Company’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

A. Description of the Plan – continued

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. In the event of total and permanent disability or death, the participant becomes fully vested. Vesting in the Company profit-sharing and discretionary matching contributions portion of accounts, plus actual earnings thereon are as follows:

Effective April 8, 2021, as part of the Plan termination, all participants became 100% vested in their Company profit-sharing and discretionary employer matching contributions.

Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are distributed in the form of rollovers or lump sum payments. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited.

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of their vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, their spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of burial or funeral expense of the participant's parent, spouse, or dependents; (4) for the payment of post-secondary tuition expenses; (5) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence; or (6) for the payment of expenses for the repair of damage to the participant's principal residence.

See Note G for how the remaining balances in the Plan were distributed following the termination of the Plan.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts may be used to pay any administrative expenses of the Plan or to reduce employer discretionary matching contributions, discretionary profit-sharing contributions, Qualified Nonelective Contributions ("QNECs"), Qualified Matching Contributions ("QMACs"), and safe harbor contributions. There were \$17,723 and \$0 in forfeitures used to reduce employer contributions and pay plan expenses, respectively, for the period from January 1, 2022 to December 12, 2022. Unallocated forfeitures outstanding as of December 12, 2022 and December 31, 2021 were \$0 and \$17,723, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct their salary deferrals in 1% increments into any of the Plan's investment options.

Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. Certain administrative expenses are paid by the Company and are not reflected in the accompanying financial statements. Fees paid by the participants for investment management and qualified administrative expenses totaled \$0 for the period from January 1, 2022 to December 12, 2022.

Basis of Accounting

As a result of the Company terminating the Plan effective April 8, 2021, the Plan's financial statements are presented on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process, and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. As of December 31, 2021, remaining administrative expenses and interest income through liquidation were estimated by management and recorded in the Plan's financial statements. All assets of the Plan were liquidated as of December 12, 2022.

B. Summary of Significant Accounting Policies

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income

The investments of the Plan are stated at fair value (except for fully-benefit responsive investment contracts, which are reported at contract value) as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

C. Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Money market funds are valued based on the short-term cash component as of the measurement date and classified within Level 1 of the valuation hierarchy.
- Mutual funds are valued at the published per share net asset value of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at net asset value.

There have been no changes in the methodologies used at December 12, 2022 or December 31, 2021.

C. Fair Value Measurements – continued

As of December 12, 2022, the Plan held no investments. As of December 31, 2021 the Plan had no assets classified within Level 2 or Level 3 of the valuation hierarchy. The following table details the Plan's investments at fair value by level, within the fair value hierarchy, as of December 31, 2021.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

D. Group Annuity Insurance Contract

As of December 31, 2021, the Plan held a group annuity insurance contract. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The group annuity insurance contract held by the Plan was a fixed account. The fixed account provides a guarantee that the annual interest rate will not fall below 1%. The fixed account was invested in the general asset account of the contract issuer and was guaranteed by the insurance company's claims paying ability. The general asset account was primarily invested in investment grade fixed income securities, which were valued daily under the liquidation value method. Liquidation value was based on the terms of the contract, which included no unobservable inputs.

D. Group Annuity Insurance Contract – continued

The Plan termination effective April 8, 2021 did not impact the Plan's ability to transact at contract value and participant balances were distributed at contract value during the period from January 1, 2022 to December 12, 2022.

E. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 12, 2022 and December 31, 2021, and net decrease in fair value of investments and interest and dividends for the period from January 1, 2022 to December 12, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the "Custodian" of the Plan).

F. Tax Status

Effective January 1, 2015, the Plan was amended and restated by the adoption of the Red Bank Pension Services, Inc. Prototype Non-standardized Profit Sharing Plan with CODA, which has a favorable opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014. This opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor identified various operational errors affecting a number of participant accounts. The Plan Sponsor is in the process of self-correcting these operational errors and believes the effects of these corrections have already been considered in the Plan's financial statements. Plan management also submitted a Voluntary Correction Program ("VCP") filing to the IRS for certain plan document errors regarding participating employers and is currently waiting on IRS approval. The Plan Sponsor does not expect the operational errors or the VCP to affect the Plan's tax status as tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 12, 2022, there are no uncertain positions taken or expected to be taken that would require adjustment to or additional disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Plan Termination

Effective April 8, 2021, the Company elected to terminate the Plan. Participants had until June 3, 2022, to transfer their funds to another employer-sponsored retirement plan or an individual retirement account (“IRA”) or to take a lump-sum distribution. If a participant did not move his or her funds by this date, and his or her balance was greater than \$1,000, an IRA was established with the broker of the Plan in the participant’s name to accept the rollover of the participant’s funds. If the participant’s balance was less than \$1,000, the funds were distributed to the participant. All assets of the Plan were liquidated as of December 12, 2022.

H. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan may invest in shares of mutual funds managed by the Custodian. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA which are exempt from the prohibited transaction rules.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances for the period from January 1, 2022 to December 12, 2022 and the amounts reported in the statements of net assets available for benefits as of December 31, 2021. The Plan had no assets as of December 12, 2022.

J. Subsequent Events

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through July 11, 2023, the date the financial statements were available for issuance.
