Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). The following description of the 401(k) Savings Plan for Employees of Seattle Times Company and Subsidiaries (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - Effective December 31, 2010, the Plan's oversight committee resolved to consolidate the four defined contribution plans included in the Times 401(k) Retirement Savings Trust into one surviving plan. The Plan is the surviving plan. As of December 31, 2010, the following plans were merged into one plan that was renamed the 401(k) Savings Plan for Employees of Seattle Times Company and Subsidiaries effective January 1, 2011:

- Savings Plan for Unaffiliated Employees of Seattle Times Company (STC Unaffiliated)
- Retirement Savings Plan for Affiliated Employees of the Seattle Times Company (STC Affiliated)
- Amended and Restated Retirement Savings Plan for Employees of Times Communications Co. (TCC - includes unaffiliated employees from WWUB, YHR, ROP, and IP)
- Yakima Herald-Republic Savings Plan for Affiliated Employees (YHR Plan - includes only YHR Affiliated Employees)

The Plan is a defined contribution plan sponsored by Seattle Times Company (STC) and various affiliated companies (collectively, the Company) including:

- Walla Walla Union Bulletin, Inc. (WWUB)
- Yakima Herald-Republic, Inc. (YHR)
- Rotary Offset Press (ROP) - All ROP employees transferred to STC during September 2020
- Issaquah Press (IP) - Closed company with no employees

The Plan covers two types of employee groups: affiliated and unaffiliated employees. Affiliated employees are those employees covered by a collective bargaining agreement (Affiliated Employees). Unaffiliated employees are those employees who are not covered by a collective bargaining agreement (Unaffiliated Employees).

The Plan is intended to qualify under Sections 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility -

Eligibility for Employee Contributions - Each employee of the Company who is not otherwise excluded becomes eligible to make pre-tax, Roth, and non-Roth after-tax contributions upon completion of 90 days of service. There is not a required number of service hours. However, if a TCC Unaffiliated Employee or a YHR Affiliated Employee completes a year of service in his/her eligibility computation period, he/she is eligible to participate in the Plan regardless of whether or not the days of service requirement has been met.

Eligibility for Employer Matching Contributions - TCC Unaffiliated and YHR Affiliated Employees are eligible for employer matching contributions upon completion of one year of service with the employer, provided the employee has worked at least 1,000 hours during their first year, and otherwise, upon completion of 1,000 hours in any subsequent calendar year. STC Unaffiliated Employees and Affiliated Employees who are not otherwise excluded are eligible for discretionary employer matching contributions upon completion of 90 days of service.

Note 1 - Continued

Eligibility for TCC Employer Nonelective Contributions and YHR Affiliated Employer Nonelective Contributions - TCC Unaffiliated and YHR Affiliated Employees are eligible for nonelective contributions upon completion of one year of service with the employer, provided the employee has worked at least 1,000 hours during their first year, and otherwise, upon completion of 1,000 hours in any subsequent calendar year.

Participant Contributions - Participants may elect to defer up to 50% of their compensation as pre-tax, Roth, or non-Roth after-tax contributions, subject to certain limitations under the IRC. Certain employees are automatically enrolled to make pre-tax contributions at a savings rate of 4% of their compensation unless they elect otherwise. The Plan allows catch-up deferral contributions for participants 50 years of age or older, as well as rollover contributions from other eligible plans.

Employer Matching Contributions -

TCC Employer Matching Contributions - STC's Board of Directors may make discretionary matching contributions for employees of WWUB and YHR (Unaffiliated). For the 2022 plan year, WWUB employees received a match equal to the greater of 100% of the first 1% of compensation contributed or 50% of the first 6% of compensation contributed. For the 2022 plan year, YHR Unaffiliated Employees received a match equal to 100% of the first 1% of compensation contributed plus 50% of the next 5% of compensation contributed.

STC Employer Matching Contributions - STC's Board of Directors may make discretionary matching contributions for employees of STC. For the 2022 plan year, STC Affiliated Employees who have a match included in their collective bargaining agreement and STC Unaffiliated Employees received a match equal to 50% of the first 4% of compensation that a participant contributes.

YHR Affiliated Employer Matching Contributions - The employer matches 50% of the first 6% of compensation that a participant contributes.

Employer Nonelective Contributions -

TCC Employer Nonelective Contributions - STC's Board of Directors may make discretionary nonelective contributions for employees of WWUB and YHR (Unaffiliated). There were no nonelective contributions for the 2022 plan year.

YHR Affiliated Employer Nonelective Contributions - Nonelective employer contributions for affiliated employees of YHR are determined by the collective bargaining agreement in place for that plan year. The collective bargaining agreement did not include a provision for nonelective employer contributions for the 2022 plan year.

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions, if any, as well as allocations of plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting -

TCC Employees - Participants are immediately vested in all of their contributions and any earnings thereon.

STC Affiliated and Unaffiliated Employees and YHR Affiliated Employees - All participants are immediately vested in their salary deferral contributions and any earnings thereon. Vesting in employer contributions, and earnings thereon, is based on years of continuous service, according to the following schedule:

Any participant who is not already 100% vested becomes 100% vested in employer contributions upon death, disability, or reaching age 65 while still an employee.

Forfeited Accounts - At December 31, 2022 and 2021, forfeited nonvested accounts totaled approximately \$6,000 and \$47,000, respectively. These accounts are used to reduce future employer contributions or pay administrative expenses of the Plan. During 2022, approximately \$63,000 of forfeitures were used to reduce employer contributions.

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive a lump sum, partial lump sum, or annual installments equal to the value of the participant's vested interest in their account. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their pre-tax and Roth accounts prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from their non-Roth after-tax account as well as balances rolled into the Plan.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding note receivable balance in their account during the prior 12-month period. Note repayment terms are five years or less, except for the purchase of a primary residence, which may be repaid over a longer period. Principal and interest are paid ratably through payroll deductions. The notes are secured by the participant's vested account balance and bear interest at a rate commensurate with prevailing rates as determined by the Plan's Investment Committee.

Note 2 - Significant Accounting Policies

Basis of Accounting - As permitted by the Department of Labor, the financial statements are prepared on the modified cash basis of accounting. Accordingly, investment income and contributions are recognized when received and expenses are recognized when paid.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that may affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are valued at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through June 27, 2023, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds valued as described above.

Stable Value Collective Trust Fund - The fund is composed primarily of benefit-responsive investment contracts and fixed income securities and is valued at the NAV provided by the fund's trustee. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals made in order to accommodate benefit payments to participants may be made on any business day. Withdrawals made in order to accommodate a participant-initiated exchange to another investment option may be made on any business day, provided that the exchange is not directed to a competing fund. Withdrawals initiated by the Company may be paid at less than the fund's NAV and must be preceded by a twelve-month advance written notice. However, the fund's trustee may, in its discretion, complete any such withdrawal before the expiration of such twelve-month period. The fund's trustee also reserves the right to temporarily delay any withdrawal from the fund that might adversely affect the fund's portfolio.

Note 4 - Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2022 and 2021, and investment income or loss for the year ended December 31, 2022, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and units of a collective trust fund managed by the trustee and its affiliates. Therefore, transactions with these investments and fees paid by the Plan to the trustee or its affiliates qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

Note 7 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 9, 2016, that the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan provides for various investment funds options, which in turn invest in various investment securities such as stocks, bonds, and others. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Delinquent Contributions

The Company determined there was one instance during 2022 in which participant deferral contributions were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$14 of deferral contributions were identified as delinquent. During 2023, the Company restored lost earnings to the account of the participant impacted by the delinquent deposit.
