- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for Audit of the Financial Statements section of our report. We are required to be independent of ClearChoice MD Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ClearChoice MD Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Other Matter**

### **Supplemental Schedule Required by ERISA**

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

September 30, 2022

### 1. Description of Plan

The following description of the ClearChoice MD Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, established January 1, 2015 and most recently amended March 9, 2022, covering all eligible employees of ClearChoice MD MSO, LLC and ClearChoice MD, PLLC (the Company) who have attained the age of twenty-one, except nonresident aliens, employees covered by a collective bargaining agreement and leased employees. All employees who were employed on January 1, 2015 were eligible to participate in the Plan effective January 1, 2015. Employees subsequently hired are eligible to participate in the Plan on the first day of the month after two months of service effective January 1, 2021 (one year of service prior to January 1, 2021).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company merged with Urgent Care Centers of New England effective May 28, 2021. Effective September 30, 2022, the Plan merged with the Emergence Health Holdings (CareWell) Retirement Plan & Trust. The Plan was in a blackout period from September 27, 2022 until October 21, 2022.

#### Contributions

Each year, participants may contribute up to 90% of their respective pretax annual compensation, subject to limitations established by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan also permits Roth elective deferrals. Roth elective deferrals shall be treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not "pre-tax" deferrals as defined in the Code.

The Company makes a safe harbor matching contribution equal to 100% of the first 3% of compensation deferred and 50% of the next 2% of compensation deferred.

### Notes to Financial Statements (continued)

#### 1. Description of Plan (continued)

##### Contributions (continued)

The Company may also elect to provide a discretionary nonelective contribution. For the period January 1, 2022 through September 30, 2022 and for the year ended December 31, 2021, no discretionary nonelective contributions were made.

Participants direct the investment of their contributions and any Company contributions into various investment options offered by the Plan.

##### Participants Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor contribution, discretionary contributions (if any) and a pro rata allocation of the fund's investment gains or losses. The benefit to which a participant is entitled is the vested portion from the participant's account.

##### Vesting

Participants are immediately vested in their voluntary contributions, the Company's safe harbor contributions, plus actual earnings thereon.

Vesting in the Company's discretionary nonelective contribution, if any, plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two years of credited service and 20% each year of credited service thereafter until a participant is 100% vested after the completion of six years of credited service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years, or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 2%. Principal and interest is paid ratably through payroll deductions.

##### Payment of Benefits

Upon termination of service, or upon death, disability or retirement, a participant may receive a lump-sum amount equal to the vested value of his or her account.

### 1. Description of Plan (continued)

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

## ClearChoice MD Retirement Plan

### Notes to Financial Statements (continued)

#### **2. Summary of Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid directly by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The amounts deducted from participant accounts for the period January 1, 2022 through September 30, 2022 and the year ended December 31, 2021 amounted to \$1,704 and \$1,526, respectively.

#### **3. Investments**

All investment information and notes receivable from participants disclosed in the accompanying financial statements and schedule, including investments held and notes receivable from participants at September 30, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2022 through September 30, 2022 and the year ended December 31, 2021, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

#### **4. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There were no changes in the valuation methodologies at December 31, 2021.

*Mutual funds* are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust (CCT)* includes the Invesco Stable Asset Trust Account. The net asset value of participation units owned by the Plan in the CCT, as provided by the trustee, is used as a practical expedient. The net asset value is based on the fair value of the underlying investments held by the fund redemption less its liabilities. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments.

## ClearChoice MD Retirement Plan

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

Withdrawals directed by a Plan Sponsor must be preceded by advance written notice to the Trustee; provided, however, that the Trustee may, in its discretion, complete any such plan-level withdrawals subject to a delayed withdrawal. There are no reserves against contract value for credit risk, contract issues or restrictions. No events are probable of occurring that might limit the ability of the Plan to transact at the daily value of the Invesco Stable Asset Trust Account.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **6. Parties-In-Interest**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the trustee are considered party-in-interest transactions.

#### **7. Income Tax Status**

The Plan has adopted the non-standardized pre-approved profit-sharing plan of ADP, LLC. The non-standardized pre-approved profit-sharing plan sponsor received an advisory letter from the IRS dated October 6, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 9. Subsequent Events

The Company has evaluated all subsequent events through July 12, 2023, the date the financial statements were available to be issued. During this period, there have been no events that would require recognition in the financial statements or disclosures to the financial statements.

#### 10. Delinquent Participant Contributions

During 2022, the Company failed to transmit certain participant contributions to the Plan in the amount of \$37,727 within the time period prescribed by ERISA. Late transmission of participant contributions constitutes a prohibited transaction under ERISA section 406. The Company deposited the late contributions in 2022 and calculated and will fund the participant accounts for missed earnings of \$77.38.

During 2021, the Company failed to transmit certain participant contributions to the Plan in the amount of \$62,329 within the time period prescribed by ERISA. Late transmission of participant contributions constitutes a prohibited transaction under ERISA section 406. The Company deposited the late contributions and calculated and funded the participant accounts for missed earnings of \$1,642 on October 24, 2022.

#### **10. Delinquent Participant Contributions (continued)**

During 2020, the Company failed to transmit certain participant contributions to the Plan in the amount of \$67,573, within the time period prescribed by ERISA. Late transmission of participant contributions constitutes a prohibited transaction under ERISA section 406. The Company has deposited the late contributions and calculated and funded the participant accounts for missed earnings of \$3,389 on March 31, 2021.
