### **Scope and Nature of the ERISA 103(a)(3)(C) Audit**

We have performed an audits of the accompanying financial statements of NBHX Trim USA Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Note A - Plan Description

The following description of the NBHX Trim USA Corporation 401(k) Plan (the “plan”) provides only general information. Participants should refer to the plan document and amendments for a more complete description of the plan’s provisions.

#### General

The plan is a defined contribution plan covering substantially all full-time employees of NBHX Trim USA Corporation, Inc. (the “company”) who have two consecutive months of eligible service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute up to 90% of pretax or after tax eligible compensation, as defined in the plan, up to the maximum amount permitted by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the plan. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The company may make discretionary match or profit-sharing contributions to the plan. The company contribution is invested as directed by the participant. The company made a matching contribution of 50% of an employee’s deferral up to 4% of compensation, plus 25% of an employee’s deferral up to 2% of compensation for the years ended December 31, 2022 and 2021.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and company matching contributions, as well as allocations of the plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company’s portions of their accounts plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after three years of credited service.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The plan permits in-service and hardship withdrawals under certain conditions. A coronavirus related distribution may be made to a qualified individual in an amount not to exceed \$100,000, per an adopted provision of the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

#### **Forfeited Accounts**

Forfeited non-vested accounts totaled \$3,923 and \$3,858 at December 31, 2022 and 2021. These accounts may be used to pay administrative expenses, matching contributions, or nonelective contributions. During the years ended December 31, 2022 and 2021, \$264 and \$6,158 of forfeited non-vested accounts were used to reduce employer contributions.

### **Note B - Summary of Significant Accounting Policies**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

#### **Basis of Accounting**

The financial statements of the plan are prepared under the accrual method of accounting.

#### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments purchased and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are recorded as distributions on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the plan are paid by the plan, unless otherwise paid by the company. Expenses that are paid by the company are excluded from these financial statements. Fees related to certain distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

Plan management has evaluated subsequent events through July 13, 2023, the date the financial statements were available to be issued.

### **Note C - Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held December 31, 2022 and 2021, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the plan).

### Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**Common/collective trust (CCT)** The plan invests in the Invesco Stable Value Retirement Fund, a common/collective trust. The fair value of the plan's interest in the CCT is based on NAV, as disclosed in audited information reported by the issuer, Invesco National Trust Company (Invesco). Invesco determines NAV based on the underlying investments (primarily synthetic and traditional guaranteed investment contracts, and short-term investments) and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note G - Plan Amendment and Termination**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provision of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. In October 2022, the plan sponsor announced plans to eventually wind-down operations at the Comstock Park, Michigan manufacturing plant by the end of 2023. Employees of the plant, which comprise substantially all the participants in the plan, are expected to be laid off or relocated to other facilities. Plan management has not yet formally determined if, when or how the plan may be terminated.

### **Note H - Tax Status of Plan**

The plan has adopted a ADP Retirement Services prototype plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020. The plan has not applied for its own determination letter. The plan has been amended since this date; however, the plan administrator believes that the plan is designed and is being operated in compliance with the applicable requirements of ERISA and the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the plan's financial statements.

### **Note I - Risks and Uncertainties**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
