Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Shoemaker Manufacturing Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 20, 2022 (liquidated) and December 31, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended December 20, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shoemaker Manufacturing Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended December 20, 2022, and as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Shoemaker Manufacturing Company 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1, 2, 9, and 10 to the financial statements, the Plan sponsor terminated the Plan effective December 14, 2021, and Plan management determined liquidation is imminent. As a result, the Plan changed its basis of accounting to the liquidation basis as of and for the year ended December 31, 2021, and continued to report it as such as of and for the period ended December 20, 2022. The Plan was fully liquidated by December 20, 2022. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Shoemaker Manufacturing Company 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1 – Description of Plan

The following description of the Shoemaker Manufacturing Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was a 401(k) salary deferral and profit sharing plan covering substantially all employees of Shoemaker Manufacturing Company and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Shoemaker Manufacturing Company (the Company) is the Plan's sponsor and serves as Plan administrator.

On December 15, 2021, the Company entered into a purchase and sale agreement with an unrelated third party to sell substantially all of the operating assets and began notifying participants and Plan advisors that the Plan would be terminating. The resolution to terminate the Plan was executed on December 14, 2021, and the Plan termination date was effective December 14, 2021. No employees were allowed to enroll after the December 14, 2021, termination date, and contributions to the Plan were only allowed through the termination date.

Eligibility – Employees of the Company were eligible to participate in the Plan the first day of the next quarter upon their date of hire. Employees were eligible to receive employer safe harbor matching contributions on the first day of the next quarter upon their date of hire. Employees were eligible to receive discretionary matching contributions on the first day of the next quarter upon completion of 300 hours of service in a 12-month period. If 300 hours were not met in the first 12 months, then 1,000 hours of service in a 12-month period must be met. Certain employees were eligible to receive a discretionary profit sharing contribution where at least 1,000 hours of service was performed each year and the participant was employed as of the last day of the Plan year. No employees were allowed to participate in the Plan after December 14, 2021.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Participant contributions to the Plan were only allowed through December 14, 2021.

Employer match and profit sharing contributions – The Company may elect to make discretionary matching and profit sharing contributions to the Plan. The Company determined discretionary matches of 100% of employee contributions, up to 3% of eligible compensation deferred to the Plan plus 50% of the amount of the participant's matched employee contributions that exceed 3% of the participant's compensation but that do not exceed 5%. No discretionary matching contributions to the Plan were made for the period ended December 20, 2022. Profit sharing contributions were discretionary in an amount as determined by the Company and were paid to employees with at least 20 years of service. No profit sharing contributions to the Plan were made for the period ended December 20, 2022.

Employer safe harbor – The Company also makes safe harbor contributions equal to 3% of the participant's eligible compensation plus 50% of the amount of the participant's matched employee contributions that exceed 3% of the participant's compensation but that do not exceed 5%, regardless of the employee's hours of service or employment on the last day of the Plan year. Safe harbor contributions to the Plan were only allowed through December 14, 2021.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions, when earned, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participants were vested immediately in their contributions and employer safe harbor match contributions plus actual earnings thereon. Vesting in the Company's employer discretionary match and profit sharing contribution portions of their accounts prior to December 14, 2021, was based on years of service. Effective December 14, 2021, all participant accounts became fully vested.

Notes receivable from participants – Participant loans were not permitted by the plan.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments with a continuous right of withdrawal at times the Participant may elect. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who terminates employment with a vested balance of \$5,000 or less received an automatic cash-out distribution of their entire vested balance.

Forfeitures – Forfeitures were the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures retained in the Plan, must be used no later than in the subsequent year, and would be used to reduce future Company contributions or pay the Plan's administrative expenses. As of December 20, 2022 and December 31, 2021, there were no forfeited nonvested accounts. There were no forfeitures used to reduce Company contributions or Plan administrative expenses during the period ended December 20, 2022.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – Effective December 14, 2021, the Plan sponsor elected to terminate the Plan (see Notes 1, 2, 9, and 10) and the Plan administrator determined liquidation was imminent. Accordingly, the accompanying statement of net assets available for benefits and the statement of changes in net assets available for benefits as of and for the period ended December 20, 2022, and as of and for the year ended December 31, 2021, are prepared on the liquidation basis of accounting.

Adjustment to the liquidation basis – The Plan adopted the liquidation basis of accounting for the financial statements as of and for the period ended December 20, 2022, and as of and for the year ended December 31, 2021. Under the liquidation basis of accounting, an entity accrues costs and income that it expects to incur or earn through the end of its liquidation if and when it has a reasonable basis for the estimation. Adjustment to the liquidation basis can include estimated payments to participants upon liquidation, fees that will be incurred, interest expected to be earned on interest-bearing investments held at the statement of net assets date as a result of the Plan's termination, as well as estimated legal and audit fees. As of December 20, 2022 and December 31, 2021, the Plan did not believe it has a reasonable basis to accrue costs, income, or estimated payments to participants upon liquidation and no such adjustments were recorded in connection with the Plan's adoption of the liquidation basis of accounting in 2022 and 2021.

Use of estimates – The preparation of financial statements in accordance with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments were reported at fair value and contract value. The Plan's custodian, Voya Retirement Insurance and Annuity Company, certifies the contract value of the fixed account contract and the fair value of all other investments. If available, quoted market prices were used to value investments.

Fair value was the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date.

Contract value was the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefits were recorded when paid.

Expenses – Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Administrative expenses paid by the Plan include administrative Plan fees. The Plan's administrative expenses may be paid out of the forfeiture account. Investment related expenses were included in net depreciation of fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through July 9, 2023, which is the date the financial statements were available to be issued.

Note 3 – Investments

The Plan's investments consisted of units held in pooled separate accounts (PSAs) that were valued using the net asset value (NAV) practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. There were no unfunded commitments from participants in the Plan who invest in these accounts. The Plan had no restrictions on its ability to redeem any of the pooled separate accounts or as it relates to participant directed transactions and withdrawals as of December 20, 2022 and December 31, 2021.

There were no changes in the techniques used at December 20, 2022 and December 31, 2021.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Fixed Account Contract with ING Life Insurance Company

In 2014, the Plan entered into a benefit-responsive fixed account investment contract with ING Life Insurance Company (ING). ING maintains the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 1%. The crediting rate was reviewed yearly for resetting. The fixed account contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract met the fully benefit-responsive investment contract (FBRIC) criteria and was therefore reported at contract value. Contract value is the relevant measure for FBRICs because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by ING, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events were probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Tax Status

The Plan document was a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believed that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan had any uncertain tax positions that required disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market volatility, and credit risks. It was reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 7 – Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the custodian of the Plan, has certified to the completeness and accuracy of:

- Net depreciation in fair value of investments reflected on the accompanying statement of changes in net assets available for benefits for the period ended December 20, 2022 (liquidated).
- Investments reflected on the schedule of assets (held at end of period).

Note 8 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments were managed by Voya Financial. Voya Retirement Insurance and Annuity Company was the custodian of the Plan and an affiliate of Voya Financial and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 9 – Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their discretionary employer matching contributions and profit sharing contributions. The Plan sponsor, effective December 14, 2021, terminated the Plan (see Notes 1, 2, and 10). As a result of the termination, all participants became fully vested in any balances in which they were not previously vested.

Note 10 – Plan Amendments

During the year ended December 31, 2021, the Plan was amended to:

Terminate the Plan effective December 14, 2021, and freeze eligibility and benefit accruals effective December 14, 2021.
