Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TracFone Wireless, Inc. Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TracFone Wireless, Inc. Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2022 and December 31, 2021, and for the years then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TracFone Wireless, Inc. Investment Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. A. Description of the Plan – Transfer of Assets

On January 23, 2023, following the acquisition of the Company by Verizon Communications Inc. (Verizon), contributions to the Plan were suspended. Effective February 4, 2022, eligible employees of the Company became eligible to participate in a Verizon 401(k) Plan. The Company’s plan assets transferred to the Verizon Communications Inc. 401(k) Plan on September 16, 2022. The changes in net assets of the combined plan are included in the accompanying statements of changes in net assets available for benefits from September 30, 2022. General

The Plan was a defined contribution plan, as described in section 401(k) of the Internal Revenue Code, covering all employees of the Company who have attained age 18 and completed one month of service. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees were automatically enrolled on the first of the month after one month of service, at 3% of compensation, unless the employee opted out. Participants contributed up to 90% of their pre-tax annual compensation, limited to \$19,500 for the years ending September 30, 2022 and December 31, 2021, respectively. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants rolled over amounts representing distributions from other qualified plans. The Company made a matching contribution equivalent to 50% of the first 6% of each participant’s contributions. The Company had the right to terminate matching contributions at any time.

Participant Accounts

Each participant’s account was credited with the participant’s contribution and allocations of the Company’s matching contribution, any rollovers into the Plan, the Company’s discretionary contribution, if any, and Plan earnings, and were charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled to is the benefit that can be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their contributions, rollovers, and actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon was based on the following years of continuous service:

The Company's investment plan participants became 100% vested upon transfer to the Verizon 401(k) Savings Plan.

Investment Options

A participant directed contributions to any of several investment options.

Notes receivable from participants

Participants borrowed, from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans were fully repaid within 5 years or up to 15 years for the purchase of a primary residence. Participant loans were collateralized by the participant's vested interest in the Plan and bear interest at a rate determined by the Plan administrator. During 2022 and 2021, the interest rates ranged from 5.50 % to 4.25%. Principal and interest were paid ratably through payroll deductions. The last loan repayments to the Company's 401(k) plan via payroll deduction occurred on January 28, 2022. Participants with loan balances were provided instructions on continuing loan payments through the transfer date. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest.

Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses had been recorded as of September 30, 2022, or December 31, 2021. Delinquent participant loans were recorded as distributions based on the terms of the Plan agreement.

A. Description of the Plan - continued

Payment of Benefits

Upon termination of service, death or disability, benefits of participants with a vested value in the Plan were distributed in a single lump-sum payment. If a participant's vested interest was between \$1,000 and \$5,000, it was distributed as a single lump-sum, or rolled over to an IRA.

In-service withdrawals were permitted for certain financial hardships.

Forfeitures

Upon termination of service, participants forfeited the unvested portion of their account balance to the extent not vested. Forfeitures were used to reduce future Company matching contributions. For the year ended September 30, 2022 and December 31, 2021, there was no forfeitures allocated to participants.

Risks and Uncertainties

The Plan invested in various securities. Investment securities were exposed to various risks such as interest rates and market risks. Due to the level of risk associated with investment securities, it was at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available For Benefits.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with the United States generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits and Withdrawals

Benefits to, and withdrawals made by, participants were recorded when paid.

Administrative Costs

Certain expenses incurred maintaining the Plan, which were immaterial, was paid directly by the Company and excluded from these financial statements. Administrative expenses included fees related to the administration of notes receivable that were charged directly to the participant's account and certain recordkeeping and other fees paid by the Plan. Investment-related expenses included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events were evaluated through June 30, 2023, the date when the financial statements were available to be issued. The Company's 401(k) Plan transferred all of its assets to the Verizon Communications Inc. 401(k) plan on September 16, 2022.

Investments

The Plan's investments were stated at fair value. Purchases and sales transactions was recorded on a trade date basis. Any gain or loss resulting from the sale of fund units was determined as the difference between the sales proceeds and the cost of the units sold.

Net appreciation (depreciation) in the fair value of investments consists of the realized gains or losses and the unrealized appreciation (depreciation) on investments.

Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All Plan's investments were Level 1 inputs.

Tax Status

The plan obtained its latest determination letter on April 25, 2014, in which the Internal Revenue Service stated that the plan, as then designed, followed the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan was qualified and that the related trust is tax-exempt.

Tax Status - Continued

GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more-likely-than-not would not be sustained upon examination by a tax authority. Management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is not subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2016.

Fees incurred and paid directly by the Plan for the investment management services were \$46,281 and \$70,645 for the years ended September 30, 2022 and December 31, 2021, respectively.
