## Independent Auditor's Report

To the Plan Administrator  
Harrington Memorial Hospital 403(b) Savings Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements*

We have performed an audit of the financial statements of Harrington Memorial Hospital 403(b) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statement of net assets available for benefits as of September 29, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through September 29, 2022, and the related notes to the financial statements ("2022 Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of September 29, 2022 and for the period from January 1, 2022 through September 29, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion on the 2022 Financial Statements*

### *Basis for Opinion on the 2022 Financial Statements*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). ### *Emphasis of Matter - Plan Merger*

As further discussed in Note 1 to the financial statements, the Plan merged with the UMass Memorial Health Care 403(b) Plan effective September 15, 2022 and all assets were transferred on September 29, 2022. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the 2022 Financial Statements*

Management is responsible for the preparation and fair presentation of the 2022 Financial Statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the 2022 Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the 2022 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

*Other Matter*

*Auditor's Report on the 2021 Financial Statements*

Predecessor auditors performed an audit of the 2021 financial statements of Harrington Memorial Hospital 403(b) Savings Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by qualified institutions. Their report dated October 6, 2022 indicated that (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2021 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2021 supplemental schedule, other than the information in the 2021 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2021 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

### Notes to Financial Statements September 29, 2022

#### Note 1 - Description of Plan

The following description of Harrington Memorial Hospital 403(b) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General**

The Plan was a defined contribution plan covering substantially all full-time employees of UMass Memorial Health - Harrington Hospital, Inc. (formerly Harrington Memorial Hospital, Inc.) (the "Hospital") and Harrington Physician Services, Inc. ("HPS") (together, the "Plan Sponsors") who were regularly scheduled to work more than 20 hours of service per week. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Trustees of the Hospital was responsible for oversight of the Plan. The Hospital's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Board of Trustees of the Hospital and Plan administrator.

Effective September 15, 2022, the Plan merged into UMass Memorial Health Care 403(b) Plan (the "New Plan") and Plan participants became participants in the New Plan on that date. All of the Plan's assets, in the amount of \$53,206,096, were transferred to the New Plan on September 29, 2022.

##### **Contributions**

Through September 15, 2022, a participant could contribute up to 100% of pretax annual compensation, as defined by the Plan, subject to Internal Revenue Service ("IRS") limitations. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans with the exception of contributions designated as Roth contributions ("rollovers"). Participants directed the investment of their contributions into various investment options offered by the Plan.

Through September 15, 2022, the Plan Sponsors could make discretionary matching contributions. The percentage of elective deferral contributions matched, if any, was a percentage as determined by the Plan Sponsors. For the period from January 1, 2022 through September 15, 2022, that percentage was equal to (1) 25% of participant deferrals, up to a maximum of 4% of the employee's eligible wages for employees of the Hospital and (2) 50% of participant deferrals, up to a maximum of 2% of the employee's eligible wages for employees of HPS. The Plan also provided for a discretionary plan sponsor core contribution equal to a percentage of eligible participants' compensation. For the period from January 1, 2022 through September 15, 2022, the Plan Sponsors' core contribution was 3% of eligible participants' compensation for employees of the Hospital and 4% of eligible participants' compensation for employees of HPS. Participants who are not members of a collective bargaining unit are eligible to receive discretionary and matching contributions upon attaining the age of 21 and the completion of one year of eligibility service. Participants also directed the investment of all Plan Sponsor contributions into various investment options offered by the Plan. Contributions were also subject to certain IRS limitations.

##### **Participant accounts**

Each participant's account was credited with the participant's contributions and the Plan Sponsors' contributions, if any, as well as allocations of Plan earnings. Participant accounts were also charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

### Notes to Financial Statements September 29, 2022

#### **Vesting**

Participants were vested immediately in their contributions, plus actual earnings thereon. In the event of termination due to death or disability, participants became 100% vested in the Plan's sponsors' contribution portion of their account. For all other participants, their interest in the Plan Sponsors' core and matching contributions was fully vested after three years of credited service with the Hospital or HPS.

#### **Notes receivable from participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants could have a maximum of two loans outstanding at a time. The loans were secured by the vested balance in the participant's account. Each loan was repayable in substantially equal installments over a term not to exceed five years (or 10 years if used to purchase a primary residence), including an interest rate which is commensurate with local prevailing interest rates as determined by the Plan administrator. Principal and interest were paid ratably through monthly payroll deductions. Participants are charged a fee when taking out a loan.

#### **Payment of benefits**

On termination of service due to death, disability, or retirement or, if actively employed, upon reaching age 59 and a half, a participant could have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period not to exceed the participant's life expectancy. For termination of service due to other reasons, a participant could have received the value of the vested interest in his or her account as a lump-sum distribution. The Plan allowed in-service and financial hardship withdrawals.

#### **Forfeitures**

At September 29, 2022, there were no forfeited non-vested accounts. At December 31, 2021, forfeited non-vested accounts totaled \$169,109. These accounts were used to reduce employer contributions. In 2022, employer contributions were reduced by \$64,079 from forfeited non-vested accounts and the remaining balance of \$105,030 was transferred to the New Plan.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value (except for fully benefit-responsive investments contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Hospital's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of September 29, 2022 and December 31, 2021. All outstanding loans as of September 29, 2022 were closed prior to transfer of the Plan to the New Plan by transferring funds from liquidated investments into the loan accounts of the New Plan.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsors. Expenses that are paid by the Plan Sponsors are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

#### **Subsequent events**

The Plan has evaluated subsequent events through July 14, 2023, the date the financial statements were available to be issued.

#### **Note 3 - Certified investments**

The Plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at September 29, 2022 and December 31, 2021, and investment income (loss) and interest income on notes receivable from participants for the period from January 1, 2022 through September 29, 2022 that are disclosed in the accompanying financial statements were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Prudential Bank and Trust, F.S.B. from January 1, 2022 through March 31, 2022 and Empower Annuity Insurance Company from April 1, 2022 through September 29, 2022, the trustees, and Prudential Retirement Insurance and Annuity Company (collectively "Prudential"), the custodian, from January 1, 2022 through September 29, 2022, of the Plan.

On April 1, 2022, the full-service retirement plan business of Prudential Financial, Inc. was acquired by Empower Annuity Insurance Company of America. There were no significant changes to the Plan as a result of this acquisition.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

No assets were held as of September 29, 2022. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 5 - Fully benefit-responsive investment contract

Prior to September 29, 2022, the Plan was invested in a fully-benefit responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company. This contract met the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value as of December 31, 2021. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.50%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or over time. There are generally not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

#### Note 6 - Related party transactions and party-in-interest transactions

Certain Plan investments were invested in funds and notes receivable from participants managed by Prudential. Prudential is the custodian and trustee, as defined, by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment. The Plan made direct payments to the third-party administrator of \$208,286 during the period from January 1, 2022 through September 29, 2022. The Plan Sponsors pay directly any other fees related to the Plan's operations.

#### **Note 7 - Plan termination**

The Plan Sponsors have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. Effective September 15, 2022, the Plan merged into the New Plan and Plan participants became participants in the New Plan on that date.

#### **Note 8 - Tax status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("IRC"). The terms of the Plan have been prepared to conform to the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the merger of the Plan into the New Plan effective September 15, 2022, there were no investment amounts reported in the statements of net assets available for benefits as of September 29, 2022.



