Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Seventy-Five State Street Tax Sheltered Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 1, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period of January 1, 2022 through December 1, 2022 (in liquidation), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 1, 2022 and December 31, 2021 and for the period of January 1, 2022 through December 1, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- the information in the financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Plan Termination and Liquidation Basis of Accounting

As discussed in Note 2 to the financial statements, the Plan was terminated effective May 31, 2022 with all remaining Plan assets having been distributed as of December 1, 2022. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

1. Description of Plan

The following description of Seventy-Five State Street Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Seventy-Five State Street (the Company). All employees that work 20 or more hours a week and are not students are immediately eligible for participation in the Plan for elective deferrals. Employees who have attained age 21 and completed one year of service (1,000 hours in a 12-month period) are eligible for any employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On March 14, 2022, the Company became an adopting employer of the Avesta Housing Development Corp. 401(k) plan, the 401(k) plan of an entity affiliated with the Company. Participants of the Plan were given the option to roll over their account balances, including any outstanding notes receivable from participants, into the Avesta Housing Development Corp. 401(k) plan. The Plan was terminated effective May 31, 2022 with all remaining Plan assets having been distributed as of December 1, 2022.

Contributions

Participants may contribute up to 100% of their compensation on a pre-tax and/or after-tax basis during each Plan year, up to the maximum allowable amount, as determined by the Internal Revenue Code (the Code).

The Company has the right to provide discretionary matching contributions. For the period of January 1, 2022 through December 1, 2022, the Plan elected to offer no matching contributions to eligible employees.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Forfeitures

Forfeitures of terminated nonvested account balances from discretionary contributions may be used to pay administrative expenses or to reduce the amount of future contributions required to be made by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan was terminated effective May 31, 2022 with all remaining Plan assets having been distributed as of December 1, 2022. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statement to the liquidation basis used in presenting the 2022 financial statements. Under the liquidation basis of accounting, assets are reflected at the estimated amount of cash or other consideration expected to be collected in settling or disposing of those assets in carrying out the Plan's liquidation (estimated net realizable value). There were no changes to the 2021 financial statement as a result of the change to the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Investments

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, and other administrative services are charged directly to the participant's account and are included in administrative expenses.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

The Lincoln National Life Insurance Company Contract Termination

In October 2021, The Lincoln National Life Insurance Company notified the Plan that it was discontinuing its contract with the Plan due to the contractual minimum contribution amount not having been met. Participants who met certain criteria, as outlined in the contract, received automatic payouts in January 2022, unless they elected to take a distribution sooner. As of December 1, 2022, participants that did not meet the criteria or elect to take a distribution had their account balances fully distributed as a result of the Plan's termination.

Subsequent Events

Management has considered transactions or events occurring through June 13, 2023, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Investment Contracts with Insurance Companies

The Plan has group annuity contracts with The Lincoln National Life Insurance Company and Principal Life Insurance Company. The Lincoln National Life Insurance Company maintains the contributions in the Lincoln GVA Fixed Account and Principal Life Insurance Company maintains the contributions in the Principal Fixed Income Guaranteed Option. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses) because they are fully benefit-responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contracts were fully liquidated during the period of January 1, 2022 through December 1, 2022 at contract value.

4. Income Tax Status

The Company has adopted the Principal Life Insurance Company prototype non-standardized 403(b) plan (prototype), which received a favorable opinion letter dated March 31, 2017 from the Internal Revenue Service stating that the form of the Plan, as then designed, was in compliance with the applicable requirements of the Code. The prototype has been amended since receiving the opinion letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

6. Parties-In-Interest

Plan investments include group annuity contracts and mutual funds managed by The Lincoln National Life Insurance Company and Principal Trust Company, the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The custodians provide certain administrative services to the Plan. The custodians receive revenue from mutual funds for services provided to the Plan. This revenue is used to offset certain amounts owed to the custodians for their administrative services to the Plan. Other administrative expenses are paid directly from the Plan assets to the custodians.

7. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:
Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021. There were no assets measured at fair value at December 1, 2022.

Mutual funds: Valued at quoted market price per share at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
