## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rae-Ann Holdings Inc. and Affiliates 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 27, 2022 (in liquidation) and December 31, 2021, and the related statement of changes in net assets (in liquidation) available for benefits for the period from January 1, 2022 to September 27, 2022, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Minnesota Life Insurance Company, the custodian of the Plan, a qualified institution, as of and for the period from January 1, 2022 to September 27, 2022 and as of December 31, 2021, stating that the certified investment information, as identified in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As discussed in Note G to the financial statements, the Board of Trustees of the Plan approved termination of the Plan on May 31, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the December 31, 2021 financial statements to the liquidation basis of accounting used in presenting the September 27, 2022 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of Rae-Ann Holdings, Inc. and Affiliates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan was a defined contribution plan covering all employees of Rae-Ann Holdings, Inc. and Affiliates (the Company, Plan Administrator, and Plan Sponsor) who completed one year of service as defined by the Plan and attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The following description of the Plan represents information to the Plan termination date. Subsequent to the termination date, many of the features and options of the Plan became unavailable to participants.

##### **Contributions**

Participants were able to elect to defer up to 100% of their eligible compensation as defined by the Plan on a pre-tax or after-tax basis. The Plan also provided for catch-up contributions for participants who reach the age of 50 by the end of the Plan year. Employees who have not declined participation or completed a salary deferral agreement as of the date of their eligibility to participate in the Plan were automatically enrolled in the Plan with a pre-tax deferral of 3% invested in a fund designated by the Plan Administrator until changed by the participant. The Plan provided for a discretionary employer matching contribution. Additional discretionary employer profit sharing contributions could be made at the option of the Company's board of directors. There were no employer contributions made during the period from January 1, 2022 to September 27, 2022. The Plan provided for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code). Participants directed the investment of their contributions into various options offered by the Plan. Contributions were subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account was credited with the participant's contributions, and an allocation of the Company's discretionary employer matching contributions, the Company's discretionary profit sharing contributions, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based upon participant account earnings, compensation, or specific participant transactions, as defined. The benefit to which a participant was entitled to receive was the benefit that could be provided from the participant's vested account.

#### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

##### **Vesting**

Participants were immediately vested in their deferral contributions and rollover contributions plus actual earnings thereon. Vesting in the remainder of their account balance was based on years of continuous service. Discretionary employer matching contributions plus actual earnings thereon were 100% vested after three years and discretionary employer profit sharing contributions plus actual earnings thereon were fully vested after five years of credited service. Due to the Plan termination disclosed in Note G the participants became 100% vested in the employer contributions to the Plan.

##### **Payment of Benefits**

Upon attaining age 65 or termination of service, a participant could elect to receive a partial distribution or lump-sum amount equal to the value of the participant's account. If the value of the vested benefits credited to the participant's account was \$5,000 or less at the time of termination, the entire amount would be distributed in the form of a direct rollover to an individual retirement account as designated by the Plan Sponsor.

Active participants could request hardship withdrawals from their elective deferral account balances, subject to Plan provisions. A participant who received a distribution on account of hardship was not prohibited from making deferrals after receipt of the distribution.

During 2020, the Plan elected to allow eligible participants to request coronavirus-related distributions and suspended required minimum distributions from the Plan between March 27 and December 31, 2020 in accordance with the provisions of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act). The coronavirus-related distributions can be repaid in one or more contributions to the Plan over a 3-year period commencing on the date the distribution was received.

##### **Forfeited Accounts**

Forfeitures were first used to reduce administrative expenses and any remainder was used to reduce future employer contributions. The unallocated forfeiture balance was \$-0- at both September 27, 2022 and December 31, 2021.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

As discussed in Note G, the Board of Trustees terminated the Plan effective May 31, 2022. As a result the Plan changed its basis of accounting for the period subsequent to December 31, 2021 from the going concern basis to the liquidation basis.

##### **Basis of Accounting (Continued)**

The statement of net assets available for benefits as of December 31, 2021 was prepared using the accrual basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

##### **Investment Valuation**

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

##### **Investment Income Recognition**

Purchases and sales of securities were recorded on a trade date basis. Interest income was recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Participant and employer contributions were recorded and credited to each participant's account as received by the custodian from the Company. Any contributions attributable to the Plan year but not received by the last day of the Plan year were recorded as a receivable.

##### **Payment of Benefits**

Benefits were recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefits paid to participants were charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments on the accompanying statement of changes in net assets (in liquidation) available for benefits.

##### **Income Taxes**

The Company adopted a volume submitter profit sharing plan with cash or deferred arrangement which received an opinion letter from the IRS dated March 31, 2014, stating that the Plan and related trust was designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan is currently being operated in compliance with the applicable requirements of the Code and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### **Subsequent Events**

The Plan has evaluated subsequent events through July 13, 2023, the date which the financial statements were available to be issued.

#### **NOTE C - CERTIFICATION**

Investment information disclosed in the accompanying financial statements, including investments held at September 27, 2022 and December 31, 2021, and net depreciation in the fair value of investments and interest income for the period from January 1, 2022 to September 27, 2022 was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian.

#### NOTE D - FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The Plan had no investments at September 27, 2022 as the Plan was fully liquidated.

#### **NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Pooled separate accounts investing in mutual funds were valued at the net asset value of units held by the Plan at year end. The net asset value, as provided by the custodian, was used as a practical expedient to estimate fair value. Net asset value was based on the quoted market prices of the underlying investments, net of insurance company fees and expenses less their liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported net asset value.

Pooled separate accounts investing in bonds were valued at the net asset value of units held by the Plan at year end. The net asset value, as provided by the custodian, was used as a practical expedient to estimate fair value. Net asset value was based on quoted prices in markets that were not active, broker dealer quotations, or other methods by which all significant inputs were observable, either directly or indirectly, net of insurance company fees and expenses less their liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported net asset value.

The guaranteed investment contract was valued at fair value (Note F) by discounting the related cash flows based on the interest crediting rate, which represents average renewal market rates applied to new funds deposited as well as the expected rollover rate and an average withdrawal factor (unobservable inputs). The new fund's rate utilized to determine fair value was 1.04% and 1.00% at September 27, 2022 and December 31, 2021, respectively. The expected rollover rate was 2.04% and 2.12% at September 27, 2022 and December 31, 2021, respectively. The fair value measurement was sensitive to changes in the unobservable inputs. Because the participants transact at contract value, fair value was determined annually for financial statement reporting purposes only. At December 31, 2021, fair value equaled contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

#### **NOTE F - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan had a traditional guaranteed investment contract with Minnesota Life with a balance of \$-0- and \$250,727 at September 27, 2022 and December 31, 2021, respectively. Contributions from the Plan were maintained in Minnesota Life's general account. All benefit payments prior to contract liquidation were made at contract value; however, the contract restricted participant directed exchanges by limiting transfers between funds to the greater of up to 20% of the participant's account at contract value or \$2,000 in a 12 month period. If the Plan Sponsor terminates the contract, a market value adjustment may apply.

Contract value was the relevant measure for fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's investment contract with Minnesota Life was not considered to be fully benefit-responsive due to the restrictions on fund transfers and; therefore, the investment was included in the statement of net assets available for benefits at fair value. At December 31, 2021, the fair value of the investment contract equaled contract value because the market value adjustment that would have been applied if the contract was terminated as of that date was \$-0-.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations might have been affected by future economic and regulatory developments.

The contract was terminated in 2022 and a market value adjustment loss of \$13,067 was recorded in net depreciation in fair value of investments for the period from January 1, 2022 to September 27, 2022.

#### **NOTE G - PLAN TERMINATION**

On June 6, 2022 the Board of Trustees of the Plan adopted an amendment to terminate the Plan, effective May 31, 2022. As a result of this action, participants became 100% vested in their account balances. As of the Plan termination date, no employees were eligible to enter the Plan, no further contributions were made to the Plan, and no further deferral contributions were deducted from employee paychecks. The Plan was liquidated as of September 27, 2022.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE I - RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS**

Parties-in-interest transactions included the investment in the funds of the custodian, and related interest, and the payment of administrative expenses by the Plan. Such transactions are exempt from being prohibited transactions.
