Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sure Fit Inc. Non Union 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through September 1, 2022, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 1, 2022 and December 31, 2021, and for the period January 1, 2022 through September 1, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Basis for Opinion

Emphasis of Matter - Plan Merger

As discussed in Note G to the financial statements, the Plan Administrative Committee of Sure Fit Inc., the Plan's Sponsor, voted during 2022, to merge the Plan into the Hollander Sleep Products, LLC Retirement and Savings Plan effective September 1, 2022. All plan assets were transferred to the Hollander Sleep Products, LLC Retirement and Savings Plan on September 1, 2022. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Sure Fit Inc. Non Union 401(k) Savings Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

The Plan was a defined contribution profit sharing and 401(k) plan covering eligible employees of Sure Fit Inc. and Protect-A-Bed, LLC (collectively, "the Company"). Employees who were over the age of 21 and were not covered by a collectively bargained agreement, leased, or non-resident aliens were eligible to participate and receive discretionary employer matching and profit sharing contributions following completion of one month of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In February 2022, the Plan Sponsor voted to merge the Plan into another existing plan. Effective September 1, 2022, the Plan was amended and merged into the Hollander Sleep Products, LLC Retirement and Savings Plan (Hollander Sleep Products Plan), all assets were transferred out, and the Plan ceased to exist.

2. Contributions

The Plan was funded by voluntary pre-tax and Roth contributions of participants, discretionary employer matching contributions and discretionary profit sharing contributions of the Company. Participants could contribute to the Plan, through regular payroll deductions, and participants who had attained age 50 before the end of the calendar year were eligible for catch-up contributions. Participants could also roll over amounts representing distributions from other qualified employee benefit plans. Effective January 1, 2022, the employees of the Company were transitioned to the payroll of its parent company, and began contributing to the parent company plan. As a result, employee contributions made to the Plan for the period January 1, 2022 through September 1, 2022 were totaling \$31,392 and primarily related to participants who were terminated prior to January 1, 2022 and were entitled to their final compensation package (vacation pay-outs, bonuses, etc.) which was eligible compensation under the provisions of the Plan. The Company made employer matching contributions of \$4,397 and profit sharing contributions of \$2,149 for the period January 1, 2022 through September 1, 2022. Contributions were subject to certain IRS limitations.

2. Contributions (Continued)

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund based on the participants' birth year. Automatically enrolled participants had their deferral rate increased at a rate of 1% per year on January 1st up to a maximum of 10% of eligible compensation, unless otherwise elected by the participant.

3. Investment Options

Participants were permitted to direct their salary deferral contributions and the Company's contributions into a variety of investment funds made available and determined by the Plan Administrative Committee. Participants could change their investment options at any time.

4. Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's contributions, and an allocation of plan earnings. The Company's discretionary matching contributions were allocated based on a percentage of the participant's contribution. The Company's discretionary profit sharing contributions were allocated based on a percentage of eligible compensation for all employees who were eligible to contribute. Plan earnings were allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

5. Vesting

Participants were immediately fully vested in participant and rollover contributions plus the actual earnings thereon. The portion of the participants' accounts attributable to the Company's employer matching and profit sharing contributions became fully vested after three years of service. In the event of death, disability, or retirement at designated ages, participants became fully vested. During 2021, a partial plan termination occurred, and impacted participants were fully vested in all Company contributions.

6. Payment of Benefits

On termination of service, a participant could elect to receive a single, lump-sum payment equal to the value of his or her vested account balance or a direct rollover distribution. In-service withdrawals for participants over the age of 59 1/2 were also permitted by the Plan. Employees were permitted to take hardship withdrawals of employee contributions.

7. Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Participants were permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans were collateralized by the borrowers' respective vested account balances and bore interest at rates ranging from 4.25% to 6.00%. Principal and interest were paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence.

8. Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Investment-related expenses were included in net depreciation in value of investments.

9. Forfeitures

At December 31, 2021, unallocated plan assets resulting from forfeited nonvested accounts were \$142,659. There were no unallocated plan assets as of September 1, 2022. No forfeitures were utilized during the period January 1, 2022 through September 1, 2022.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- * Quoted prices for similar assets or liabilities in active markets;
- * Quoted prices for identical or similar assets or liabilities in inactive markets;
- * Inputs other than quoted prices that are observable for the asset or liability;
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value at December 31, 2021. As discussed in Note G, the Plan did not have any investments at September 1, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note B-2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits are recorded when paid.

NOTE C - INFORMATION CERTIFIED BY ASCENSUS TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 1, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2022 through September 1, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).

NOTE D - TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Ascensus, Inc. The prototype plan had received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter had been relied upon by this Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by Ascensus Trust Company. Ascensus Trust Company was the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Ascensus, LLC was the recordkeeper, and as such, transactions with this party qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issued loans to participants, which were secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest. Employees of the Company provide administrative services to the Plan for which no fees are charged.

NOTE G - PLAN MERGER AND TRANSFER ACTIVITY

During 2021, the Plan Sponsor was acquired by Hollander Sleep Products, LLC. In February 2022, the Plan Sponsor voted to merge the Plan into another existing plan. Effective September 1, 2022, the Plan was amended and merged into the Hollander Sleep Products, LLC Retirement and Savings Plan. As a result, net assets of \$10,830,342 were transferred to the control of the Hollander Sleep Products, LLC Retirement and Savings Plan. Date notices occurred in July 2022 and blackout periods occurred during August and September 2022. The merger does not impact participant benefits as the benefit provisions were incorporated in the Hollander Sleep Products, LLC Retirement and Savings Plan.

NOTE H - EXCESS CONTRIBUTIONS PAYABLE

Excess contributions payable represents amounts withheld from participants in excess of IRS limitations that are to be refunded. As of December 31, 2021, \$6,725 of excess contributions were required to be refunded prior to December 31, of the subsequent year. There were no excess contributions payable as of September 1, 2022.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through July 19, 2023, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions have occurred subsequent to the statement of net assets date that require disclosure in the financial statements.
