#### 1. Description of the Plan

The following description of the Hy-Tek Material Handling, Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information.

##### General

Hy-Tek Material Handling, Inc. (the “Company”) established the Hy-Tek Material Handling, Inc. Employee Stock Ownership Plan effective January 1, 2007. The Plan was designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code), and was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was administered by an ESOP Committee. The Trustee for the Plan was an independent third-party institutional Trustee.

In March 2021, the Company was sold. The Plan’s share of the proceeds from the sale were deposited into the trust. As part of the Company sale transaction, additional escrow funds were deposited into the Plan in 2022 and allocated to all participants in accordance with Plan provisions. Each participant’s remaining interest was transferred from the trust fund in accordance with Plan provisions during 2022.

##### Eligibility

Through March 2021, employees of the Company were eligible to participate in the Plan after three months of service and upon reaching 18 years of age. Participants who did not have at least 1,000 hours of service during a Plan year were generally not eligible for an allocation of Company contributions for such year.

##### Contributions

The Plan provided for employer contributions. The amount of employer contributions for each year was determined by the Board of Directors of the Company. Employer contributions were \$0 for the years ended December 31, 2022 and 2021, respectively.

Other income for the year ended December 31, 2022 was funds from the sale that were required to be held in escrow and were deposited into the trust once certain stipulations were met. Other receivables and income at December 31, 2021 and for the year then ended represented amount due from a participant that was overpaid.

##### Payment of Benefits

No distributions from the Plan were made except those required by law until a participant retired, died (in which case, payment was made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminated employment with the Company. Distributions were made in the form of cash.

Under the provisions of the Plan, the Company was obligated to repurchase participant shares which were distributed under the terms of the Plan as long as the shares were not publicly traded or if the shares were subject to trading limitations.

If the participant’s vested accrued benefit was less than \$5,000, the Trustee could distribute the accrued benefit in any plan year following the plan year in which the participant separated from service.

##### Administrative costs

All administrative expenses were paid out of the Plan unless paid by the Employer. Such expenses included any expenses incident to the functioning of the administrator, including but not limited to, fees of accountants, counsel, and other specialists and their agents, and other costs of administering the Plan. The Company elected to pay a portion of the expenses of the Plan during 2022 and 2021.

##### Voting Rights

Through the date of transfer, the Trustee was entitled to vote any stock held in the trust. Notwithstanding the foregoing, participants (or their beneficiary) were entitled to direct the voting of any voting shares of stock allocated to their stock account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all of the assets of the Company. The Trustee could vote any unallocated shares held by the trust as well as any allocated shares for which a participant has failed to give timely voting direction.

##### Plan Termination

The Company was sold in March 2021. The interest of each participant in the trust fund was distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon final termination of the Plan, the ESOP Committee directed the Trustee to pay all liabilities and expenses of the trust fund.

##### Participant Accounts and Forfeitures

The Plan was a defined contribution plan under which a separate individual account was established for each participant. Each participant's account was credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who were eligible employees of the Company as of the last day of the plan year received an allocation. Allocations were based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings were allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

##### Vesting

If a participant's employment with the Company ended for any reason other than retirement, permanent disability or death, he or she would vest in the balances in his or her account based on years of continuous service with the Company. A participant was 100% vested after 6 years of credited service. Upon termination of the plan, all participants were 100% vested.

##### Diversification

Prior to 2021, diversification was offered to participants close to retirement so that they may have the opportunity to move a portion of their investment in Company stock into investments which are more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan could elect to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50%.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

### Investment Valuation and Income Recognition

Investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits were recorded when paid.

## 3. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 16, 2016, that the Plan was qualified and the trust established under the Plan was tax-exempt, under the appropriate sections of the Internal Revenue Code. The Plan administrator and the Plan's sponsor believes that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 4. Administration of Plan Assets

The Plan's assets, which consisted principally of the Company's common stock and mutual funds prior to March 2021, were held by the Trustee of the Plan. Company contributions were held and managed by the Trustee, which invested cash received, interest, and dividend income and made distributions to participants.

Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses of the Plan were paid directly by the Company.

#### 6. Fair Value Measurements

The Plan's investments were reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of inputs used to measure fair value under this accounting standard are described as follows:

- Level 1 - Quoted prices in active markets that are accessible at the measurement date for identical or similar assets or liabilities.
- Level 2 - Observable inputs other than quoted prices included within Level 1. Inputs that are principally derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value measurement of the assets or liabilities. These include certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

The ESOP Committee, under the supervision of the Company's Board of Directors and Stockholders, determined the fair value measurement policies and procedures in consultation with the Trustee. Those policies and procedures were reassessed at least annually to determine if the valuation techniques were appropriate. At that time, the unobservable inputs used in the fair value measurements were evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value of measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies the Plan used for assets measured at fair value:

Registered investment companies (mutual funds): Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

Common stock: Valued by an annual independent appraisal. This appraisal is based on a combination of a proposed transaction, market and income valuation methods. The appraiser took into account historical and projected cash flow and net income, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The valuation process involved the selection of an appraiser. Plan management accumulated the data for the appraiser from historical and projected financial information of the Company. The appraiser prepared a report of estimated per share value that a participant will receive upon distribution. Plan management reviewed and approved the report based on the relevant information used in the appraisal.

The preceding methods described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

Management evaluated the activity of the Plan through July 21, 2023 (the date the financial statements were available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
