Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Adoption of Liquidation Basis of Accounting

As discussed in Note G to the financial statements, the governing body of Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust approved a plan of liquidation on August 15, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting in 2022 from the going concern basis to the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

PERIOD ENDED NOVEMBER 15, 2022 AND YEAR ENDED DECEMBER 31, 2021

A. DESCRIPTION OF THE PLAN:

The following description of the Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust (the “Plan”) provided only general information prior to termination and disbursement of plan assets. Participants should refer to the Plan agreement and summary plan description for a more complete description of the Plan’s provisions. On August 15, 2022, H & M Acquisitions, LLC was acquired by Dover American Road LLC, and as a result the Plan was terminated. All plan assets were distributed by November 15, 2022.

General - The Plan was a defined contribution plan that covered substantially all employees of H & M Acquisitions, LLC (the “Company” and “Plan Sponsor”) who had completed 90 days of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan allowed other commonly owned employers to adopt its provisions. Ohio MC Riders, LLC, Erie Riders, LLC, Lakeview Motorsports, LLC, Lakeside Motorcycles, LLC and TDG Management Company, all of whom were related to the Company through common ownership, had adopted the Plan.

Contributions - Each year participants could contribute up to 100% of their pre-tax or post-tax (“Roth”) annual compensation, subject to the maximum amount allowed by the Internal Revenue Code (“IRC”) or cause the Plan to exceed the maximum amount allowable as a deduction under IRC Section 404 on a tax-deferred basis. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Company had elected to match 100% of the participants’ voluntary contributions for the first 3% of compensation and 50% of the participants’ voluntary contributions for the next 2% of compensation, which resulted in matching contributions of \$199,081 for the period ended November 15, 2022. Each year, the Company could have made discretionary non-elective contributions to each participant. The Company would provide the plan administrator with written notification of the amount of the contribution to be allocated to each participant. There were no discretionary non-elective contributions for the period ended November 15, 2022.

With the consent of the plan administrator, the Plan could accept participant rollover contributions from other qualified retirement plans.

Participant Accounts - Each participant’s account was credited with the participant’s contributions including elective deferrals and rollover contributions and an allocation of the Company’s contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that was provided from the participant’s account. All investments of the Plan were fully participant directed.

Vesting - A participant was fully vested immediately in elective wage deferrals and in amounts rolled over from other qualified plans. Vesting attributable to employer matching and profit-sharing contributions was as follows:

Effective August 15, 2022, participants became 100% vested in their accounts.

A. DESCRIPTION OF THE PLAN (CONTINUED):

Payment of Benefits - Upon termination of employment due to death, disability or retirement, a participant having a balance of more than \$5,000 may have elected to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. A participant having a vested account balance less than \$5,000 received a lump-sum distribution regardless of whether they consented to receive it.

Non-terminated employees could make withdrawals of a minimum of \$1,000 up to 100% of their vested account balances as a hardship withdrawal prior to reaching normal retirement age. Hardship withdrawals were subject to additional rules and conditions as outlined in the Plan agreement.

Non-terminated employees who had reached age 59½ could make withdrawals of a minimum of \$1,000 up to 100% of their vested account balances as an in-service distribution.

Forfeitures - Forfeitures which occurred pursuant to the Plan could be used to pay any administrative expenses of the Plan, then to reduce profit sharing contributions, then to reduce company matching contributions. As of November 15, 2022, there was no forfeited balance as a result of the plan termination and liquidation. As of December 31, 2021, there were available forfeitures of approximately \$39,000. Prior to August 15, 2022, the Plan had approximately \$7,400 of forfeitures that were used to reduce 2022 company contributions. On August 15, 2022, all balances vested 100%.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Liquidation Basis of Accounting – As a result of the Plan termination, the financial statements are prepared on the liquidation basis of accounting. As such, all amounts in the accompanying financial statements are valued at their fair value.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may have differed from these estimates.

Investment Valuation and Income Recognition - Investments were reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments was included the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Payment of Benefits - Benefits were recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Certain investment management and other fees were paid directly by the Plan. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events - The Company has evaluated subsequent events through July 12, 2023, which is the date the financial statements were available to be issued.

C. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS:

Certain information related to investments disclosed in the accompanying financial statements at November 15, 2022 and December 31, 2021, and investment loss, interest, net depreciation in fair value of investments, and benefits paid from January 1, 2022 to November 15, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Life Insurance Company, the custodian of the fully benefit-responsive investment contract, and Nationwide Financial Services, Inc., the custodian of the mutual funds.

D. FAIR VALUE MEASUREMENTS:

The authoritative accounting guidance established a framework for measuring fair value. That framework provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 - Inputs included quoted prices that were observable for the asset or liability and inputs that were derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability had a specified (contractual) term, the Level 2 input must have been observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 15, 2022 or December 31, 2021.

D. FAIR VALUE MEASUREMENTS (CONTINUED):

Mutual funds: Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan were valued at the daily closing prices as reported by the fund and adjusted upon conversion into units to be allocated to participant accounts, as determined by the custodians.

The preceding method described may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments in the Plan have been liquidated; therefore, there were no investments as of November 15, 2022. All assets measured at fair value as of December 31, 2021, were mutual funds that were classified as level 2 assets within the fair value hierarchy.

E. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan offered the Nationwide Fixed Select Option, which was a group fixed annuity contract issued by Nationwide Life Insurance Company as custodian. The Nationwide Fixed Select Option is a traditional investment contract guaranteed by Nationwide Life Insurance Company that guarantees a rate of interest that will be credited to participant accounts. This contract met the fully benefit-responsive investment contract criteria and was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Due to the nature of the contract, there were no specific underlying assets assigned. As a result, the average yield earned by the Plan was the yield earned (i.e. interest credited) on the group annuity contract. Under the terms of the existing contract, the crediting rate is reset on a quarterly basis. The crediting interest rate is net of administrative fees.

The contract is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of the issuer and not on the value of the securities within the insurer’s general account. Key factors that could influence future crediting interest rates are changes in interest rates, and default or credit failures of the securities in the insurer’s general assets. Past interest rates are not indicative of future interest rates. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The Fixed Select Option contract did not have a maturity date. The provisions did not provide for a distribution at book value at some specified future date. A contract holder could have requested a lump sum distribution with a market value adjustment, or an installment payout, at book value, over a period of years. The Fixed Select Option contract continued in force until all assets were distributed, or no further payments were due.

E. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED):

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

F. TRANSACTIONS WITH PARTIES-IN-INTEREST:

Nationwide Financial Services, Inc. and Nationwide Life Insurance Company were the custodians of the Plan and held all of the Plan's investments. The custodians were considered parties-in-interest of the Plan as defined by ERISA Section 3(14), and accordingly investment transactions in the funds are parties-in-interest transactions. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant eligibility records were absorbed by the Company. Other than as described above, or pursuant to a trust agreement, the Plan had no agreements or transactions with any parties-in-interest.

G. PLAN TERMINATION:

On July 15, 2022, the Company voted to terminate the Plan subject to the provisions of ERISA, effective August 15, 2022. Participants became 100% vested in their accounts. All assets and participant accounts were liquidated and distributed out of the Plan on or before November 15, 2022.

H. INCOME TAX STATUS:

The Plan adopted a prototype non-standardized profit-sharing plan ("the prototype plan") sponsored by FIS Business Systems, LLC. The prototype plan received an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan document was in compliance with applicable requirements of the IRC. The Plan Sponsor adopted this restated prototype plan document on January 1, 2021. The prototype plan opinion letter was relied upon by this Plan. The plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was potentially subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits (in liquidation) as of November 15, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits (in liquidation) for the period from January 1, 2022 to November 15, 2022, and the related notes to the financial statements (in liquidation) (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of November 15, 2022 and December 31, 2021, and for the period January 1, 2022 to November 15, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Adoption of Liquidation Basis of Accounting

As discussed in Note G to the financial statements, the governing body of Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust approved a plan of liquidation on August 15, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting in 2022 from the going concern basis to the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

PERIOD ENDED NOVEMBER 15, 2022 AND YEAR ENDED DECEMBER 31, 2021

A. DESCRIPTION OF THE PLAN:

The following description of the Ohio Motorcycle Group 401(k) Profit Sharing Plan and Trust (the “Plan”) provided only general information prior to termination and disbursement of plan assets. Participants should refer to the Plan agreement and summary plan description for a more complete description of the Plan’s provisions. On August 15, 2022, H & M Acquisitions, LLC was acquired by Dover American Road LLC, and as a result the Plan was terminated. All plan assets were distributed by November 15, 2022.

General - The Plan was a defined contribution plan that covered substantially all employees of H & M Acquisitions, LLC (the “Company” and “Plan Sponsor”) who had completed 90 days of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan allowed other commonly owned employers to adopt its provisions. Ohio MC Riders, LLC, Erie Riders, LLC, Lakeview Motorsports, LLC, Lakeside Motorcycles, LLC and TDG Management Company, all of whom were related to the Company through common ownership, had adopted the Plan.

Contributions - Each year participants could contribute up to 100% of their pre-tax or post-tax (“Roth”) annual compensation, subject to the maximum amount allowed by the Internal Revenue Code (“IRC”) or cause the Plan to exceed the maximum amount allowable as a deduction under IRC Section 404 on a tax-deferred basis. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Company had elected to match 100% of the participants’ voluntary contributions for the first 3% of compensation and 50% of the participants’ voluntary contributions for the next 2% of compensation, which resulted in matching contributions of \$199,081 for the period ended November 15, 2022. Each year, the Company could have made discretionary non-elective contributions to each participant. The Company would provide the plan administrator with written notification of the amount of the contribution to be allocated to each participant. There were no discretionary non-elective contributions for the period ended November 15, 2022.

With the consent of the plan administrator, the Plan could accept participant rollover contributions from other qualified retirement plans.

Participant Accounts - Each participant’s account was credited with the participant’s contributions including elective deferrals and rollover contributions and an allocation of the Company’s contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that was provided from the participant’s account. All investments of the Plan were fully participant directed.

Vesting - A participant was fully vested immediately in elective wage deferrals and in amounts rolled over from other qualified plans. Vesting attributable to employer matching and profit-sharing contributions was as follows:

Effective August 15, 2022, participants became 100% vested in their accounts.

A. DESCRIPTION OF THE PLAN (CONTINUED):

Payment of Benefits - Upon termination of employment due to death, disability or retirement, a participant having a balance of more than \$5,000 may have elected to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. A participant having a vested account balance less than \$5,000 received a lump-sum distribution regardless of whether they consented to receive it.

Non-terminated employees could make withdrawals of a minimum of \$1,000 up to 100% of their vested account balances as a hardship withdrawal prior to reaching normal retirement age. Hardship withdrawals were subject to additional rules and conditions as outlined in the Plan agreement.

Non-terminated employees who had reached age 59½ could make withdrawals of a minimum of \$1,000 up to 100% of their vested account balances as an in-service distribution.

Forfeitures - Forfeitures which occurred pursuant to the Plan could be used to pay any administrative expenses of the Plan, then to reduce profit sharing contributions, then to reduce company matching contributions. As of November 15, 2022, there was no forfeited balance as a result of the plan termination and liquidation. As of December 31, 2021, there were available forfeitures of approximately \$39,000. Prior to August 15, 2022, the Plan had approximately \$7,400 of forfeitures that were used to reduce 2022 company contributions. On August 15, 2022, all balances vested 100%.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Liquidation Basis of Accounting – As a result of the Plan termination, the financial statements are prepared on the liquidation basis of accounting. As such, all amounts in the accompanying financial statements are valued at their fair value.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may have differed from these estimates.

Investment Valuation and Income Recognition - Investments were reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments was included the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Payment of Benefits - Benefits were recorded when paid.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Administrative Expenses - Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Certain investment management and other fees were paid directly by the Plan. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events - The Company has evaluated subsequent events through July 12, 2023, which is the date the financial statements were available to be issued.

C. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS:

Certain information related to investments disclosed in the accompanying financial statements at November 15, 2022 and December 31, 2021, and investment loss, interest, net depreciation in fair value of investments, and benefits paid from January 1, 2022 to November 15, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Life Insurance Company, the custodian of the fully benefit-responsive investment contract, and Nationwide Financial Services, Inc., the custodian of the mutual funds.

D. FAIR VALUE MEASUREMENTS:

The authoritative accounting guidance established a framework for measuring fair value. That framework provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 - Inputs included quoted prices that were observable for the asset or liability and inputs that were derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability had a specified (contractual) term, the Level 2 input must have been observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 15, 2022 or December 31, 2021.

D. FAIR VALUE MEASUREMENTS (CONTINUED):

Mutual funds: Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan were valued at the daily closing prices as reported by the fund and adjusted upon conversion into units to be allocated to participant accounts, as determined by the custodians.

The preceding method described may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments in the Plan have been liquidated; therefore, there were no investments as of November 15, 2022. All assets measured at fair value as of December 31, 2021, were mutual funds that were classified as level 2 assets within the fair value hierarchy.

E. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan offered the Nationwide Fixed Select Option, which was a group fixed annuity contract issued by Nationwide Life Insurance Company as custodian. The Nationwide Fixed Select Option is a traditional investment contract guaranteed by Nationwide Life Insurance Company that guarantees a rate of interest that will be credited to participant accounts. This contract met the fully benefit-responsive investment contract criteria and was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Due to the nature of the contract, there were no specific underlying assets assigned. As a result, the average yield earned by the Plan was the yield earned (i.e. interest credited) on the group annuity contract. Under the terms of the existing contract, the crediting rate is reset on a quarterly basis. The crediting interest rate is net of administrative fees.

The contract is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of the issuer and not on the value of the securities within the insurer’s general account. Key factors that could influence future crediting interest rates are changes in interest rates, and default or credit failures of the securities in the insurer’s general assets. Past interest rates are not indicative of future interest rates. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

The Fixed Select Option contract did not have a maturity date. The provisions did not provide for a distribution at book value at some specified future date. A contract holder could have requested a lump sum distribution with a market value adjustment, or an installment payout, at book value, over a period of years. The Fixed Select Option contract continued in force until all assets were distributed, or no further payments were due.

E. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED):

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

F. TRANSACTIONS WITH PARTIES-IN-INTEREST:

Nationwide Financial Services, Inc. and Nationwide Life Insurance Company were the custodians of the Plan and held all of the Plan's investments. The custodians were considered parties-in-interest of the Plan as defined by ERISA Section 3(14), and accordingly investment transactions in the funds are parties-in-interest transactions. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant eligibility records were absorbed by the Company. Other than as described above, or pursuant to a trust agreement, the Plan had no agreements or transactions with any parties-in-interest.

G. PLAN TERMINATION:

On July 15, 2022, the Company voted to terminate the Plan subject to the provisions of ERISA, effective August 15, 2022. Participants became 100% vested in their accounts. All assets and participant accounts were liquidated and distributed out of the Plan on or before November 15, 2022.

H. INCOME TAX STATUS:

The Plan adopted a prototype non-standardized profit-sharing plan ("the prototype plan") sponsored by FIS Business Systems, LLC. The prototype plan received an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan document was in compliance with applicable requirements of the IRC. The Plan Sponsor adopted this restated prototype plan document on January 1, 2021. The prototype plan opinion letter was relied upon by this Plan. The plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was potentially subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
