Accordingly, all assets were subsequently transferred into that plan as of December 31, 2022. The 2021 financial statements do not include any adjustments that might be necessary upon merger and termination. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of Lectra USA, Inc. (the “Company”) 401(k) & Profit Sharing Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. *General and Plan Merger.* The Plan is a defined contribution plan covering all employees of the Company. There are no age or service requirements to participants in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). On October 12, 2022, the Plan Sponsor elected to merge the Plan into the Lectra USA 401(k) Plan. Accordingly, all investments and participants loans were subsequently transferred to that Plan as of December 31, 2022.
- B. *Contributions.* Each year, participants may contribute up to 60% of pretax annual compensation as defined by the Plan, except that no employee may make annual tax-deferred contributions in excess of amounts provided by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company matches 50% of each participant’s current pre-tax contribution limited to 5% of their eligible compensation.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s deferral contribution and allocations of (a) the Company’s contribution (if any) and (b) plan earnings including administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately vested in their salary deferral contribution plus actual earnings thereon. Vesting in the Company’s contribution portion, if any, of their account plus actual earnings thereon is based on years of continuous service; a participant is 100% vested after five years of credited service with the vesting percentage accruing ratably each year of the period.
- E. *Participant Loans.* Participants may borrow from their fund accounts a minimum of \$1,000 and up to fifty percent (50%) of their vested account balance, not to exceed \$50,000. The loans are secured by the balance in the participant’s account and bear interest at fixed rates ranging from 4.25% to 6.75%, which are based on the prime rate published in the *Wall Street Journal* on the first business day of each month plus two percent (2%). Principal and interest is paid through biweekly payroll deductions.
- F. *Payment of Benefits.* Distributions from the Plan are made in the form of a lump sum of a Participant’s entire vested account balance or a single sum distribution of a portion of the Participant’s vested account balance. Optional forms of payment available upon termination of employment include lump sum distribution of entire vested balance or single distribution of a portion of the vested account balance.

G. *Forfeited Accounts.* Forfeitures may be used to reduce future employer contributions. These amounted to \$44,970 in 2022.

H. *Plan Amendment.* The Plan was amended, effective February 5, 2010, to exclude bonuses from compensation for the purposes of computing employee deferrals and employer matching contributions.

2. SUMMARY OF ACCOUNTING POLICIES

A. *Basis of Accounting.* The financial statements of the Plan are prepared under the accrual method of accounting.

B. *Payment of Benefits.* Benefit payments are recorded when paid.

C. *Investment Valuation and Income Recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

E. *Notes Receivable from Participants.* Participant loans are evaluated by management for default and write-offs are deemed as distributions. Starting on January 1, 2012, with the adoption to changes within Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contributions Pension Plans*, participant loans were reclassified from investments to notes receivables from participants.

F. *Subsequent Events.* Plan management has evaluated the need for disclosures or adjustments resulting from subsequent events through July 19, 2023, the date the financial statements were available for issuance. No events were identified that required disclosure in or adjustments to the financial statements.

3. INVESTMENT CONTRACT WITH TRUSTEE

During 2013, the Plan entered into an investment contract with PNC Institutional Investments (PNC). During 2019 PNC was merged into Newport Retirement Services (NRS), which now holds the investment contract. Funds are participant-directed into investment funds. The investment funds are managed either by external mutual fund companies or by NRS, and the accounts are included in these financial statements at fair market value as reported by NRS.

4. INVESTMENTS

The following investments represented five percent or more of the Plan's net assets available for benefits at December 31, 2021:

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$3,092,083 in 2022 and appreciated in value by \$703,851 in 2021. The changes in value were entirely attributable to mutual funds.

5. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following describes the valuation methodologies used for assets measured at fair value on a recurring basis. The techniques utilized in estimating the fair values of financial instruments are reliant on the assumptions used. Care should be exercised in deriving conclusions based on the fair value information of financial instruments presented below. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument.

Mutual Funds – The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets. Lifecycle funds are managed based on a target date. Due to similar valuation techniques, they are classified as mutual funds.

Money Market Fund – The money market fund is held as an individual plan asset, has a principal value of \$1 per unit and has an available price quoted daily in an active market.

The preceding described methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2021, plan management evaluated the lifecycle funds and determined, based on the underlying assets of mid to large cap stock, that these funds should be classified as Level 1. The Plan investments at fair value classified within Levels 2 and 3 were zero as of December 31, 2022 and 2021.

6. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. The Plan was merged into another 401(k) plan during 2022. See Note 1.

7. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, NRS, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021. NRS has also certified the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2022 and 2021, and the schedule of assets held at end of year.

8. RELATED-PARTY TRANSACTIONS

Certain plan investments are money market and mutual funds managed by an affiliate of NRS, the trustee of the Plan, and, therefore, these are considered party-in-interest transactions.

The Plan also pays administrative fees to NRS. These fees are considered exempt party-in-interest transactions. Other administrative expenses of the Plan are absorbed by the Plan sponsor. Therefore, those expenses are not reflected in these statements.

9. TAX STATUS

The Plan utilized a service provider to handle administrative matters including plan design. An opinion letter from the Internal Revenue Service has been obtained by the service provider accepting the Plan as a prototype qualifying under the appropriate Internal Revenue Code Sections. The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2015.

10. RISK AND UNCERTAINTIES

The Plan provides various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
