Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the CareCloud Health, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 13, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to December 13, 2022, and for the year ended December 31, 2021 and the related notes to the financial statements.

Notes to the Financial Statements

December 13, 2022 and December 31, 2021

(1) Description of plan

The following description of the CareCloud Health, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Adoption Agreement and Summary Plan Description, for a more complete description of the Plan's provisions. CareCloud Corporation (the "Plan Administrator" or the "Company") is the Plan Sponsor.

On March 29, 2021 the CareCloud 401k Plan was renamed to the CareCloud Health, Inc. 401(k) Plan (the "Plan").

The Plan was amended effective December 1, 2022 and the Plan's net assets were merged into the CareCloud, Inc. 401(k) Plan on December 13, 2022.

(a) General

The Plan was a defined contribution plan which was adopted to provide retirement benefits for employees of CareCloud Health, Inc. The Plan covered substantially all employees of the Company who were at least age 21 ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Contributions to the Plan were made by the participants and the Company. Participants could elect to defer a percentage of their annual compensation, as defined by the Plan and consistent with the Internal Revenue Service ("IRS") limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Additionally, participants could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution).

The Plan allowed participants to designate certain salary deferral contributions as Roth elective contributions. Designated Roth contributions were included in the gross taxable income of the participant, but distributions of designated Roth contributions and earnings thereon, were excludable from gross taxable income for that participant.

The Company may elect to make discretionary employer matching contributions in accordance with the Plan document. The Company made discretionary employer matching contributions of \$80,772, net of forfeitures of \$80,235, and \$222,999 for the period from January 1, 2022 to December 13, 2022 and the year ended December 31, 2021, respectively.

In addition, the Company could elect to make profit sharing contributions in accordance with the Plan document. For the period from January 1, 2022 to December 13, 2022 and the year ended December 31, 2021, the Company did not make any profit sharing contributions into the Plan.

(c) Participant accounts

Each participant's account was credited (charged) with the participants' and Plan Sponsor contributions and allocations of investment earnings (losses) and administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were fully vested in their elective salary deferral contributions plus actual earnings thereon. Vesting in the Company's matching contributions and profit sharing contributions was based on three years of continuous service, according to the vesting schedule below:

Less than 1	0%
1	25%
2	50%
3	100%

Participants were 100% vested, regardless of the above schedule upon reaching retirement age, becoming disabled, or upon death.

(e) Forfeitures

Forfeitures were created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures could be used to pay administration expenses of the plan and to reduce the Plan Sponsor's contributions to the Plan. Forfeitures of \$95,952 and \$20,809 were utilized to reduce the Company's matching contributions and pay plan expenses during the period from January 1, 2022 to December 13, 2022 and the year ended December 31, 2021, respectively. Forfeited nonvested accounts totaled \$37,456 as of December 31, 2021.

(f) Payment of benefits

Upon termination of service for any reason, a participant could elect to receive either a lump-sum amount or rollover payment equal to the vested value of his or her account or have the amount remain invested in the account if the balance was greater than \$5,000. Vested benefits less than \$5,000 could be distributed in a lump-sum amount without the participant's election.

(g) Notes receivable from participants

Participants could borrow a minimum of \$1,000 from their fund accounts and up to a maximum equal to the lesser of \$50,000, or 50% of participants vested account balance. Participants could only have one loan outstanding at any point in time. Loans and interest were repaid ratably through payroll deductions.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments were stated at fair value as reported by Ascensus, as agent for Ascensus Trust Company ("Ascensus"). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determined the Plan's valuation policies utilizing information provided by Ascensus. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income is recorded when earned. Dividends were recorded on the ex-dividend date. Net (depreciation) appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan agreement.

(e) Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") required management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

Management of the Plan has evaluated events and transactions that occurred between December 13, 2022 and July 21, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants presented and disclosed in the accompanying financial statements, including investments at fair value and notes receivable from participants held at December 13, 2022 and 2021, and net (depreciation) appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the period from January 1, 2022 to December 13, 2022 and for the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus.

(4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

- (i) *Mutual funds and money market fund:* Valued at the net asset value ("NAV") of shares held by the Plan at year end in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan which received a favorable opinion letter on June 30, 2020, in which the IRS stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself had not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan Sponsor believed that the Plan had been designed to comply with and was operating in accordance with the requirements of the IRC, and therefore, believes the Plan was qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan, and has concluded that as of December 13, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

Certain investments were managed by The Vanguard Group, Inc., the recordkeeper of the Plan. Therefore, those transactions qualified as party-in-interest transactions under ERISA. The Plan held notes receivable from participants which qualify as party-in-interest transactions. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.
