We have audited the financial statements of Vandeventer Black LLP 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) for the period ended June 30, 2022, and we have issued our report thereon dated July 19, 2023. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by Fidelity Management Trust Company, the “Trustee”. Which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America (“U.S. GAAP”). SIGNIFICANT AUDIT MATTERS

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during the period ended June 30, 2022. We noted no transactions entered into by the Plan during the period for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management’s knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management’s assessment of the various criteria in the valuation hierarchy (using Levels 1, 2, or 3 valuation inputs) by which fair values of investments were determined under Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*. We evaluated the key factors and assumptions used to make your assessments of the valuation criteria used, and the application of those criteria, for each Plan investment in determining that they were reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements were:

The disclosure of the measurement of fair value for each investment held by the Plan. The Plan followed the guidance of ASC 820 which requires that the Plan disclose how they determined the fair value of its investments by three levels of inputs. The three levels of inputs are: 1) quoted prices in the active market, 2) significant observable inputs, and 3) significant unobservable inputs.

The Plan amendment effective June 30, 2022 as further described in Note 1. The amendment resulted in a change of Plan name and a change in the Plan sponsor. The amendment resulted in a transfer of all Plan assets to the amended plan (Woods Rogers Vandeventer Black 401(k) and Profit Sharing Plan) effective June 30, 2022.

The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. The following material misstatement detected as a result of audit procedures was corrected by management: Adjusting journal entry to record the receivables relating to the profit sharing contribution.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated July 19, 2023.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

OTHER MATTERS

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the supplemental schedule required by ERISA, other than that agreed to or derived from the certified investment information, is presented in compliance with Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of the Trustees and management of Vandevanter Black LLP 401(k) Profit Sharing Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

We have performed an audit of the accompanying financial statements of Vandeventer Black LLP 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the six months ended June 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of June 30, 2022 and December 31, 2021 and for the six months ended June 30, 2022, stating the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

The amendment resulted in a transfer of all Plan assets to the amended plan (Woods Rogers Vandeventer Black 401(k) and Profit Sharing Plan) effective June 30, 2022. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Note 1—Description of the Plan

The following brief description of the Vandeventer Black LLP (the “Firm” or “Employer”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all full-time and non-leased employees of the Firm who have 12 months of service. The Firm’s Executive Board is responsible for controlling and managing the operation and administration of the Plan. Fidelity Management Trust Company serves as the “Trustee” of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Vandeventer Black LLP entity (EIN 54-0619797) ceased to exist at midnight on June 30, 2022. Effective July 1, 2022, the Plan sponsor, Vandeventer Black LLP merged into Woods Rogers PLC. The firm then renamed itself Woods Rogers Vandeventer Black PLC. Effective July 1, 2022, the Plan was amended to change the name to Woods Rogers Vandeventer Black 401(k) and Profit Sharing Plan. In addition, the name and the EIN of the sponsor were changed to Woods Rodgers Vandeventer Black PLC and 54-1294386, those of the surviving entity of the merger. The amendment resulted in a transfer of all Plan assets to the amended plan (Woods Rogers Vandeventer Black 401(k) and Profit Sharing Plan) effective June 30, 2022.

Contributions – Participants may contribute up to 90% of their pretax annual compensation each year, as defined in the Plan document, subject to Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Firm may provide a matching contribution and discretionary profit sharing amounts at the option of the Firm’s Executive Board. The Firm’s matching contribution was 50% of the first 6% of compensation contributed by each participant for 2022 and 2021. The Firm’s profit sharing contribution was \$115,737 for the period ended June 30, 2022 and \$182,024 for the year ended December 31, 2021. Contributions are subject to certain limitations.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Firm’s contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 20% vested after two years of service, 40% vested after three years, 60% vested after four years, 80% vested after five years, and 100% fully vested after six years of service.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocation of (a) the Firm’s contributions and (b) investment earnings or losses (including net appreciation and depreciation in fair value of investments), and charged with benefit payments and transaction fees related to notes receivable from participants and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value fund as investment options for participants. In addition, participants may utilize an individual self-directed brokerage option, through which participants are able to invest in a variety of securities including stocks, bonds, mutual funds, money market funds, closed end funds, exchange traded funds, bank deposit accounts, unitized trusts, and government securities in accordance with the Plan’s investment policy.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. At June 30, 2022 and December 31, 2021, outstanding loans bore interest rates ranging from 4.25% to 6.50%. Principal and interest are paid through payroll deductions.

Note 1—Description of the plan (continued)

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in their account in either a lump sum amount or various annuity options, as provided by the Plan. Hardship distributions are available from vested balances upon demonstration of financial hardship, with limitations defined in the Plan. In-service distributions are available from rollover accounts and Firm contribution accounts, if fully vested. In-service distributions are available from salary deferred accounts after the participant reaches age 59½.

Forfeitures – At June 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$23,306 and \$30,800, respectively. These amounts will be used to pay Plan expenses or reduce future Firm contributions. During the six months ended June 30, 2022 and the year ended December 31, 2021, forfeitures of \$7,516 and \$28,375 were used to pay Plan expenses.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by Fidelity Investments, the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. No allowance for credit losses was recorded as of June 30, 2022 and December 31, 2021. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded upon distribution.

Administrative Expenses – The Plan’s administrative expenses are paid by either the Plan or the Firm, as provided by the Plan document. Certain administrative functions are performed by employees of the Firm. No employee receives compensation from the Plan. Expenses related to specific participant transactions (notes receivable from participants, distributions, and advisory services) are charged directly to the participant’s account. Investment related expenses are included in net appreciation of fair value of investments.

Note 3—Fair value measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at June 30, 2022 or December 31, 2021:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 of the valuation hierarchy.

Stable Value Fund – A stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at NAV of units of the bank collective trust. NAV is used as a practical expedient to estimate fair value and the fund is, therefore, excluded from classification in the fair value hierarchy. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a 12-month notification in order to ensure securities liquidations will be carried out in an orderly business manner.

Money Market Fund – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. The Trustee establishes the market and quotes the price, on a daily basis, that is available to market participants, which is a market approach to valuation. This investment is classified as Level 1 of the valuation hierarchy.

Self-Directed Brokerage Accounts – Valued by the Trustee of the assets, based on the closing prices reported on active markets in which the securities are traded and are classified as Level 1 of the valuation hierarchy.

Note 4—Unaudited information certified by Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified to the completeness and accuracy of the following data included in the accompanying financial statements as of June 30, 2022 and December 31, 2021.

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021.
- Net depreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2022.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of June 30, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

Note 5—Party-in-interest transactions

Certain Plan investments are funds managed by Fidelity Investments ("Fidelity"). Fidelity is an affiliate of the Trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management and other investment services are included as a reduction of the return earned on each fund. The Plan paid Fidelity or its affiliates \$4,667 and \$15,899 during 2022 and 2021 for administrative services. Notes receivables from participants qualify as party-in-interest transactions. The Plan paid \$0- and \$16,900 for audit and other accounting services during 2022 and 2021.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their account balances. The amendment as described in Note 1 resulted in a transfer of assets to the amended plan (Woods Rogers Vandeventer Black 401(k) and Profit Sharing Plan) effective June 30, 2022. This was not considered a Plan termination.

Note 7—Tax status

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated March 31, 2014, that the volume submitter plan document was designed in accordance with applicable sections of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9—Reconciliation of financial statements for Form 5500

The following is a reconciliation of net assets available for benefits per the accompanying financial statements to Schedule H of Form 5500 as of June 30, 2022 and December 31, 2021. As discussed in Note 10 the Plan was amended effective July 1, 2022. Accordingly, and for the sole purpose of filing the final Form 5500, the assets of the Plan are reflected as being transferred from the Plan as of June 30, 2022. Note 10—Subsequent events

Effective July 1, 2022, the Plan sponsor, Vandeventer Black LLP merged into Woods Rogers PLC. The firm then renamed itself Woods Rogers Vandeventer Black PLC. The Vandeventer Black LLP entity (EIN 54-0619797) ceased to exist at midnight on June 30, 2022. Effective July 1, 2022, the Plan was amended to change the name to Woods Rogers Vandeventer Black 401(k) and Profit Sharing Plan. In addition, the name and the EIN of the sponsor were changed to Woods Rodgers Vandeventer Black PLC and 54-1294386, those of the surviving entity of the merger. All participant balances in the Plan will continue under the amended plan. Management is currently working with the Trustee to migrate the balances and participants from the legacy Woods Rogers PLC plan into this Plan and anticipates this migration to be completed later in 2023.

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through July 19, 2023, the date these financial statements were available to be issued.

Please accept this letter as our explanation for the late filing of the Form 5500 report for the Vandeventer Black LLP 401(k) Profit Sharing Plan, for the period of 6 months ended 6/30/2022. The late reporting is due to the demands and complexities of our recent *merger*.

On 7/1/2022 Vandeventer Black LLP (EIN 54-0619797) merged into Woods Rogers PLC (EIN 54-1294386 ... this is also the EIN of the post-merger, surviving entity). This was an unusual filing, as this is the final 5500 filing for the "old" entity. We also needed to have a "short year" audit of the first 6 months.
