Basis for Opinion

Emphasis of Matter – Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of Deist Industries, Inc., the Plan Sponsor, voted on December 20, 2021 to terminate the Plan, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting to the liquidation basis of accounting used in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued (or within one year after the date that the financial statements are available to be issued when applicable).

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of Plan

The following description of the Buck's Fabricating 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

Prior to termination, the Plan was a safe harbor defined contribution plan covering substantially all eligible employees of Deist Industries, Inc. (the Plan Sponsor). The Plan was formed on January 1, 1996 (as restated, effective January 1, 2018) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Prior to the termination of the Plan, in order to be eligible to participate, eligible employees were required to satisfy both an age requirement and complete 90 days of service.

Plan Termination and Liquidation

Effective December 20, 2021, the Plan Sponsor's Board of Directors adopted a resolution to terminate the Plan effective December 31, 2021. As a result, management determined that liquidation was imminent. Participants became 100% vested in their total account balance as of the termination date. All participants were notified on December 20, 2021 of the Plan's termination and that they were required to take a distribution within a reasonable period of time after the termination date.

Effective December 9, 2022, the Plan was fully liquidated.

Contributions

Prior to the termination of the Plan, participant contributions were made on a tax-deferred basis, as well as Roth deferrals to the Plan through payroll deductions, and such elective deferrals were subject to the federal tax laws governing the limits on elective deferrals. Rollover contributions to the Plan from other qualified plans were permitted by eligible employees. The Plan Sponsor made safe harbor matching contributions to each participant's account in an amount equal to each participant's elective deferrals up to 3% plus 50% of deferrals between 3% and 5%. Prior to termination, each year, at the discretion of the Plan Sponsor's Board of Directors, profit sharing contributions to the Plan were decided upon. Such contributions were allocated to each eligible participant's account in proportion to the total eligible participants compensation. Additionally, at the discretion of the Plan Sponsor, a discretionary matching contribution may be made to the Plan equal to a uniform percentage of participant salary deferrals. No discretionary contributions were made for the years ended December 31, 2022 or 2021.

Participant Accounts

Effective December 31, 2021, the date of Plan Termination, employees were no longer permitted to enter the Plan and no contributions were allowed for periods after such date.

Prior to the termination of the Plan, participants directed the investment of their account within the investment funds offered by the Plan. Each participant's account was credited with the participant's contribution and allocation of (a) their respective employer's contribution (b) Plan earnings or losses and (c) forfeitures of terminated participants' non-vested accounts if not used to pay Plan expenses. Allocations were based on participant compensation; the Plan did not take into account compensation paid after the effective date of plan termination.

1. Description of Plan (continued)

Vesting

Participants were immediately vested in their voluntary contributions, rollover contributions and the Plan Sponsor's safe harbor contributions, plus actual earnings thereon. Prior to the termination of the Plan, matching contributions and earnings, if any, vested at the rate of 20% for each year of service earned after the first year of service. Additionally, a participant became 100% vested upon death, total disability, normal retirement age or Plan termination.

Notes Receivable from Participants

Prior to the termination of the Plan, participants who incurred a financial hardship or had a specified financial need were able borrow from their vested account balance a minimum of \$1,000, not to exceed the lesser of one-half of the vested participant account balance, or \$50,000, reduced by the participant's highest outstanding note receivable balance outstanding within the last twelve-month period. The note receivable was collateralized by the participant's account balance and had a reasonable fixed rate of interest as defined by the Plan. Notes receivable required a definite repayment period not to exceed five years, unless the note receivable was for the purchase of a principal residence, which allowed for a longer repayment term.

A participant who terminated employment with an outstanding note receivable was advised to pay off the outstanding balance of the note receivable within a reasonable amount of time after termination. If the participant elected to not repay the entire outstanding loan balance, the remaining outstanding balance of the note receivable was deemed a distribution to the participant and treated as a taxable event to the participant.

Forfeitures

Prior to termination of the Plan, non-vested balances resulting from discretionary employer contributions and any earnings thereon were forfeited upon distribution. Based on the discretion of the Plan Sponsor, forfeited non-vested balances were available to be used for payment of administrative expenses or to reduce certain future employer contributions. There were no unallocated forfeitures at December 31, 2022 or 2021.

Benefit Payments

Prior to termination of the Plan, a participant was entitled to receive the vested portion of his or her account upon termination of employment, normal retirement (age 65), disability or death. Participants became 100% vested in their accounts upon reaching normal retirement age of 65 or their 5-year anniversary of joining the Plan, if later. Installments were permitted, but only with respect to minimum required distributions. Prior to the termination of the Plan, working participants that attained the age requirement of 59 ½ could request in-service withdrawals from the Plan from accounts the participant was 100% vested in. Benefits are recorded when paid.

Administrative Expenses

The Plan was responsible for payment of administrative expenses not paid by the Plan Sponsor. These expenses were not material to the Plan's financial position and results from operations. For the years ended December 31, 2022 and 2021, the Plan paid advisory, recordkeeping, and certain fund management fees out of Plan assets, characterizing these fees as administrative fees. Fees paid by the Plan for the investment management and recordkeeping services totaled \$19,535 and \$5,763 for the years ended December 31, 2022 and 2021, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the termination of the Plan, the accompanying financial statements have been prepared in accordance with the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect amounts reported in the financial statements and related disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

As a result of the termination of the Plan, the Plan's investments are stated at liquidation value, which approximates fair value, except for the fully benefit-responsive contract, which is recorded at contract value. Contract value was the relevant measure for the portion of the net assets available for benefit of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would have received if they initiated permitted transactions under terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date-basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

The Plan has evaluated subsequent events through July 17, 2023, the date the financial statements were available to be issued.

3. Tax Status of the Plan

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the trust established under the Plan to hold the Plan's assets qualifies under Section 401(a) of the Internal Revenue Code (the Code) and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

Management has evaluated the Plan's tax positions in accordance with the Financial Accounting Standards Board (FASB) issued guidance on accounting for uncertainty in income taxes and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. Although terminated, the Plan may still be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2019.

4. Investments

For the years ended December 31, 2022 and 2021, the Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and regulations for Reporting and Disclosure under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements, including investments held at December 31, 2022 and 2021, and net realized and unrealized (depreciation) appreciation in fair value of investments, interest and dividend income, and administrative expenses for the years ended December 31, 2022 and 2021, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the trustee, Voya Retirement Insurance and Annuity Company (VRIAC).

The financial information certified by the trustee and the custodian, VRIAC, have been adjusted to reflect minor timing differences related to financial statement presentation in accordance with accounting principles generally accepted in the United States of America.

5. Fair Value Measurements

Investments were recorded at estimated fair value, in accordance with FASB ASC's *Fair Value Measurements and Disclosures* topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC's *Fair Value Measurements and Disclosures* topic are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

5. Fair Value Measurements (continued)

Pooled separate accounts: Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the pooled separate accounts which is not publicly quoted. These pooled separate accounts are classified as Level 2. The redemption frequency of each of these pooled separate accounts is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan's investment in pooled separate accounts.

Self-directed brokerage accounts (SDBA): The securities held within the SDBA are standard assets such as mutual funds, equities, cash and cash equivalents and fixed income assets. These holdings are reported at quoted market price. These assets are included in Level 1.

6. Guaranteed Investment Contract (GIC)

The Plan participated in one GIC related investment option, the Voya Fixed Account, issued by VRIAC (a party-in-interest). The contract underlying this investment option is considered to be fully benefit responsive in accordance with ASC Topic 962, *Plan Accounting - Defined Contribution Pension Plans*. At December 31, 2021, the contract value of the investment in insurance contracts was \$10,337. As of December 31, 2022, due to Plan termination, all participant balances in the GIC were distributed at contract value.

The crediting interest rates to participants for the Voya Fixed Account as of December 31, 2022 and 2021 was 3.00%. The guaranteed minimum crediting interest rates for the contract for the years ended December 31, 2022 and 2021 was 3.00%. VRIAC makes this guarantee, and although VRIAC may credit a higher interest rate, the credited rate will not fall below the lifetime guaranteed minimum of 3.00%.

VRIAC's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

6. Guaranteed Investment Contract (GIC) (continued)

Prior to termination of the Plan, certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

Prior to the Plan's termination, VRIAC had the option to payout 100% of the current value of the contract after completion of five contract years.

7. Related Party Transactions

Prior to termination of the Plan, the Plan's participants were able to maintain balances in certain funds managed by VRIAC who acts as trustee for investments of the Plan. The Plan also issued loans to participants prior to termination of the Plan, which were secured by the balances in the respective participant accounts. Transactions in such investments qualified as party-in-interest transactions and were exempt from the prohibited transaction rules.


