Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of Marks Paneth 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 29, 2022 (in liquidation) and December 31, 2021 (ongoing) and the related statement of changes in net assets available for benefits for the period January 1, 2022 through December 29, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Marks Paneth 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution, in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 29, 2022 (in liquidation) and December 31, 2021 (ongoing) and for the period January 1, 2022 through December 29, 2022 (in liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Marks Paneth 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Marks Paneth 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Information Required by ERISA

The supplemental information of Schedule H, line 4i – schedule of assets (held at end of year), as of December 29, 2022 (in liquidation), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



Our opinion is not modified with respect to this matter.

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of Marks Paneth 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility

The Plan was established on January 1, 1994 and was available to eligible employees of Marks Paneth, LLP (the Company, Employer or Plan Sponsor). The Plan was amended and restated through the years to comply with certain tax legislation. Eligible employees, except interns, who had completed one (1) month of credited service, were eligible to make elective deferrals. The Company is the Plan Administrator.

Great-West Life & Annuity Insurance Company of New York and Great-West Trust Company, LLC (collectively, the Trustee) served as the Trustee to the Plan. The Trustee's affiliate, Empower Retirement, provided recordkeeping services to the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Termination of Plan

Effective January 1, 2022, the Plan Sponsor joined CBIZ, Inc. and ceased operations. Accordingly, on December 31, 2021, the Plan Sponsor elected to terminate and the Plan effective January 1, 2022, and all remaining participants became fully vested in their account balances. All assets of the Plan were distributed by December 29, 2022. As a result, the accompanying 2022 financial statements are presented on the liquidation basis of accounting.

Effective January 1, 2022, participant contributions to the Plan were discontinued as a result of the impending Plan termination.

Contributions

Participants in the Plan could voluntarily contribute up to 100% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). The Plan's provisions also allowed participants to make Roth 401(k) elective deferrals. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor could make discretionary matching contributions to the Plan. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year in order to be eligible for discretionary matching contributions. There were no Employer contributions for the period January 1, 2022 through December 29, 2022 (in liquidation).

Contributions are subject to certain IRS limitations.

Participant accounts

Each participant account was credited with the participant's contribution and an allocation of: (a) the Employer's contributions (if any) and (b) Plan earnings or losses thereon, and was charged with his or her withdrawals and Plan administrative expenses. Allocations were based on participant earnings, deferrals, or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account. Each participant directed the investments of his or her account to any of the investment options available under the Plan.

Note 1 – Description of Plan, Continued

Vesting

Participants were immediately vested in their individual contributions, plus actual earnings or losses thereon. Vesting in the Employer's contributions, plus any earnings or losses thereon, was based on years of continuous service. Participants who became eligible, and were enrolled in the Plan, received vesting credit for years of service based only on the elapsed time method, as defined. Vesting in the Company's discretionary matching contributions (if any), plus any earnings or losses thereon, was based upon the number of years of continuous service as listed below:

Years of Service	Vesting Percentage
Less than one year	0%
One, but less than two	20%
Two, but less than three	40%
Three, but less than four	60%
Four, but less than five	80%
Five or more	100%

Participant accounts become fully vested upon reaching normal retirement age of sixty-five (65), death, disability, or upon Plan termination.

Effective January 1, 2022, all participant accounts became fully vested due to the Plan termination.

Forfeitures

Nonvested forfeited accounts may be used to offset Plan administrative expenses or reduce Employer contributions. During the period January 1, 2022 through December 29, 2022, forfeitures were used to offset Plan administrative expenses totaling \$81,714. As of December 29, 2022 and December 31, 2021, unallocated forfeitures totaled \$0 and \$375,563, respectively.

Participant notes receivable

Plan participants could borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans were required to be repaid within a period of five years. Loans were secured by the vested account balance in the participant's account, and bore interest at 1% over the prime rate on the first business day of the month the loan is originated. A participant could have up to two (2) loans outstanding at any given time. Principal and interest were paid ratably through regular payroll deductions. Any delinquent notes receivable from participants were recorded as distributions and the notes are collateralized by the participants' account balances.

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or in monthly installments. For termination of service due to other reasons, a participant could choose to leave the vested interest in the Plan if such amounts exceed \$5,000 or elect a lump-sum distribution. Participants with vested amounts less than \$5,000 must elect a lump-sum distribution. Benefit payments to participants were recorded upon distribution. Participants could elect to take an in-service distribution of vested funds if they meet certain defined requirements, including becoming disabled, or for heavy financial hardship needs, as defined. The Plan did not provide for an early retirement age provision.

Administrative expenses

The Plan allowed certain administrative expenses to be paid from Plan investment assets and recorded as administrative expenses. Certain administrative expenses are paid directly by the Plan Sponsor and are not reflected in these financial statements. Investment management fees were charged to the Plan as a reduction of investment return and included in investment income reported by the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP). The accompanying financial statements for the period ended December 29, 2022 have been prepared on the liquidation basis of accounting in accordance with U.S. GAAP.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and the Trustee.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in net assets and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and those differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible changes in risks in the near-term would materially affect participants' account balances and the amounts reported in the financial statements.

Participant notes receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are charged directly to the borrowing participants account and included as administrative expenses when incurred. No allowance for credit losses had been recorded at December 29, 2022 and December 31, 2021. If a participant ceases to make scheduled repayments and the Plan Administrator deemed the participant note receivable to be in default, the note receivable balance is reclassified, and a benefit payment recorded.

Payment of benefits

The Plan records benefits when paid.

Plan administration

The Company is the Plan Administrator, and as such, controlled and managed the operations of the Plan. The Plan's investment assets were maintained by Great-West Life Annuity Insurance Company of New York and Great-West Trust Company LLC (collectively, Great-West or the Trustee) as of December 29, 2022 and December 31, 2021 and for the period January 1, 2022 through December 29, 2022. The Trustee invested cash received, interest and dividend income and made distributions to participants (subject to the direction of participants). Empower Retirement, an affiliate of the Trustee, provided recordkeeping services to the Plan. Fees from covered service providers of the Plan were in compliance with the Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2).

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at December 29, 2022 that it would be unable to substantiate.

Note 3 – Investment Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Life & Annuity Insurance Company of New York and Great-West Trust Company, LLC, collectively, the Trustee, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and participant notes receivable as shown on the statements of net assets available for benefits as of December 29, 2022 (in liquidation) and December 31, 2021 (ongoing);
- Net investment activity and interest income on participant notes receivable as shown in the statement of changes in net assets available for benefits for the period January 1, 2022 through December 29, 2022 (in liquidation); and
- Investment information included in the schedule of assets (held at end of year) as of December 29, 2022 (in liquidation), as shown on the ERISA-required supplemental schedule.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 4 – Fair Value Measurements, Continued

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 29, 2022 (in liquidation) and December 31, 2021 (ongoing). During the period January 1, 2022 through December 29, 2022 (in liquidation), there were no transfers of financial instruments into or out of Level 3.

Following is a description of the value methodologies used for assets measured at fair value:

Mutual funds – valued at quoted market prices, which represent their daily net asset value (NAV) and therefore classified as Level 1. Mutual funds held by the Plan are open-end mutual funds that are traded on national exchanges (active markets).

Common and preferred stocks – consists of individual common stocks and preferred stocks which are valued at the closing price reported on active markets on which the individual securities are traded.

Money market funds – fair value is measured based on the quoted market price for the money market fund. The money market fund always has a net asset value of \$1.

Corporate bonds – valued on the last trade price of the fiscal year. When the corporate bond has not traded on the last day of the fiscal year, the price is obtained from an independent third-party pricing company.

U.S. government and agency obligations – valued using quoted prices in active markets for similar or identical assets.

Collective trusts – are measured at the NAV of units of the collective trusts. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the trust would sell its underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully Benefit Responsive Investment with Insurance Company

The Plan had a traditional fully benefit-responsive investment contract with Great-West Life and Annuity Insurance Company of New York (GWL&A) totaling \$191,515 as of December 31, 2021. GWL&A maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participant's principal and interest were fully guaranteed by the general accounts of GWL&A. The methodology for calculating the interest crediting rate was based on the earnings on the underlying investments, in the entire medium-long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. GWL&A was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate was reviewed on a quarterly basis for resetting. The contract does not permit GWL&A to terminate the agreement prior to the scheduled maturity date.

Note 5 – Fully Benefit Responsive Investment with Insurance Company, Continued

The contract met the fully benefit-responsive investment criteria and, therefore, was reported at contract value. Contract value was the relevant measurement for fully benefit-responsive investment contracts, because it was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Under the terms of the investment contract, participants could direct the withdrawal or transfer of all or a portion of their balance in the investment option at contract value. Contract value, as reported to the Plan by GWL&A, represented contributions made under the contract, plus earnings, less participant withdrawals and expenses.

The Plan's ability to receive amounts due was dependent on GWL&A's ability to meet its financial obligations. GWL&A's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Note 6 – Related Party and Party-In-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan's investments included shares of mutual funds, collective trust funds, and a guaranteed investment contract issued, managed and/or administered by Great-West which was the Plan's Trustee. Empower Retirement, an affiliate of the Trustee, was the Plan's recordkeeper, and accounted for investment transactions and participant accounts. Therefore, transactions and the related fees charged by Great-West and Empower Retirement qualify as party-in-interest transactions.

Certain administrative functions were performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services. Investment management fees and operating expenses charged to the Plan for investments in mutual funds, collective trust funds, and guaranteed investment contract were deducted from income earned daily and are not separately reflected. Consequently, certain administrative fees and recordkeeping expenses are reflected as a reduction of investment return for such investments.

For the period ended December 29, 2022 (in liquidation), fees paid directly by the Plan for recordkeeping and fund management services totaled \$45,715. Fees paid directly for investment advisory and brokerage fees approximated \$60,000 for the period ended December 29, 2022 (in liquidation).

Note 7 – Fidelity Bond

The Plan has complied with the fidelity bonding requirement of ERISA.

Note 8 – Plan Termination

The Plan Sponsor approved the termination of the Plan on January 1, 2022. The Plan Sponsor discontinued contributions and terminated the Plan subject to the provisions of ERISA. Upon termination, participants became fully vested in their accounts and all investments were distributed to the participants by December 29, 2022.

Note 9 – Tax Status

The Plan uses a non-standardized pre-approved profit sharing/money purchase plan with CODA plan document sponsored by Great-West Trust Company, LLC. Great-West Trust Company, LLC received an opinion letter from the IRS, dated June 30, 2021, which states that the prototype document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 9 – Tax Status, Continued

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress. The Plan Sponsor believes that it is no longer subject to tax examinations for tax periods prior to 2019.
