Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Scapa North America, Inc. 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Scapa North America, Inc. 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Scapa North America, Inc. 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of Scapa North America, Inc. 401(k) Savings Plan (“plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

1. *Plan Merger.* In September 2022, the plan merged into another plan sponsored by the plan sponsor’s parent company, Mativ. As part of that merger, a blackout period went into effect on September 28, 2022. All funds except for those invested in the Standard Stable Value Fund were transferred out of the plan and into the SWM Retirement Savings Plan II 401(k) plan on September 29, 2022. The remaining funds invested in the Standard Stable Value Fund were transferred out of the plan and into the SWM Retirement Savings Plan II 401(k) plan on October 13, 2022.
2. *General.* The plan is a defined contribution plan, which covers all non-union U.S. employees of Scapa Tapes North America, LLC (the “Company” or “employer”) who were at least age 21. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As discussed in the plan merger section above, the plan has merged into another plan sponsored by the plan sponsor’s parent company.

The Company appointed an investment trustee and custodian, Fidelity Management Trust Company (the “trustee” or “Fidelity”), to hold the plan’s assets, execute investment transactions, and administer the participants’ accounts. The Investment Committee determined the appropriateness of the plan’s investment offerings and monitored investment performance.

3. *Contributions.* Eligible employees who chose to participate were allowed to contribute up to 90% of their eligible compensation. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the plan.

The plan includes an automatic enrollment feature which automatically enrolled all newly eligible employees at a deferral rate of 6% unless they affirmatively elected not to participate in the plan. The plan added an automatic re-solicitation feature for employees who had previously opted out. This required eligible employees to opt out on an annual basis or be auto enrolled in the plan. The plan also added an auto-escalation feature which increased a participant’s deferral percentage by 1% annually until the rate reached 15% unless the participant had opted out.

In 2021, the Company contributed a match of 50% of the first 6% of base compensation that eligible participants contributed to the plan, after six months of employment. In 2022 the Company changed their match contribution to the following (still after 6 months of employment):

- 100% of the first 3% of base compensation that eligible participants contributed to the plan
- 50% of the next 5% of base compensation that eligible participants contributed to the plan
- 25% of the next 2% of base compensation that eligible participants contributed to the plan

NOTE A - DESCRIPTION OF THE PLAN (continued)

In 2021, the Company also contributed a non-elective profit sharing contribution of 1.5% of eligible compensation, after six months of employment, for those hired after December 31, 2015 (4% for those hired by the Company on December 31, 2015 or earlier). In 2022, the Company stopped contributing the non-elective profit sharing contribution for all participants except those who were eligible to receive the 4% contribution.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

During 2022 and 2021, the Company match and non-elective profit sharing allocated to participants was approximately \$1,107,000 and \$984,000, respectively. In 2022 this was funded by approximately \$971,000 in employer contributions and \$136,000 from the forfeiture and pension plan accounts. In 2021 this was funded by approximately \$616,000 in employer contributions and \$368,000 from the forfeiture and pension plan accounts. See the note below regarding the funds transferred in from the Scapa North America, Inc. Pension Plan.

4. *Participant Accounts.* Each participant's account was credited with the participant's contributions and allocations of the Company's matching contributions, as well as allocations of the Company's profit sharing contributions and plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.
5. *Vesting.* Participants vested immediately in their contributions plus actual earnings thereon. As of 2022, participants are also vested immediately in the employer contribution portion of their accounts
6. *Notes Receivables from Participants.* Participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at prevailing rates. Interest rates ranged from 3.25% to 10.25% in 2022 and 2021. Principal and interest was paid ratably through payroll deductions.
7. *Payment of Benefits.* Upon termination of service, participants were entitled to receive a distribution in an amount equal to the value of their vested account in the form of a lump sum or in installments.
8. *Transfer In From Plan Sponsor.* During 2020, the plan sponsor terminated its defined benefit pension plan, the Scapa North America, Inc. Pension Plan, which after fulfilling all of its obligations had remaining assets of \$795,141. Those funds were transferred into the Scapa North America, Inc. 401(k) Savings Plan in March 2020 to be used to fund future non-elective profit sharing contributions. During 2022 and 2021, approximately \$132,000 and \$358,000 of these funds were used to reduce employer contributions. As of October 13, 2022 and December 31, 2021, funds remaining totaled \$0 and approximately \$196,000, respectively. These funds were non-participant directed and were invested in the Fidelity Government Money Market Fund.
9. *Forfeited Accounts.* At October 13, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and approximately \$128,000, respectively. In 2022 and 2021, employer contributions were reduced by approximately \$4,000 and \$10,000, respectively from forfeited nonvested accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisors, custodians, and trustee. See Note C for discussion of fair value measurements.

The plan's shares of mutual funds are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the plan at each year end.

The Standard Insurance Company Stable Asset Fund IV (the "stable value fund") guarantees the return of principal, along with competitive crediting rates and 100% liquidity. The declared crediting rate will never be below 1%. The fund invests in fully-benefit-responsive investment contracts (FBRICs) and is presented at fair value based on its NAV. As a result, the plan is an indirect investor in fully benefit-responsive contracts since the plan itself does not directly invest in FBRICs. The investment in this collective trust is valued at NAV per unit, as determined by the trustee at year end. The NAV is used as the practical expedient to estimate fair value of the collective trust.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivables from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 13, 2022 or December 31, 2021. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance would be reduced and a benefit payment would be recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review

The plan has evaluated subsequent events through the report date, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at October 13, 2022 and December 31, 2021.

- *Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded (Level 1).
- *Money Market Fund:* As permitted by compliance with certain conditions under Rule 2a-7 of the Investment Company Act of 1940, money market securities are valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity. Securities held by the money market fund are generally high quality and liquid; however, the inputs used to determine fair value are not quoted prices in an active market (level 2).
- *Stable Value Fund:* The plan uses NAV per unit to value the stable value fund. The NAV, as provided by the fund's trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the stable value fund will sell the investment for an amount different than the reported NAV.

All assets were transferred out of this plan by October 13, 2022, therefore there are no assets to report as of that date.

NOTE D - INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, has certified to the completeness and accuracy of all plan assets, investment transactions, and income as of October 13, 2022 and December 31, 2021 and for the years then ended.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Plan investments during 2022 and 2021 were shares of investments managed by the plan's trustee and custodian, Fidelity Management Trust Company. Angell Pension Group, Inc. served as the plan's third party administrator. Therefore, transactions between the plan and these organizations qualify as party-in-interest transactions. Fees paid directly by the plan for management and record keeping services amounted to approximately \$98,000 and \$117,000 in 2022 and 2021, respectively, plus additional amounts included as a reduction of the returns on the investments.

Certain employees and officers of the plan sponsor, who were also participants in the plan, performed administrative services to the plan at no cost to the plan. These transactions are exempt from the prohibited transaction rules. The plan was administered by the Compensation Committee. In that role, the Compensation Committee had the power to make various administrative determinations as provided for under the plan documents.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts. Effective January 1, 2022, a plan amendment caused all participants to become 100% vested in their accounts. As noted above, the plan merged into another plan in October 2022. This was not considered to be a formal plan termination.

NOTE G - TAX STATUS

The plan adopted a volume submitter profit-sharing plan with Fidelity Management Trust Company. The plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the plan and the related trust, as then designed, are in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the advisory opinion, the plan administrator believes that the plan was designed and operated in compliance with the applicable requirements of the IRC.



