Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Totall Metal Recycling, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The following description of Totall Metal Recycling, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Totall Metal Recycling, Inc. (the Company), except non-resident aliens and those included in collective bargaining units, unless the agreement requires the employees to be included in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Transamerica Life Insurance Company (Transamerica) is the contract issuer and recordkeeper for the Plan.

Eligibility

Employees who have attained the age of 20½ and have completed 500 hours of service in a six-month period, as defined in the Plan Document, are eligible to participate. Employees may participate in the Plan on the first day of the calendar month following the date on which the eligibility requirements are met.

Contributions

Participants may contribute salary deferral contributions, Roth contributions, or a combination of both, up to 100% of compensation, as defined in the Plan Document. Participants can affirmatively choose not to contribute or choose a different percentage to be contributed to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans (rollover).

The Company may make matching contributions at its discretion. For the years ended December 31, 2022 and 2021, the Company's contribution was 100% of the first 2% of eligible compensation. The Company may also make discretionary profit sharing contributions to the Plan. The Company did not make profit sharing contributions for the years ended December 31, 2022 or 2021.

All contributions are subject to Internal Revenue Service (IRS) limitations.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. For Company matching and profit sharing contributions plus actual earnings thereon, vesting in a participant's account is based on years of service, as defined by the Plan Document, with vesting at 0% until becoming fully vested upon the achievement of three years of service. Notwithstanding the foregoing, a participant will become fully vested upon attainment of normal retirement age, death or upon suffering a disability, as defined by the Plan Document, while an employee.

Forfeitures

Forfeitures of nonvested accounts may be used to pay Plan administrative expenses, reduce future Company contributions, or reallocate to participant accounts. At December 31, 2022, there were no forfeited non-vested accounts. At December 31, 2021, forfeited non-vested accounts totaled \$4,644. The Company used \$9,298 to reduce Company contributions for the year ended December 31, 2022. No forfeitures were utilized for the year ended December 31, 2021.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's contributions, and an allocation of Plan earnings (losses) and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of contributions into various investment options. Participants may change their investment elections at any time.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to the lesser of \$50,000, less the participant's largest outstanding loan balance during the preceding 12 months, or 50% of their vested account balance. Participants can have no more than one loan outstanding at a time. Loans are for a period not to exceed five years, except for a loan for the purchase of a principal residence. Loans bear interest at a rate of prime plus 1%. Participant loans are secured by participants' vested account balances. The loans are repaid through payroll withholdings, including principal and interest.

Payment Of Benefits

Upon termination of employment, death, disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in their account in the form of a lump sum payment.

In-Service Withdrawals

Upon attainment of age 59½, a participant may withdraw all or any portion of their vested interest in their account.

A participant may also make withdrawals of their elective deferral contributions and rollover contributions in the event of an undue financial hardship, as defined by the Plan Document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Investment related expenses are included in net change of fair value of investments. Investment advisory and certain recordkeeping fees are paid by the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are reported on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments other than fully benefit-responsive investment contracts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Transamerica Stable Value Core option is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment Of Benefits

Benefits are recorded when paid.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2022 and 2021, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Transamerica, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Transamerica that the information provided to the Plan Administrator related to the following information is complete and accurate.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts

Valued at the net asset value (NAV) of units held by the Plan at year end, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The pooled separate accounts may be redeemed daily, and file an annual report on Form 5500 as a direct filing entity. There are no capital commitments related to the Plan's pooled separate accounts.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2022, all Plan assets consisted of pooled separate accounts measured at NAV as a practical expedient, which have not been categorized in the fair value hierarchy.

There have been no changes in the valuation methodology used at December 31, 2022 or 2021.

5. Investment Contract With Insurance Company

The Plan invests in a benefit-responsive investment contract with Transamerica. Transamerica maintains the contributions in a separate account. The investment account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the account. Contract value, as reported to the Plan by Transamerica, represents contributions plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon schedule with the issuer and is reset on a semi-annual basis.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification.

6. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their account balances.

8. Income Tax Status

The Plan was amended and restated effective January 1, 2022 through the adoption of a pre-approved plan document. The sponsor of the pre-approved plan document has received a letter from the IRS, dated June 30, 2022, in which the IRS states that the pre-approved plan document is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Party In Interest Transactions

Plan investments consists of pooled separate accounts, an interest bearing cash account, and an investment contract managed by Transamerica. The Plan pays administrative fees to Transamerica for recordkeeping and administrative services. In addition, certain participants have outstanding loans with the Plan as of December 31, 2022 and 2021. These transactions qualify as party in interest transactions allowable under ERISA.

10. Subsequent Events

Effective January 1, 2023, the assets of the Plan were merged with and participants' accounts in the Plan were transferred to the Wieland North America, Inc. Retirement Savings Plan, which is a plan under common control.
