Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Luby's Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 8, 2022 (in liquidation) and December 31, 2021 (ongoing), the related statement of changes in net assets available for benefits for the period from January 1, 2022 through December 8, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 8, 2022 (in liquidation) and December 31, 2021 (ongoing), and for the period from January 1, 2022 through December 8, 2022 (in liquidation), stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As further discussed in Note 1 to the financial statements, the company resolved on March 30, 2022, to terminate the Plan effective June 1, 2022. As a result, the Plan changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Management's Responsibilities for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events that, considered in the aggregate, raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but it is not absolute assurance; therefore, it is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Plan Description

The following description of the Luby's Savings and Investment Plan (the "Plan") provides only general information. Luby's, Inc. (the "Company" or "Employer") is the Plan Sponsor. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

Plan Termination

The Company resolved on March 30, 2022, to terminate the Plan effective June 1, 2022 ("termination date"), and to distribute Plan assets as soon as administratively feasible. Effective June 1, 2022, the Plan ceased all contributions and new participant loans. The nonvested portion of all participant accounts were fully vested upon the termination date. All Plan participants received an account closing distribution of their account balances based on their distribution election. Distributions were requested in lump sum cash distribution or as a direct rollover to an Individual Retirement Account ("IRA") or other qualified retirement plan. As of December 8, 2022, immediately following completion of all distributions of Plan assets, in full satisfaction of all benefits and expenses due under the Plan, the trust was fully liquidated and terminated. As a result of the termination, the Plan filed a final Form 5500.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Luby's, Inc. and Luby's Fuddrucker's Restaurants, LLC through voluntary contributions by employees and discretionary contributions by the Company. The Plan, which commenced effective March 1, 1997, was amended and restated effective March 1, 2021, to comply with the latest rules and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC").

Plan Custodian and Trustee

Great-West Trust Company, LLC ("Great-West," the "Trustee," or the "Custodian") is the Custodian maintaining custody of all investments held by the Plan, except for the group annuity contract. Great-West maintains the Plan's participant account balances and provides record-keeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Great-West Life & Annuity Insurance Company is the custodian of the group annuity contract. Great-West also serves as the Plan's Trustee.

Eligibility

All employees, except those under collective bargaining agreements, nonresident aliens who receive no U.S.-source income, and leased employees, are eligible to participate in the Plan upon having completed six months of service and having attained age 21.

Participant Contributions

Prior to the termination date, participants may elect to contribute an amount not less than 1% and not more than 25% of eligible compensation as defined by the Plan up to the maximum amount allowed for deferral annually under the IRC, which was \$20,500 for 2022. Participants who have attained 50 years of age before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually under the IRC, which was \$6,500 for 2022.

Note 1 – Plan Description (continued)

Employer Contributions

For the period from January 1, 2022 through June 1, 2022, the Employer made discretionary matching contributions to the Plan on behalf of participants in an amount equal to 50% of participants' elective contributions up to a maximum of 6% of the participant's eligible compensation. Contributions are subject to certain IRC limitations.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The investment options vary in types of investments, rates of return, and investment risk.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions, plus allocations of net plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions and the qualified nonelective contributions plus actual earnings thereon. Prior to the termination date, vesting in the Company's contributions portion of their accounts is based on years of continuous service as follows:

Notes Receivable from Participants

Prior to the termination date, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are secured by the balance in the participant's account. Interest is charged at the Prime rate at the time the loan is made plus 1%. Loan terms range from one to five years for general-purpose loans. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump sum payment equal to the value of the participant's vested balance or a partial withdrawal. In addition, the Plan provides in-service distribution benefits for eligible participants. On termination of service, any balance under \$5,000 is automatically distributed from the Plan as soon as administratively possible.

Forfeitures

Participants who terminate employment with the Company prior to full vesting forfeit the nonvested portion of the Company's nonelective contribution. At December 8, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$4,927, respectively. Employer contributions were reduced by \$9,705 from forfeited nonvested accounts for the period from January 1, 2022 through December 8, 2022. Plan expenses of \$21,179 were paid from forfeited nonvested accounts for the period from January 1, 2022 through December 8, 2022.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

Effective June 1, 2022, a decision was made to terminate the Plan. As a result, the 2021 financial statements have been prepared on the ongoing basis, and the 2022 financial statements have been prepared on the liquidation basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold, as well as, held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 8, 2022 and December 31, 2021. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Company may pay, at its discretion, all reasonable costs, charges, and expenses incurred in the administration of the Plan. Any administrative expenses not paid by the Company are paid directly by the Plan and participants. Investment-related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 20, 2023, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 8, 2022 and December 31, 2021.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 8, 2022 and December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements.

Note 5 – Group Annuity Contract

The Plan has a group annuity contract with Great-West Life & Annuity Insurance Company that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Note 5 – Group Annuity Contract (continued)

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to, the following: (i) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (iv) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are mutual funds. Those and the group annuity contract are both managed by the Trustees, and as such, both types of transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. There have been no known prohibited transactions with parties-in-interest. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants as of December 31, 2021. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 7 – Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized preapproved profit-sharing plan document sponsored by Great-West. This non-standardized plan document has been filed with the appropriate agency and obtained an opinion letter from the IRS dated June 30, 2020, stating that the non-standardized plan and related trust, as then designed, constituted a qualified plan under Section 401 of the IRC, and therefore were not subject to tax.

The Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status. However, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income taxes has been made in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 8, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2019.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 – Partial Plan Termination

In August 2021, the Company sold 35 stores to a third party. The sale resulted in a significant reduction in workforce during 2021, which constituted a partial plan termination. In accordance with IRS guidance, participants of the Plan whose employment terminated during 2021 were made fully vested in any unvested amounts in their Plan accounts.

In addition, during 2020, the Plan experienced a partial plan termination due to the termination of greater than 20% of active plan participants. Partial plan termination results in all affected participants becoming fully vested in their account balances. However, all affected employees were not fully vested due to an administrative error. During 2022, the Company self-corrected the operational error and distributed the forfeited portions of the accounts to the affected participants.
