Note 1. Plan Description

The following description of the Source Management, Inc. 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 1996 and subsequently amended, covering substantially all employees of Source Management, Inc. (the "Company"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In May 2022, the Company acquired Sandy's Office Supply, Inc. Effective July 1, 2022, all employees of Sandy's Office Supply, Inc. became eligible to participate in the Plan.

The Company is the Plan's sponsor, and the Company's Board of Directors serves as plan administrator. Standard Insurance Company (Standard) serves as custodian and maintains the Plan's records. Standard offers Plan participants a variety of investment options through various pooled separate accounts (PSAs) and a fully benefit-responsive investment contract. Individual accounts are invested in the various investment options at the direction of the participants.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching age 18 and after completing one month of service. The entry date for eligible participants is the first day of the first month following obtaining eligibility. Participants are eligible for employer matching contributions upon the first payroll of the quarter after one year of service.

Contributions

Participant Contributions - Participants may make before-tax and after-tax (Roth) contributions up to 100% of their annual eligible compensation, as limited by the IRS, which is adjusted annually by the Secretary of the Treasury for inflation. The maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the Plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Newly eligible employees who do not affirmatively elect to have a specific deferral percentage contributed or opt out of deferring into the plan will automatically have 4% of their eligible compensation deferred into the Plan. The Plan contains an automatic-escalation feature which increases participant's deferrals by 1% annually up to a maximum of 10% unless the participant opts out. Employee contributions to the Plan are made through regular payroll deductions.

Contributions (Continued)

Employer Match Contributions - The Company may elect to make discretionary matching contributions to the Plan. The discretionary matching contributions formula is 25% of elective deferrals, up to 4% of eligible compensation, for the year ended December 31, 2022. The Company also has a discretionary variable match. For each 1% of pretax net profit incurred for the calendar year, the Company will match 10% up to the first 4% of employee compensation contributed for the year ended December 31, 2022. To be eligible for the variable match, participants are required to have worked in excess of 1,000 hours from January 01, 2022 to December 31, 2022 and be employed as of December 31, 2022. Discretionary matching contributions are funded each pay period, and the variable match is funded once a year after year end.

Contributions are subject to regulatory limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with benefit payments and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting

Participants are 100% vested in their voluntary contributions, any matching contributions, and allocated earnings or losses thereon.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2022, the rates of interest on outstanding loans ranged from 3.25% to 6.25%.

Payment of benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a single lump-sum, partial payments, or installment payment in the amount equal to the participant's vested account balance. Benefits are recorded when paid.

The Plan allows in-service distributions and partial distributions to participants age 59 ½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or less to be automatically distributed. The IRS has required minimum distributions once a participant reaches age 72 during the previous Plan year and is no longer employed by the Company.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) using the accrual method of accounting.

Investment contracts held by the defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements. Such estimates also affect the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Investment valuation and income recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Benefit payments

Benefits paid to participants are recorded when paid.

Note 3. Information Certified by Standard Insurance Company

Note 4. Fair Value Measurements

The Plan's investments, except for benefit-responsive investment contracts, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 2 Fair Value Measurements

The fair value of the pooled separate accounts are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal. No distributions of income and gain or loss are made to participants.

Note 5. Guaranteed Investment Contract with Insurance Company

The Plan holds an investment contract with Standard Insurance Company. This contract, the Stable Asset Fund II, meets the fully benefit-responsive traditional investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in these contracts at contract value. The actual average yield earned by the Plan was 1.45% and 1.77% for the years ended December 31, 2022 and 2021, respectively. The following represents the total contract value of these investment contracts held by the Plan.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified rate of interest that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will not fall below one percent.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5. **Guaranteed Investment Contract with Insurance Company (Continued)**

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer.

Note 6. **Tax Status**

The Plan adopted a non-standardized plan sponsored by Standard Retirement Services, Inc. and has not requested a determination letter but rather has relied upon the Internal Revenue Service opinion letter dated June 30, 2020 issued on the non-standardized plan stating the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 7. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, subject to the provisions of ERISA.

Note 8. **Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by the Plan's custodian. Therefore, these transactions qualify as party-in-interest transactions. However, these transactions are not considered prohibited transactions. Fees paid to service providers by the Plan for administrative services amounted to \$20,161 for the year ended December 31, 2022.


