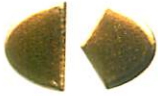

Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.


In performing an audit in accordance with generally accepted auditing standards, we:

NOTES TO FINANCIAL STATEMENTS

FOR THE YEAR ENDED DECEMBER 31, 2022

1. Description of the plan:

The following description of the Sierra Autocars, Inc. 401(k) Plan (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan was an employee contribution plan covering all employees of Sierra Autocars, Inc., Sierra Pursuits, Inc. and Argonaut Food Services, Inc. (the "Companies"). Collectively bargained employees and non-resident aliens are excluded from the Plan. The Plan was initiated on July 1, 1997 and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversaw governance of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to

Plan termination:

As described in Note 7, the Board of Directors of the Company elected to terminate the Plan due to the sale of the Company's assets on November 15, 2021.

Contributions:

Participants may elect, by submitting a written request to the Plan administrator, to have their wage compensation reduced by up to the dollar amount allowable under the limitations of the IRC Sections 415, 401(k) and 402(g). Participants may also contribute amounts representing distributions from other qualified plans (rollover). For the year ended December 31, 2022, elective deferral amount allowed under IRC Code Section 402(g) was \$20,500, and catch-up contribution allowed for participants age 50 or older, under IRC Code Section 414(v) was \$6,500. This deferred amount flows directly to the Plan. There were no participant contributions to the Plan for the year ended December 31 2022.

The Plan sponsor may contribute to the Plan an amount of matching contributions determined at its discretion. The sponsor did not make a discretionary matching contribution for the Plan year ended December 31, 2022.

Maximum annual addition to each participant's account was subject to the limitation set by IRC Code Section 415(c)(1)(A), which was the lesser of \$61,000 or 100% of the participant's compensation for the year ended.

Participant accounts:

Each participant's account was credited with the participants contribution and an allocation of the Company's contribution, if applicable, Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of the plan (continued):

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and employer match is based on years of continuous service. A participant is 100% vested after five years of credited service (20% vesting per year of credited service).

As a result of the Plan's termination due to the sale of the Company, affected participants became 100% vested in their respective employer match and employer profit sharing accounts.

Notes receivable from participants:

Participant loans against individual Plan balances were allowed. No loan to any Participant or Beneficiary was made to the extent that such loan, when added to the outstanding balance of all other loans to the Participant or Beneficiary, would exceed the lesser of (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans during the one year period ending on the day before the loan is made over the outstanding balance of loans from the Plan on the date the loan is made, or (b) one-half the present value of the non-forfeitable account. There were no outstanding loans as of December 31, 2022.

Payment of benefits:

Upon retirement, death, disability, or termination of service, participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum payment equal to his or her vested balance in the Plan. A participant may also elect to roll over their balance into another qualified profit sharing plan or IRA. Participants are advised of the tax consequences of each option and may opt to have taxes withheld.

Forfeitures:

Forfeitures may be used to reduce employer and/or matching contributions or pay plan expenses. Forfeiture amounts available as of December 31, 2022 and 2021 were \$0 and \$4,996, respectively. Forfeitures totaling \$14,973 were used to pay Plan expenses for the 2022 Plan year.

Plan expense:

The employer has elected to absorb part of the Plan's operating and administrative expenses. Certain administrative expenses are paid from Plan assets.

2. Summary of accounting policies:

Basis of accounting:

The financial statements of the Plan were prepared on the liquidation basis of accounting, consistent with terminated plans, as of December 31, 2022 and 2021, and for the years then ended in conformity with accounting principles generally accepted in the United States of America ("GAAP"). There were no material differences between the liquidation basis of accounting and the ongoing basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ('GAAP') requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Investment advisers, custodians, and insurance company. See Note 4 for

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2021. All outstanding and unpaid notes receivable from participants were deemed distributions during 2022 based upon the terms of the Plan document.

2. Summary of accounting policies (continued):

Excess contributions payable:

The Plan distributed the 2021 excess contributions amounting to \$3,520 prior to March 15, 2022. There were no contributions to the Plan in 2022

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan were paid directly by the Companies and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Fees related to the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Date of Management's review:

The Plan administrator has evaluated subsequent events through June 20, 2023, the date the financial statements were available to be issued.

3. Information prepared and certified by Reliance Trust Company:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2021, and net appreciation/(depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company. 4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurement, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2022 and 2021. The following is a description of the valuation methodologies used for assets measured at fair value:

Level 2 fair value measurements:

The shares of mutual funds are valued at the daily closing price as reported by each fund. The mutual fund Net Asset Value(s) ("NAVs") are reported by the fund companies to Transamerica upon the daily market close. The trustees have determined that Level 2 is the proper designation.

5. Stable Value Option with Transamerica Financial Life Insurance Company:

The Plan entered into a traditional fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company (Transamerica), which maintains the invested funds in a Fixed Income Account. The Fixed Income Account is part of Transamerica's general account and is subject to the claims of Transamerica's general creditors. Transamerica credits interest on contributions made to the Fixed Income Account at a rate Transamerica declares for a period of time that it determines. Participant accounts are charged for withdrawals and administrative expenses. The contract values at December 31, 2022 and 2021 were \$0 and \$1,086,020, respectively.

The contract meets the fully benefit-responsive investment contract criteria therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Stable Value Option with Transamerica Financial Life Insurance Company (continued):

Transamerica is contractually obligated to repay the principal and the specified interest that it guarantees to the Plan, subject to Transamerica's claims paying ability. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable—for example, a significant decline in creditworthiness of Transamerica, the Stable Value Option investment choice may no longer be considered fully benefit-responsive. Although plan participants generally may withdraw assets from the Stable Value Option investment choice without restrictions, TLIC or TFLIC may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

6. Related-party and party-in-interest transactions:

Certain plan investments are shares of mutual funds managed by the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

Fees paid during the year for administrative services rendered by parties in interest were based on customary and reasonable rates for such services and were paid by the employer and the Plan. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

7. Plan termination:

In conjunction with the sale of the Company's auto franchises on November 15, 2021, the Board of Directors elected to terminate the Plan as of November 17, 2021. As such, management determined that liquidation was imminent and participants became 100% vested in their accounts. Management informed participants of their right to roll funds over to a qualified plan. As of the date of this report, the Plan has distributed all funds based on participant requests.

As a result of its intent to terminate as of November 17, 2021, and in accordance with accounting principles generally accepted in the United States of America ('GAAP'), the Plan changed its basis of accounting used to value Plan assets from the ongoing basis to the liquidation basis to present the 2021 and 2022 financial statements.

8. Tax status:

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the liquidation date.

8. Tax status (continued):

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax

9. Risk and uncertainties:

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would have occurred in the near term and that such changes could have materially affected participants' account balances and the amount reported in the statement of net assets available for benefits in liquidation.

10. Reconciliation of financial statements to Form 5500:

Schedule H of Form 5500 does not present excess contributions payable as of the end of each year. As of December 31, 2021, the excess contributions payable recorded on the statement of net assets available for benefits, but not on Schedule H, was \$3,520. Consequently, there was a difference in net assets available for benefits per the financial statements and Schedule H as of December 31, 2021, as illustrated below:
