INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants Carr Management 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carr Management 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Carr Management 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Carr Management 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As further discussed in Note 4 of the financial statements, in August 2022, Carr Management Inc. was acquired by Altium Packaging LLC. As such, in December 2022, all Plan assets were transferred out of the Carr Management 401(k) Plan and into the Altium Packaging 401(k) Plan.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Carr Management 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Carr Management 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of Carr Management, Inc. and its wholly owned subsidiaries (collectively, the "Company") who had one year of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan administrator was responsible for oversight of the Plan and determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Board of Directors.

Contributions

Each year, participants could contribute up to the maximum limits allowed by the Internal Revenue Code ("IRC") of pretax annual compensation, as defined by the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of all contributions into various investment options offered by the Plan.

The Company had a discretionary matching contribution equal to 50% of the first 6% of compensation deferred per allocation period. In addition, the Company could make discretionary profit sharing contributions. The Company did not make a discretionary profit sharing contribution in 2022 or 2021.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions and the Company's discretionary matching contributions made prior to 2019, plus actual earnings on the contributions. Post-2019, vesting in the Company's discretionary matching and profit sharing contribution portions of their account was based on years of continuous service. A participant was 100% vested after six years of credited service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate would be based on the rates available for similar loans from commercial lending institutions, as defined. Principal and interest were paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or as requested partial withdrawals. In addition, the Plan did not allow for hardship distributions.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$8,147, respectively. These accounts were used to reduce future employer contributions or to pay administrative expenses. During the year ended December 31, 2022, \$40,093 forfeited amounts from nonvested accounts were utilized by the Plan for administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Net depreciation included the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses had been recorded as of December 31, 2022 or 2021. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability. As of December 31, 2022 and 2021, excess contributions payable totaled \$0 and \$30,384, respectively. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 12, 2023, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled separate accounts: The fair value of the investments in this category had been estimated using the net asset value (NAV) per share as a practical expedient. The NAV of these accounts was based on the market value of its underlying investments. The NAV of these accounts was not a public-quoted price in an active market.

There were no investments held as of December 31, 2022, due to the merging of the Plan, as described in Note 4. The following summary sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021:

NOTE 4 - TRANSFER OF ASSETS TO OTHER PLAN

In August 2022, Carr Management Inc. was acquired by Altium Packaging LLC. The Trustees of the Plan authorized the merger of the Carr Management 401(k) Plan into the Altium Packaging 401(k) Plan effective December 2022. The assets were transferred out of the Plan and were certified by John Hancock Life Insurance Company (U.S.A.). All participants in the Carr Management 401(k) Plan were credited for their years of service with the predecessor employer and will follow the vesting rules discussed in Note 1 upon merger and were provided the option to have their account balance transferred into the Altium Packaging 401(k) Plan. The Plan stopped accepting contributions after December 23, 2022, and an aggregate of \$12,182,831 was transferred out of the Plan on December 30, 2022.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) was the custodian and recordkeeper for the Plan and, therefore, these transactions qualified as party-in-interest transactions. Other transactions, which may be considered related-party or party-in-interest transactions, relate to normal plan management and administrative services, and the related payment of fees.

NOTE 6 - PLAN TERMINATION

The Company had the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note 4 for discussion of the plan merger that resulted in the transfer of all plan assets into another plan during 2022.

NOTE 7 - TAX STATUS

The Company had adopted a volume submitter profit sharing plan with CODA sponsored by Actuarial Benefits & Design Co. The volume submitter profit sharing plan had received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, as to the volume submitter profit sharing plan's qualified status. The volume submitter profit sharing plan opinion letter had been relied upon by the Plan. Although the Plan had been amended since receiving the opinion letter, the plan administrator believes the Plan was designed and was being operated in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believe the Plan was qualified, and the related trust was tax exempt.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the custodian of the Plan).
