INDEPENDENT AUDITORS' REPORT

To the Plan Trustee of the
Living Centers, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Living Centers, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of October 18, 2022, (Termination Date) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended October 18, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Living Centers, Inc. 401(k) Plan's, financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS
October 18, 2022 and December 31, 2021

Note 1 - Description of Plan

The following description of the Living Centers, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution Plan covering all employees of the Company who have completed 90 days of service and attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustee determine the appropriateness of the Plan's investment offerings and monitors investment performance.

In 2022, Living Centers, Inc. decided to terminate the Plan and to distribute Plan assets as soon as administratively feasible. In accordance with the Plan provisions, the Sponsor vested 100% of the Plan's assets in 2022.

Contributions: Each year, participants may contribute the lesser of 100% of eligible compensation or \$ 20,500 for 2022 (\$ 19,500 for 2021) in elective deferral contributions as pre-tax elective deferral contributions or Roth elective deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who were automatically enrolled at 3% and have made no changes to their deferral percentage during the Plan year will see their rate increase by 1% each Plan year until the amount withheld from the participant's paycheck reaches 10% of eligible compensation. The Company may make discretionary contributions as determined by the Company. Participants who are actively participating in the Plan on the last day of the Plan year and have 1,000 or more hours of service in the Plan year are eligible for the discretionary contribution. The discretionary contribution is based upon a percentage of each participant's annual pay. For the period ending October 18, 2022 and year ended December 31, 2021, the Company made no discretionary contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may invest their contributions in any of several investment options offered by the Third Party Administrator (TPA), Principal Trust Company.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary portion of their accounts is based on years of service and is determined as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 years	0%
1 years but less than 2	20%
2 years but less than 3	40%
3 years but less than 4	60%
4 years but less than 5	80%
5 years or more	100%

Notes Receivable from Participants: During 2022 and 2021, participants could borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$ 50,000. The loans are secured by the balance in the participant's account and bear interest at a rate to be determined when the participant applies. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits: Once participants attain the age of 59½, they are entitled to receive an in-service distribution of all or any part of their vested account resulting from elective deferral contributions. Accounts totaling \$ 1,000 or less are distributed automatically in a lump sum payment. Accounts totaling more than \$ 1,000 but less than \$ 5,000 will be converted into an Individual Retirement Account (IRA), unless a lump sum payment distribution is elected. Accounts exceeding \$ 5,000 can either be distributed in a lump sum payment or the participant can elect to take installments over a specified period not exceeding their life expectancy or the joint life expectancy of the participant and beneficiary participants. Participants who terminate employment due to disability become 100% vested under the Plan and will receive distributions in the same manner as participants who attain normal retirement age.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are expensed when incurred. As of October 18, 2022 and December 31, 2021, the Plan did not have any loans and therefore there was no allowance for credit losses recorded.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses consist of third-party administration, and investment and other advisory services.

Note 3 – Qualified Institution Certification

The October 18, 2022 and December 31, 2021 Statements of Net Assets Available for Benefits, investment activities included on the Statements of Changes in Net Assets Available for Benefits and the accompanying notes to the financial statements were prepared in part or entirely from information certified by a Qualified Institution in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified included total investments of \$ - 0- and \$ 137,799 for the year ended October 18, 2022 and December 31, 2021, respectively. The information certified also included an investment loss of \$ 19,397 at October 18, 2022 and investment gain of \$ 14,115 for the year ended December 31, 2021.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There were no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 18, 2022 and December 31, 2021:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The following tables set forth, by level within the fair value hierarchy, the Plan's investments at fair value as of October 18, 2022 and December 31, 2021:

Note 5 - Transactions with Parties-in-Interest

Certain Plan investments are shares of mutual funds managed by Principal Financial Group. Principal Financial Group is the Third Party Administrator (TPA) as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$ 6,536 and \$ 4,143 for period ended October 18, 2022 and year ended December 31, 2021, respectively.

All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 - Plan Termination

On March 1, 2022, Living Centers, Inc., the Plan sponsor, approved the termination of the Plan. Plan assets were distributed as soon as administratively feasible to all participants in accordance with Plan requirements. All participant balances were distributed as of October 18, 2022.

Note 7 - Tax Status

The Internal Revenue Services (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although, the Plan has been amended since receiving the determination letter, the Plan's Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Subsequent Events

The management of the Living Centers, Inc. 401(k) Plan has evaluated events occurring subsequent to October 18, 2022 as to their potential impact to the financial statement through June 21, 2023, which is the date the financial statements were available to be issued.
