## Notes to Financial Statements

Period from January 1, 2022 to June 30, 2022 and December 31 2021

### 1. Description of Plan

The following is a brief description of Tribune Publishing Company Defined Contribution Retirement Plan (the "Plan"). Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

On June 30, 2022 the Plan merged with the Tribune Publishing Company 401(k) Plan and the funds amounted to \$5,864,871 were transferred to the Tribune Publishing Company 401(k) Plan. After the transfer and effective July 1, 2022, the Tribune Publishing Company Master Trust was terminated.

#### General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established on June 13, 2014. The Plan covers certain union employees of Tribune Publishing Company (the "Company", or "Employer"). Employees of the Chicago Tribune Company, LLC who are members of International Association of Machinists Local #126, employees of the Baltimore Sun Company, LLC who are members of the Washington-Baltimore Newspaper Guild, the Graphics Communications Conference / International Brotherhood of Teamsters, Local 31 (Pressman), the Columbia Typographical Union No. 101-12, or the Baltimore Mailers' Union, Local No. 888, employees of Sun-Times Media LLC who are members of the Chicago Newspaper Guild, and Local 34071 (Post Tribune, Pioneer Press, or Lake County News Sun) are eligible to participate in the Plan.

Vanguard Fiduciary Trust Company ("Vanguard") serves as the Plan's Trustee ("Trustee") and record-keeper. The Plan is part of the Tribune Publishing Company Master Trust (the "Master Trust") whose assets are held with Vanguard. The Master Trust was established on June 13, 2014, to hold the qualified defined contribution investment assets of the Plan and another benefit plan sponsored by the Company.

#### Eligibility and Contributions

A covered union employee becomes eligible to participate in the Plan the first payroll period after which he or she has both attained the age of 21 and completed one year of eligible service, defined as the completion of 1,000 hours of service during the plan year. Participants may elect to contribute up to 25% of their eligible compensation, as defined by the Plan, as pre-tax contributions. Additionally, participants who have obtained the age of fifty before the close of the Plan year are also eligible to make catch-up contributions up to 15% of their pretax compensation, subject to the maximum limitation imposed by the Internal Revenue Code ("IRC").

The Plan also allows for Company contributions in amounts determined during collective bargaining negotiations by the Company and the individual Union. The Company contribution, if any, is based on eligible compensation contributed to the plan during each payroll period. for the period ended June 30, 2022, the Company made the following contributions:

- The Baltimore Sun: Washington-Baltimore Newspaper Guild members received an Employer contribution of participant elective deferrals up to 3.5% of a participant's wages.
- The Baltimore Sun: Baltimore Mailers' Union, Local No. 888 Mailers members received an Employer contribution of participant elective deferrals up to 1% of a participant's wages.
- The Morning Call, Inc.: Graphic Communications International Local # 160-M members received an Employer contribution of participant elective deferrals up to 3% of a participant's wages.

Employer contributions totaled approximately \$69,000 for the period from January 1, 2022 to June 30, 2022.

## Vesting

Participants are always fully vested in their own contributions plus earnings thereon. Participants become vested in the Plan's employer contributions based on the following schedule:

## Forfeitures

The portion of a participant's account balance, which is not vested upon termination of employment, is forfeited, and remains in the Plan. Forfeitures were approximately \$5,581 for the period from January 1, 2022 to June 30, 2022. The Company contributions and administration fees of \$3,999 were funded from the forfeiture account for the period ended June 30, 2022. At June 30, 2022, the forfeiture account balance of \$2,574 was included in the transfer of the Plan assets to the Tribune Publishing Company 401(k) Plan, and At December 31, 2021, there were forfeitures of approximately \$1,000 available.

## Benefit Payments

Upon attaining the age of 65, a participant is entitled to a lump-sum distribution from the Plan. In addition, participants may withdraw funds from the Plan upon termination of employment or, in certain other cases and subject to the approval of the Retirement Plan Committee; participants may request a withdrawal of a portion of their balances in the case of financial hardship.

## Notes Receivable from Participants

Loans are available to all participants with the exception of participants who are employees of the Baltimore Sun and belong to the Graphics Communications Conference / International Brotherhood of Teamsters, Local 31 (Pressman), the Columbia Typographical Union No. 101-12, or the Baltimore Mailers' Union, Local No. 888.

Loans may be available to the eligible participants subject to the approval of the plan administrator. Participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Their vested account balances also serve as collateral for the loan. A participant can have no more than 2 loans outstanding at any time. Interest rates ranged from 3.25% to 5.50% at June 30, 2022. Loans that are in default are accounted for as a distribution in the year the default occurs.

## Participant Accounts

Individual participant accounts are credited with participant contributions, the Company's matching contributions, and allocations of Plan earnings, and charged with withdrawals and allocations of the losses and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## Administrative Expenses

Distribution and loan fees are charged directly to the requesting participant's account. Substantially all other administrative expenses are paid by the Company.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

### Subsequent Events

The Plan has evaluated subsequent events through July 26, 2023, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

### 3. Information Certified by the Plan's Trustee

The Company has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's rules and Regulations for Report and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to certain information certified as complete and accurate by the Trustee, as defined by ERISA, as of June 30, 2022 and December 31, 2021 and for the period from January 1, 2022 to June 30, 2022. Information included in the accompanying financial statements as to investments in the Master Trust and the Plan's interest in the Master Trust's investment income, and information included in Note 4 is presented in reliance solely upon these certifications.

### 4. Interest in Master Trust

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and the assets of the Participating Plans. Each Participating Plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by the Trustee. The value of the Plan's interest in the Master Trust is based on the beginning of period value of the Plan's interest in the trust plus actual contributions and allocated investment gain, actual distributions and allocated administrative expenses. As of June 30, 2022, all the plan investments were liquidated and transferred from Master trust to Tribune Publishing Company 401(K) Plan. At December 31, 2021, the Plan's interest in the net assets of the Master Trust was approximately 3.1%. Investment gain and administrative expenses relating to the Master Trust are allocated to the individual plans based upon the average monthly balances invested by each plan.

Each plan continues to be operated under its current plan document and pays its plan benefits and allocated administrative expenses.

There are no assets held in the Master trust on June 30, 2022. The following table represents the net assets of the master trust as of December 31, 2021:

### Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022:

- Mutual funds and money market funds: Valued at unadjusted quoted market prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no investments held in the Master trust as of June 30, 2022.

### 5. Related Party Transactions

Certain Plan investments are mutual funds or a common collective trust fund managed by Vanguard. Vanguard is the trustee and record-keeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to Vanguard by the Plan for management services amounted to approximately \$12,600 for the period from January 1, 2022 to June 30, 2022. Services rendered by the investment advisor and auditor also qualify as party-in-interest transactions. These administrative expenses paid by the plan, amounted to approximately \$5,000 for the period from January 1, 2022 to June 30, 2022.

### 6. Plan Termination

Effective June 30, 2022, the Plan merged with the Tribune Publishing Company 401(k) Plan. Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested.

### 7. Tax Status

The Plan is based on a prototype plan developed by Vanguard which received a favorable opinion letter dated March 31, 2014, from the Internal Revenue Service ("IRS") stating that the prototype plan constitutes a qualified plan under Section 401(a) of the IRC. The Company believes the Plan, as adopted and amended, is operating within the guidelines of the IRC and continues to be tax exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2019.
