Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Emphasis of Matter

The financial statements for the year ending December 31, 2021 were prepared assuming the Plan would continue as a going concern. As discussed in Note 11 to the financial statements, Sentry Electrical Group, Inc., the Plan's sponsor, elected on September 14, 2022, to merge the Plan with a multiple employer plan, which subsequently occurred on December 31, 2022. The 2021 financial statements do not include any adjustments that might be necessary upon merger and termination. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sentry Electrical Group 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of Sentry Electrical Group (the “Company”) 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. *General.* The Plan is a defined contribution plan covering all employees of the Company. There are no age or service requirements to participants in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On September 14, 2022, the Plan Sponsor elected to merge the Plan into the AGC Retirement Savings Plan (“AGC Plan”). Accordingly, all investments were transferred into the IEC Plan as of December 31, 2022.

- B. *Contributions.* Each year, participants may contribute up to 86% of pretax annual compensation as defined by the Plan, except that no employee may make annual tax-deferred contributions in excess of amounts provided by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Plan had a safe harbor provision which permitted matching of 100% employee deferrals up to 4% of eligible compensation.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s deferral contribution and allocations of (a) the Company’s contribution (if any) and (b) plan earnings including administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately vested in their salary deferral contribution plus actual earnings thereon. Vesting in the Company’s contribution portion, if any, of their account plus actual earnings thereon is based on years of continuous service; a participant is 100% vested after three years of credited service with the vesting percentage accruing ratably each year of the period.
- E. *Participant Loans.* Participants may borrow from their fund accounts a minimum of \$1,000 and up to fifty percent (50%) of their vested account balance, not to exceed \$50,000. The loans are secured by the balance in the participant’s account and bear interest at fixed rates which are based on the prime rate published in the *Wall Street Journal* on the first business day of each month plus one percent (1%). Principal and interest is paid ratably through biweekly payroll deductions.

1. DESCRIPTION OF THE PLAN (Continued)

F. *Payment of Benefits.* Distributions from the Plan are made in the form of a lump sum of a Participant's entire vested account balance or a single sum distribution of a portion of the Participant's vested account balance. Optional forms of payment available upon termination of employment include lump sum distribution of entire vested account balance or single sum distribution of a portion of the vested account balance.

G. *Forfeited Accounts.* Forfeitures may be used to reduce future employer contributions. There were none used in 2022.

2. SUMMARY OF ACCOUNTING POLICIES

A. *Basis of Accounting.* The financial statements of the Plan are prepared under the modified cash method of accounting.

B. *Payment of Benefits.* Benefit payments are recorded when paid.

C. *Investment Valuation and Income Recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

E. *Notes Receivable from Participants.* Participant loans are evaluated by management for default and write-offs are deemed as distributions.

F. *Subsequent Events.* Plan management has evaluated the need for disclosures or adjustments resulting from subsequent events through July 28, 2023, the date the financial statements were available for issuance. No events were identified that required disclosure in or adjustments to the financial statements.

3. INVESTMENT CONTRACT WITH TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and the notes receivable from participants reflected on the accompanying statements of net assets available for benefits and the related investment activity and interest from notes receivable from participants reflected in the statement of changes in net assets available for benefits.

4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following describes the valuation methodologies used for assets measured at fair value on a recurring basis. The techniques utilized in estimating the fair values of financial instruments are reliant on the assumptions used. Care should be exercised in deriving conclusions based on the fair value information of financial instruments presented below. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument.

4. FAIR VALUE MEASUREMENTS (continued)

Mutual Funds – The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets. Lifecycle funds are managed based on a target date. Due to similar valuation techniques, they are classified as mutual funds.

Money Market Fund – The money market fund is held as an individual plan asset, has a principal value of \$1 per unit and has an available price quoted daily in an active market.

The preceding described methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. On September 14, 2022, the Plan Sponsor elected to merge the Plan into the IEC Members Savings Plan (“IEC Plan”). Subsequently, all investments were transferred into the IEC Plan as of December 30, 2022

6. INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 30, 2022 and 2021, and the related investment activity reflected in the statement of changes in net assets available for benefits.

7. RELATED-PARTY TRANSACTIONS

Certain plan investments are money market and mutual funds managed by an affiliate of Fidelity Management Trust Company, the trustee of the Plan, and, therefore, these are considered party-in-interest transactions.

The Plan also pays administrative fees to Fidelity. These fees are considered exempt party-in-interest transactions. Other administrative expenses of the Plan are absorbed by the Plan sponsor. Therefore, those expenses are not reflected in these statements.

8. TAX STATUS

The Plan utilized a service provider to handle administrative matters including plan design. An opinion letter from the Internal Revenue Service has been obtained by the service provider accepting the Plan as a prototype qualifying under the appropriate Internal Revenue Code Sections. The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2017.

9. RISK AND UNCERTAINTIES

The Plan provides various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
