Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the CEANNATE CORP. 401(K) PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of July 7, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits (liquidation basis) for the periods then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

PLAN DESCRIPTION

The following description of the Ceannate Corp. 401(k) Plan (“Plan”) is provided for general information purposes only. Readers of the financial statements should refer to the Plan agreement for more complete information.

1. General - The Plan covered all full-time regular employees of Ceannate Corp. and its controlled group subsidiaries (the Company) that had attained 21 years of age after one month of service with the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
2. Contributions - In compliance with the Plan agreement, participants may have contributed up to the maximum allowable amount of wages, on a pre-tax or after-tax basis, (subject to IRS limitations) that would not cause the Plan to fail non-discrimination testing to the Plan. The contributions were accrued and funded on a per pay-period basis.

Participants may also have rolled over contributions from other qualified retirement plans. There weren’t any rollovers into the plan during 2022 or 2021.

Beginning in 2018, the Plan adopted a Safe-Harbor Matching Provision that matched 100% of deferrals up to the first 3% of compensation and 50% of deferrals for the next 2% of compensation. Matching contributions made to the Plan were \$-0- for 2022 and \$120,179 for 2021.

In compliance with the Plan agreement, the Company must have contributed a non-elective contribution (“the Prevailing Wage Contribution”), determined pursuant to the Davis-Bacon Act or any other Federal, State, or Municipal prevailing wage law for certain employee groups. There were no non-elective contributions to the Plan for 2022 or 2021.

All contributions to the Plan were stopped as of December 31, 2021 per the Plan termination.

3. Participant Accounts - Each participant’s account was credited with the participant’s contribution and the allocations of (a) the Company’s contributions and (b) individual account earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s account. A participant’s beneficiary received the remainder of the account, if any, upon the death of the participant.
4. Vesting - All participants were 100% vested in participant contributions and prevailing wage contributions. There was a 4-year vesting schedule for employer contributions as follows:

5. Disposition of Forfeitures – Forfeitures attributable to matching contributions were used to pay plan expenses and then reduce any employer matching contributions. Forfeitures totaled \$-0- and \$18,376 as of July 7, 2022 and December 31, 2021, respectively.

PLAN DESCRIPTION (Continued)

6. Payment of Benefits - On termination of service, a participant could elect to receive either a lump-sum amount equal to the value of his or her account or installments over a period not to exceed the life expectancy of the participant and his/her beneficiary as applicable. Participants could also receive in-service distributions for qualified financial hardship.
7. Plan Expenses – The Company paid for the significant expenses of the Plan.
8. Plan Termination - The Company was sold and the Plan was terminated, accordingly. Each participant became fully vested as to the value of his/her separate account.

NOTE 1—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**BASIS OF ACCOUNTING**

The accompanying financial statements have been prepared using the liquidation basis of accounting due to the plan being terminated.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from Plan assets during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments, other than the Morley Financial Services, Inc. Stable Value Signature Fund ("Stable Value Fund"), were stated at fair value at December 31, 2021. If available, quoted market prices were used to value investments. Investments having no quoted market price were reflected at their estimated fair value as determined by the investment manager. Investments in pooled separate accounts were valued at the net asset value of shares held by the Plan at year-end. Investments in common collective trusts were valued based on the market value of the underlying securities. All investments were held by Principal Trust Company.

The Stable Value Fund invests primarily in guaranteed investment contracts ("GIC's") and synthetic GIC's which are fully benefit-responsive. The GIC's and synthetic GIC's are stated at contract value (principal balances of the contracts, plus accrued interest at the stated rate, less payments received and contract charges by the insurance company). The average yield for fund was .85% for 2022 and .88% in 2021. The actual yield credited to participant to plan participants was .777% for 2022 and .902% for 2021.

NOTES TO FINANCIAL STATEMENTS

NOTE 1—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)**

The Stable Value Fund negotiates contracts with certain employer-initiated transaction provisions including percentage allowances for targeted layoffs, bankruptcy resulting in employee job loss, reorganizations, spin-offs, and plan terminations. Due to the size of the fund and the specific percentage allowances negotiated by the fund, it is highly unlikely (not probable) that any event would occur that would limit the fund's ability to transact at contract value with each issuer under these events.

The only event or circumstance that would allow issuers to terminate a fully-benefit responsive contract with the Fund at an amount different from contract value would be if they were provided with willingly fraudulent information about the fund. This would constitute a breach of contract and would allow for termination at a value that could be different from contract value.

Dividend and interest income were recognized when earned. Net appreciation on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year.

Purchases and sales of securities were reflected on a trade-date basis. Realized gains and losses on the sale of securities are computed on a specific identification basis.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document.

BENEFIT PAYMENTS

Benefit payments to participants were recorded when paid.

RECLASSIFICATIONS

Certain prior year amounts have been reclassified to conform with the current year presentation.

NOTE 2—INVESTMENT PROGRAMS

The Plan had a custodial agreement with Principal Life Insurance Company to hold the assets of the plan. Participants specified the percentage of contributions that were to be directed to each available investment fund.

NOTE 3—INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's asset custodian, Principal Life Insurance Company (a party-in-interest) for the period ended July 7 2022 and year ended December 31, 2001, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits as of July 7, 2022 and December 31, 2021.
- b. Investment income as shown in the accompanying statements of changes in net assets available for benefits for the for the period ended July 7 2022 and year ended December 31, 2001.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4—NOTES RECEIVABLE FROM PARTICIPANTS

Participants could borrow up to the lesser of 50% of their vested equity balance or \$50,000. Repayments of principal and interest were due at least quarterly over the specified loan period. In no instance could the term of repayment be greater than five years, unless the loan is used to acquire the participant's principal residence. Loans had fixed interest rates commensurate with the prevailing interest rate charged on similar commercial loans under like circumstances by persons in the business of lending money.

NOTE 5—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain expenses of the Plan were paid by the Plan sponsor. The Plan's investments were managed by Principal Life Insurance Company. These companies are considered parties in interest. Fees paid to Principal Life Insurance Company were \$23,455 for the period ended July 7, 2022 and \$11,118 for the year ended December 31, 2021.

NOTE 6—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

NOTE 6—FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 7, 2022 and December 31, 2021.

Level 1 Fair Value Measurements

The fair value of mutual funds were based on quoted net asset values of the shares held by the Plan at period-end.

Level 2 Fair Value Measurements

Level 2 Fair Value Measurements were not applicable to the Plan for 2022 and 2021.

Level 3 Fair Value Measurements

Level 3 Fair Value Measurements were not applicable to the Plan for 2022 and 2021.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB ASC subtopic 820-10, certain investments that are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Common collective trusts are valued at the net asset value ("NAV") of shares held by the Plan at year-end. The fair value of the pooled separate accounts is based on quoted net asset values of the shares held by the Plan at year-end. There are no unfunded commitments or any restrictions on the participant's ability to redeem investments. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Plan transactions (issuances and redemptions) may occur daily. Were the plan to initiate a full redemption of the common collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The common collective trust is designed to protect capital with low-risk investments and includes cash, bank notes, corporate notes, government bills, and various short-term debt instruments.

NOTE 7—TAX STATUS

The Plan, through its adoption of a Pension Specialists Ltd. Volume Submitter Profit Sharing Plan with CODA, has obtained an opinion letter issued to Pension Specialists Ltd. from the Internal Revenue Service dated March 31, 2014, stating that the Plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”) for use by employers for the benefit of their employees. The Plan administrator believes that the Plan was designed and was operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 7, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTES TO FINANCIAL STATEMENTS

NOTE 8—PLAN TERMINATION

On September 27, 2021, the Company engaged the third-party administrator to begin the process of terminating the plan. The Plan had distributed all plan assets to Plan participants as of July 7, 2022.

NOTE 9—SUBSEQUENT EVENTS

The Plan Administrator has evaluated subsequent events through July 25, 2023, the date which the financial statements were available for issue. There were no subsequent events which require disclosure.
