### **Disclaimer of Opinion**

We do not express an opinion on the financial statements of the Plan referred to in the first paragraph. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient, appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

As a result of the matter described in the Emphasis of Matter paragraph, the Plan does not have sufficient accounting records and supporting documents relating to the completeness of participants' data on which the contributions and benefit payments are determined. Accordingly, we were unable to apply auditing

procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Koffee Kup Bakery, Inc. 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct audits of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. ### **Emphasis of Matter**

As discussed in Note 1 to the financial statements, Koffee Kup Bakery, Inc., the Plan Sponsor, ceased operations during 2021 (currently acting under a Dissolution Receivership). As such, the Plan is no longer a going concern and was terminated during 2021. All remaining assets were disbursed during 2022.

### **(1) Description of Plan**

The following description of the Koffee Kup Bakery, Inc. (the "Company") 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

The Company ceased operations during 2021 and has been acting under a KeyBank Receiver since May 2021. A Dissolution Receiver was appointed in July 2021, and the KeyBank Receiver was dismissed in October 2021. Currently, the Company is acting under the Dissolution Receivership.

Additionally, the Plan terminated effective June 30, 2021 and all remaining assets were fully disbursed during 2022. As such, the Plan is no longer a going concern.

#### **(a) General**

The Plan was sponsored and administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The purpose of the Plan was to provide eligible employees a measure of financial security upon their retirement.

#### **(b) Eligibility**

The Plan was a defined contribution plan covering all employees of Koffee Kup Bakery, Inc., Superior Bakery, and Vermont Bread Company, who completed either one year of service, defined as 1,000 hours, or a 6 month special eligibility period during which hours of service equal at least 1,000 multiplied by a fraction number of months in the eligibility period divided by 12. Upon satisfaction of eligibility, participation in the Plan could begin on the first day of the following calendar quarter. Participation was voluntary.

#### **(c) Contributions**

Contributions to the Plan were made by the participants in the form of salary reductions (minimum of 2% up to a maximum of 100%) of qualified compensation as defined by the Plan. The Company's contributions were discretionary as determined annually by the Board of Directors. Up until the Company ceased operation, the Company match was equal to 50% of the first 6% of eligible deferred compensation. The Company could also make an additional discretionary contribution which was allocated to participants based on compensation and years of service. There were no additional discretionary contributions made during the period from January 1, 2022 to August 31, 2022 and the year ended December 31, 2021. Contributions were subject to certain Internal Revenue Service (IRS) limitations. Participants were permitted to rollover contributions from other qualified plans. All Plan contributions were participant directed upon deposit.

***(d) Participant Accounts***

Each participant's account was credited with the participant's and Company's contributions, allocations of investment earnings and any miscellaneous administrative expenses. Each participant's account was also adjusted to reflect the current fair value of the assets in which such account was invested. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

***(e) Vesting***

Participants were immediately vested with respect to their contributions plus earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus earnings thereon was based on years of continuous service. Vesting for the Company's contribution was 20% after two years of service and 20% per year thereafter. A participant was 100% vested after six years of credited service.

***(f) Payment of Benefits***

Benefits under the Plan were distributed to participants upon retirement, death, disability, or termination of employment in an amount equal to 100% of their vested account balance.

***(g) Forfeitures***

The part of any participant account that was not vested upon distribution was transferred to a "forfeiture account". The balance of the forfeiture account attributable to Company contributions could be used to pay administrative expenses of the Plan or reduce Company contributions. Forfeitures used totaled approximately \$0 and \$25,000 for the period from January 1, 2022 to August 31, 2022 and the year ended December 31, 2021, respectively. As of August 31, 2022 and December 31, 2021 there were no unused forfeitures.

***(h) Notes Receivable***

Participant loans were not permitted under the Plan.

**(2) Summary of Significant Accounting Policies**

***(a) Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP") Effective January 1, 2020, the financial statements are presented on the liquidation basis of accounting.

***(b) Investment Valuation and Income Recognition***

The Plan's investments were reported at fair value. Shares of registered mutual funds were valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation(depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

***(c) Use Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein during the reporting period. Actual results could differ from those estimates.

The Plan invested in mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes could materially affect the amounts reported in the financial statements.

***(d) Payment of Benefits***

Benefits were recorded when paid.

***(e) Administrative Expenses***

The Plan document provided that the expenses of administering the Plan were paid by the Company with the exception of certain miscellaneous expenses which were paid by the Plan.

***(f) Excess Contributions Payable***

Contributions that exceeded limits permitted by the IRS under discrimination testing requirements were recorded as liabilities to the Plan.

***(g) Subsequent Events***

The Plan has evaluated subsequent events through July 17, 2023, the date at which the financial statements were available to be issued.

**(3) Information Certified by the Plan's Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified as being complete and accurate the investments on the statements of net assets available for benefits in liquidation as of August 31, 2022 and December 31, 2021, and the investment activity reflected in the statements of changes in net assets available for benefits in liquidation for the periods then ended. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's trustee for their respective periods.

**(4) Related Party Transactions**

The Plan used a number of service providers. These providers were considered parties-in-interest under ERISA.

**(5) Fair Value Measurements**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value and a hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the period from January 1, 2022 to August 31, 2022 and the year ended December 31, 2021.

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Stable value funds:* Valued using the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(6) Plan Termination and Amendment**

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Additionally, the Company could amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprived any participant of the participant's non-forfeitable accrued benefit. As discussed in Note 1, the Plan was terminated during 2021 and was fully disbursed during 2022.

**(7) Tax Status**

The Plan is based on a prototype plan that has obtained a determination letter stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code. Generally, the plan administrator and the Plan may rely on the determination letter as to the form of the plan qualifying under the Internal Revenue Code (except as otherwise noted in the determination letter). Additionally, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and remains tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
