REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator and Participants of the
Emerge Energy 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Emerge Energy 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of July 6, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to July 6, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of July 6, 2022 and December 31, 2021, and for the period from January 1, 2022 to July 6, 2022, and the year ended December 31, 2021, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTES TO FINANCIAL STATEMENTS

Period from January 1, 2022 to July 6, 2022

A. Description of the Plan

General

The following brief description of the Emerge Energy 401(k) Plan (the “Plan”) is provided for general information purposes only. The Plan was sponsored by EES GP, LLC (the “Plan Sponsor”). Prior to May 1, 2021, the Plan, formerly known as the Emerge Energy Services GP, LLC 401(k) Plan, was sponsored by Emerge Energy Services GP, LLC. Participants should refer to the Plan document for more complete information. The corporate offices of the Plan Sponsor are located in Fort Worth, Texas.

Effective July 6, 2022 (“Effective Date”), the Plan Sponsor entered into an Agreement of Merger with the professional employer organization (“PEO”), Employer Flexible HR, LLC. Pursuant to the terms of the agreement, the participants and plan assets of the Plan were merged into the Employer Flexible 401(k) Plan effective July 6, 2022. On November 22, 2022, all plan assets were transferred into the Employer Flexible 401(k) Plan.

The Plan was established effective June 1, 2012, restated most recently May 1, 2021, and was a defined contribution plan that was available to all employees of the Plan Sponsor who had attained age 21 and who had completed one month of service. All employees of the Plan Sponsor were eligible to participate in the Plan, except for those employees who were covered by a collective bargaining agreement or non-resident aliens. Eligible employees could have entered the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan was to encourage the Plan Sponsor’s employees to save and invest, systematically, a portion of their current compensation so that they and their families could have a source of additional income upon their retirement, or in the event of death.

During 2021, Branch Banking & Trust Company’s recordkeeping retirement business was acquired by Ascensus, LLC (“Ascensus”). As a result, the Plan Sponsor’s recordkeeping services were transitioned to Ascensus, and the Plan Sponsor’s trustee was transitioned to Ascensus Trust.

Contributions

Prior to the Effective Date, participants could have contributed up to 80% of their payroll period compensation, as defined by the Plan. Contributions were subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. In addition, some or all of a participant’s contributions could have been designated as a Roth deferral contribution. Roth deferral contributions were made on an after-tax basis; however, such contributions were not taxed at the time of distribution. Eligible participants could have also made rollover contributions to the Plan from another qualified plan.

A. Description of the Plan – continued

Contributions – continued

Prior to the Effective Date, participants who were eligible to make salary deferral contributions under the Plan and who had attained age 50 before the close of the year could have made catch-up contributions in accordance with, and subject to, the limitations imposed by the Code.

Effective January 1, 2021, the Plan was amended to allow for the Plan Sponsor to make a safe harbor matching contribution equal to 100% of the participant's elective deferrals that do not exceed 6% of his or her compensation. There were no other discretionary employer contributions made during the period from January 1, 2022 to July 6, 2022 and the year ended December 31, 2021.

Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of the Plan Sponsor's contributions and Plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's account.

Vesting

Participants were fully and immediately vested in their voluntary contributions, employer safe harbor contributions, and any actual earnings thereon.

Participant Loans

Up through the Effective Date, participants could have borrowed from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. Loan terms ranged up to five years, or longer for the purchase of a primary residence. The loans were secured by the balance in the participant's account and included interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor. As of December 31, 2021, interest rates ranged from 4.25% to 6.50%. Principal and interest were paid ratably through payroll deductions. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

Benefit Payments

Participants withdrawing during the period for reasons of service or disability, retirement, death, or termination were entitled to their vested account balances. Benefits were distributed in the form of rollovers or lump-sum payments.

Certain in-service withdrawals were allowed. A participant could have elected to withdraw all or a portion of his or her salary reduction contributions while employed after reaching age 59 ½.

A. Description of the Plan – continued

Benefit Payments – continued

A participant could have also received a hardship distribution from salary reduction contributions if the distribution met one of the following conditions: (1) on account of uninsured medical expenses incurred by the participant, his or her spouse, or dependents; (2) to purchase (excluding mortgage payments) a principal residence for the participant; (3) for the payment of post-secondary tuition expenses for the participant, his or her spouse, or dependents; (4) needed to prevent eviction of the participant from his or her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) for funeral expenses for the participant's parents, spouse, or dependents; or, (6) for payments to repair the participant's principal residence that would qualify for a casualty loss deduction.

Effective January 1, 2020, the Plan's hardship withdrawal provisions were updated in connection with the Bipartisan Budget Act. Participants were no longer (1) required to obtain a loan prior to requesting a hardship withdrawal; (2) participant deferral contributions were no longer suspended after receipt of a hardship withdrawal; and (3) earnings on elective deferral contributions in a participant's account were to be included as part of a hardship withdrawal. The reasons for heavy financial need were also expanded to include certain disaster events and casualty losses not associated with disasters.

Investment Options

Upon enrollment in the Plan, a participant could direct his or her salary deferrals in any increment into any of the Plan's investment options.

Plan Expenses

Employees of the Plan Sponsor performed certain administrative functions with no compensation from the Plan. In accordance with Plan provisions, the Plan Sponsor paid substantially all costs relating to asset charges and recordkeeping. All significant administrative expenses were paid by the Plan Sponsor and are not reflected in the accompanying financial statements.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

B. Summary of Significant Accounting Policies – continued

Contributions

Contributions from the Plan Sponsor and participants are accrued as they become obligations of the Plan Sponsor, as determined by the plan administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income

The investments of the Plan are stated at fair value and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the period and unrealized increases or decreases in the market value of investments held at period-end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Cash and Cash Equivalents

All highly liquid investments with a maturity of three months or less when purchased are treated as cash equivalents. At December 31, 2021, the Plan held such investments in one financial institution, which did not exceed amounts covered by insurance provided by the U.S. Federal Deposit Insurance Corporation. The Plan did not have such investments as of July 6, 2022.

C. Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Mutual funds are valued at the published per share net asset value ("NAV") of shares held by the Plan and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at NAV.
- The stable value collective trust fund represents investments with various investment managers and composed primarily of fully benefit-responsive investment contracts. Units held by the Plan in the common collective fund are valued at the unit value as reported by the investment managers. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

C. Fair Value Measurements – continued

As the Plan merged into the Employer Flexible HR, LLC’s 401(k) Plan effective July 6, 2022, there is no fair value to report for the period ending July 6, 2022. There have been no changes in the methodologies used at December 31, 2021. The following table details the Plan’s investments at fair value by level, within the fair value hierarchy, as of December 31, 2021. The Plan has no assets classified within Level 2 or Level 3 of the valuation hierarchy.

D. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2021, and net realized and unrealized gain on investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022 to July 6, 2022 and year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Branch Banking and Trust Company for the period January 1, 2021 through February 28, 2021, and by Ascensus Trust Company, (the trustee of the Plan) for the period March 1, 2021 through July 6, 2022.

E. Tax Status

Prior to May 2021, the Plan had adopted the Branch Banking and Trust Company Defined Contribution Prototype Plan, which has a favorable opinion letter from the Internal Revenue Service (“IRS”) dated March 31, 2014. Effective May 1, 2021, the Plan was amended and restated by the adoption of the Ascensus, LLC Non-Standardized Safe Harbor Profit Sharing Prototype Plan with CODA, which has a favorable opinion letter from the IRS dated June 30, 2020. The opinion letter states that the form of the prototype plan is acceptable under Section 401 of the Code.

The Plan Sponsor may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor believes that through the effective date, the Plan was being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 6, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participants’ accounts will become 100% vested.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Parties-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Notes receivable from participants to the Plan qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

I. Subsequent Events

In preparing the accompanying financial statements, management has evaluated all subsequent events and transactions for potential recognition or disclosure through May 15, 2023, the date the financial statements were available for issuance.
