### **Emphasis of Matter — Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note A to the financial statements, the Plan Administrator the Plan approved a plan of liquidation on November 30, 2021, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

### Note A – Description of Plan

The following description of the Southeastern Sash & Door, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all employees of Southeastern Sash & Door, Inc. (the “Company” or “Employer”). The Plan was formed and adopted on January 1, 1997 and was amended and restated February 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees were eligible to participate in the Plan immediately upon reaching 18 years of age and completing 1 month of service. Employees could enter the Plan on the first day of the month coinciding with or following the date eligibility requirements are satisfied. All employees of the Company are eligible to participate upon meeting the aforementioned requirements and are automatically enrolled at 1% of their eligible earnings.

The Plan Administrator elected to terminate the Plan effective November 30, 2021 and distributed all assets to participants as of February 23, 2022.

#### Administration of the Plan

The accounting records from January 1, 2022 to February 23, 2022 were maintained by the Company. The Plan’s assets for the year were maintained and administered by Reliance Trust Company (the “Trustee”). The Plan utilized ADP, LLC as its record keeper.

#### Contributions

Effective November 1, 2021, all participant contributions were stopped. There were no participant or Employer contributions during 2022.

#### Participant Accounts

Each participant’s account is credited and/or reduced with the participant’s elective deferral contributions and distributions, the Company’s contributions, and an allocation of the Plan’s investment earnings/losses, investment fees and any administrative expenses paid out of the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan.

#### Vesting

Participants are immediately vested in their voluntary and qualified non-elective contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credit service as follows:

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, or other acceptable collateral, and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The maximum note repayment period is five years unless the note is for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan will be treated as a taxable distribution as of the first day of the second calendar quarter following the calendar quarter in which the participant failed to make a required installment payment.

#### **Distribution of Benefits**

After age 59 ½, upon termination of service due to death, disability or retirement a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments paid over various periods, as defined in the Plan agreement, less any applicable taxes. Participants may request a hardship withdrawal from the portion of their accounts attributable to employee deferral balances, excluding any earning on those deferrals, as well as any vested matching contributions or non-elective contributions for distribution.

#### **Forfeitures**

Forfeitures occur when a participant terminates employment and has not vested in a portion of the Company's contribution amount. Forfeitures may be applied to reduce Employer contributions and Plan expenses. As of February 23, 2022 and December 31, 2021, forfeited non-vested accounts totaled approximately \$0, respectively. For the period from January 1, 2022 to February 23, 2022, no forfeitures were used to offset Employer matching contributions.

#### **Plan Termination**

The Company was sold and acquired by Fulcrum Building Group, LLC on December 1, 2021. Effective January 31, 2022, the Plan was terminated and all participants became 100% vested. Participants were notified in writing that they have 60 days to request a distribution of funds contributed to the Plan or were given the option to roll over the assets to an eligible retirement plan. All plan assets were distributed to participants by February 23, 2022.

### **Note B – Summary of Significant Accounting Policies**

#### **Basis of Presentation**

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

#### Valuation of Investments

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the period of January 1, 2022 to February 23, 2022 and Plan year December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Fair Value Measurements (continued)

*Common/collective trusts.* Valued at NAV provided by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at February 23, 2022 and December 31, 2021. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at February 23, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022 to February 23, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution. As of February 23, 2022 and December 31, 2021, and for the period from January 1, 2022 to February 23, 2022, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Trustee, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated July 8, 2014 for its prototype plan stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2020.

### Note E – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions were in investment funds managed by the Trustee; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$10,000 during the period from January 1, 2022 to February 23, 2022.
