## Independent Auditors' Report

To the Plan Administrator

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the Hohman Plating and Manufacturing 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the ten month period ended October 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 31, 2022 and for the ten month period ended October 31, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A – DESCRIPTION OF PLAN**

On April 1, 2022, Hohman Plating and Manufacturing, LLC (the Company) was acquired by Novaria Group. In conjunction with the closing of this transaction, the Company terminated the Plan, and there were no additional employee or employer contributions made to the Plan. As a result, all participant accounts in the Plan became 100% vested and the account balances were liquidated and distributed to participants as soon as administratively practicable after that time.

The following brief description of the Hohman Plating and Manufacturing 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General Information**

The Plan is a defined contribution prototype plan and trust administered by Pension Corporation of America covering all eligible employees of the Company. Employees who are not covered by a collective bargaining agreement and are age 21 or older were eligible to participate in the Plan. Eligible participants could enter the Plan on January 1, April 1, July 1, or October 1, upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is qualified under the Internal Revenue Code (Code).

**Contributions**

Each year, participants could elect to defer pre-tax or Roth after-tax contributions up to the maximum allowed by law. Roth 401(k) contributions were included as taxable income to the employee. Earnings on the Roth 401(k) contribution will accumulate tax free and retirement withdrawals may be exempt from federal income tax. Employees with existing qualified pre-tax retirement plans or Roth 401(k) accounts with a prior employer could transfer or roll-over those accounts into the Plan upon becoming a participant in the Plan. Participants that are age 50 or older and make the maximum allowable deferral to the Plan are entitled to contribute an additional catch-up contribution. Participants could direct investment of their account balances into various investment options offered by the Plan.

The Plan provides for the Company to make discretionary matching contributions. The Company will make discretionary matching contributions equal to 30% of participant elective deferrals, up to 4% of compensation for all participants that have completed one year of service as defined by the Plan. The discretionary matching contribution is made to participants' accounts for both pre-tax contributions and Roth after-tax contributions. The Company also makes a safe harbor contribution equal to 4% for all participants that have completed one year of service as defined by the Plan. The Company could also make a discretionary profit-sharing contribution that is allocated to all eligible participants.

The Company's discretionary matching and safe harbor contributions for the period ended October 31, 2022 were \$175,552. There were no discretionary profit-sharing contributions made in 2022.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective deferral contributions, rollovers, employer safe harbor contributions and discretionary contributions plus any earnings they generate. Employer matching contributions to the Plan plus any earnings they generate vest at 20% each year and are fully vested after five years of service. In conjunction with the termination of the Plan, all participants accounts in the Plan became 100% vested.

**Notes Receivable from Participants**

Participants could borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or longer for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account provided the outstanding balance does not exceed 50% of the vested interest in the Plan. The loan is charged a commercially reasonable rate of interest based on interest rates charged for similar types of loans by other lenders. A participant could only have one loan outstanding at a time. The principal and interest is paid ratably through regular payroll deductions.

**Payment of Benefits**

Participants become eligible for benefit payments upon retirement, termination of employment, disability or death. Additionally, the Plan provides for in-service distributions after a participant has reached age 59 ½ and after their account is fully vested. Participants could also receive distributions from the employee deferral or rollover balance for qualified financial hardships. Distributions could be made as a single lump-sum payment, partial withdrawals of at least \$1,000, or installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary). Vested account balances that do not exceed \$5,000 could only be distributed in a single lump-sum payment.

**Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan was terminated effective April 1, 2022 and all participants accounts became 100% vested.

**Forfeitures**

Forfeitures resulting from the non-vested portion of participants' accounts who terminate prior to being fully vested are generally used first to pay any administrative expenses of the Plan. Any remaining forfeitures will be used to reduce employer contributions. At October 31, 2022 and December 31, 2021, forfeitures were \$0 and \$290, respectively. For the period ended October 31, 2022, \$1,402 of forfeitures were used for administrative expenses.

**Expenses of the Plan**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses paid by the Plan totaled \$62,561 for the period ended October 31, 2022.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying December 31, 2021 financial statements of the Plan have been prepared on the accrual basis of accounting.

The October 31, 2022 financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (ASU) 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on April 1, 2022. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2022 or December 31, 2021.

**Payment of Benefits**

Benefit payments are recorded when approved. There were no benefit payments that were approved but not paid as of October 31, 2022 or December 31, 2021.

**NOTE C – INVESTMENTS (INFORMATION CERTIFIED BY THE PLAN TRUSTEE)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at October 31, 2022 and December 31, 2021, net depreciation in fair value of investments, and dividends and interest for the ten month period ended October 31, 2022, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE D – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

*Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2022 and December 31, 2021.

*Mutual funds:* Mutual funds are stated at fair value as defined by observable quoted prices in active markets (Level 1).

*Collective trust fund:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. The Wells Fargo Stable Value Fund C has no withdrawal restrictions for participant-initiated withdrawals but does require a 12-month advance notice for plan sponsor-initiated withdrawals.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the Plan’s valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – TAX STATUS**

The Plan adopted a volume submitter plan that received an advisory letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype plan document is qualified under Section 401 of the Internal Revenue Code (IRC), and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company believes the Plan, as amended, is being operated and administered in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt at October 31, 2022 and December 31, 2021.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that at October 31, 2022 and December 31, 2021, there were no uncertain positions taken that would require recognition of an asset or liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H – PARTIES-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those fiduciaries or employees of the Plan, any person who provides services to the Plan and employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. Certain administrative expenses are provided by the Company at no cost to the Plan and certain administrative expenses of the Plan are paid by the Company.
