Note 1 -- Description of the plan

The following description of the Admin Inc. DBA Paro 401(k) Plan ("the plan") provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions. The Plan was adopted effective January 1, 2020. The purpose of the Plan is to provide eligible employees an opportunity to accumulate savings on a tax-advantage basis.

General

The plan is a defined-contribution plan covering employees of the company who have reached the age 21. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees oversee governance of the plan. The plan's Investment Committee determines the appropriateness of the plans investment offerings, monitors investment performance and report to the Trustees.

Contribution

Each year, participants may contribute up to 100% of annual compensation, as defined in the plan, not to exceed the limits set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) plan earning and (b) charged with an allocation of administrative expenses. Allocations of plan earnings are based on participant, account balances, as defined in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The total eligible participants at year end are 124. The plan permits the transfer of funds from other qualified plans to a separate participants' rollover account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

Payment of benefits

On termination of service due to death, disability, retirement (age 65) or other reasons, a participant with an account valued at less than \$5,000 shall receive a lump-sum distribution. For accounts exceeding \$5,000 the participant may (a) elect a lump-sum distribution; or (b) elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or (c) elect to rollover the distribution to another qualified plan. The plan permits hardship distributions if certain criteria are met. The plan permits in-service distributions at age 59 ½.

Notes receivable from the participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that range from 5% to 8.25%, set by the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through payroll deductions.

Note 2 -- Summary of significant accounting policies

Basis of Accounting

The preparation of these financial statements and accompanying notes in conformity with United States of America generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported. Actual results could differ from those estimates.

Use of estimates

The preparation of financial statements in accordance with the U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's Investment Committee determines the plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note-4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the period ended December 31, 2022.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any interest accrued but unpaid interest. Interest income is recorded on the accrual bases. Related fees are charged directly to the borrowing participants' account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is deemed a distribution and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The company pays most of the administrative expenses of the plan which are excluded from these financial statements. The major administrative expenses are payroll and related expenses, legal and accounting fees.

Subsequent events

The Plan evaluated subsequent events through August 02, 2023, the date the financial statements were available to be issued. Events or transactions occurring after December 31, 2022, but prior to August 02, 2023, that provided additional evidence about conditions that existed at December 31, 2022, have been recognized in the financial statements for the year ended December 31, 2022.

NOTE 3 -- Investments

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by the custodian of the Plan Ascensus, LLC, except for comparing such information to the information included in the Plan's financial statements and supplemental schedule as of December 31, 2022, and for the year December 31, 2022.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. The Trustee of the Plan executed all investment transactions and certified the assets of the plan as of December 31, 2022.

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2022, net appreciation/ (depreciation) in fair value of investments, investment income and investment expenses for the period then ended, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

The U.S. GAAP framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets; Level 2 inputs consist of observable inputs other than quoted prices for the asset or liability; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022, are reported in net appreciation in fair value of investments.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 -- Party-in-interest transactions

Vanguard Group, Inc. is the asset custodian of the plan and is, therefore designated as a fiduciary and party-in-interest. The plan regularly invests in funds for which Vanguard or its affiliates are the issuing parties. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions, there were \$385 of admin expenses paid to custodian by the year ended December 31,2022.

Fees paid for accounting and other professional services by parties-in-interest were based on customary and reasonable rates for such services.

NOTE 6 -- Tax status

The company adopted the Ascensus, LLC Volume Submitter 401(k) Plan, referred to in Note-1, which received a favorable opinion letter from the IRS on June 30, 2020, that the plan and related trust are in accordance with applicable section of the IRC. The volume submitter plan has been restated since receiving the opinion letter. However, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRS.

NOTE 7 -- Plan termination

Although it has not expressed any intent to do so, the employer has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their allocated employer contributions.

NOTE 8 -- Concentration of market risks

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and other credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 9 -- Covid-19

On March 11, 2020, the World Health Organization characterized coronavirus (COVID-19) as a pandemic, and on March 13, the President of the United States declared a national emergency relating to the disease. This measures is designed to protect the overall public health, however are expected to have material adverse impacts on domestic and foreign economies

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

As a result of COVID-19, there has been heightened market risk and volatility associated with the pandemic, and this could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits, as mentioned above. Because of the uncertainty of the markets during this time, Plan management is unable to estimate the total impact the pandemic will have.
