## Form 5500 Cover Letter

Aluminum Shapes and Affiliated Companies (Plan 001)  
Aluminum Shapes L.L.C (EIN: 46-1406288)  
Plan Year Ending December 31, 2022

Aluminum Shapes L.L.C. was the Sponsor of the Aluminum Shapes and Affiliated Companies (the “Plan”). A majority of the assets of the Plan were distributed prior to the establishment of the Liquidating Trust (see below). The 2022 Form 5500 was prepared by Prudential (acquired by Empower Retirement) and signed by the Liquidating Trustee, solely in capacity as the Liquidating Trustee, who cannot confirm the accuracy of all the information contained in the 2022 Form 5500.

On August 15, 2021 (the “Petition Date”), Aluminum Shapes L.L.C. (the “Debtor”) filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code (the “Chapter 11 Case”) in the United States Bankruptcy Court for the District of New Jersey (the “Court”). On August 11, 2022, the Court entered the *Findings of Fact, Conclusions of Law, and Order (I) Approving the Disclosure Statement on a Final Basis, and (II) Confirming the Official Committee of Unsecured Creditors’ Plan of Liquidation Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 619] (the “Confirmation Order”), (i) approving on a final basis the *Disclosure Statement of the Official Committee of Unsecured Creditors for the Plan of Liquidation of the Official Committee of Unsecured Creditors Dated May 6, 2022* (as further modified, revised, supplemented and amended, the “Disclosure Statement”) [Docket No. 512]; and (ii) confirming *The Official Committee of Unsecured Creditors’ Liquidating Plan Pursuant to Chapter 11* [Docket No. 511] (as further modified, supplemented and amended including all attachments and exhibits thereto, the “Plan”). Through the Plan, a liquidating trust (“Liquidating Trust”) was established to administer the Liquidating Trust assets and make distributions to holders. Advisory Trust Group, LLC was chosen to serve as the liquidating trustee of the Liquidating Trust (the “Liquidating Trustee”). The effective date of the Plan occurred on August 24, 2022 [Docket No. 635] (the “Effective Date”). Upon the Effective Date, the Liquidating Trustee was vested with all of the power and authority set forth in the Plan and otherwise as is necessary or proper to carry out the provisions of the Plan, as applicable.
