### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of the N(3) 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 16, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period beginning January 1, 2022 and ended June 16, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) Audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 16, 2022 and December 31, 2021, and for the period beginning January 1, 2022 and ended June 16, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Note 1 - Description of plan:

The following description of the N(3) 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor was N(3), LLC (the Company, Plan Sponsor, or Plan Administrator). The Plan was a defined contribution 401(k) plan covering substantially all employees of the Company who were immediately eligible after they had attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan termination

The Company was acquired by Accenture LLP in October 2020, and due to the sale, the Company approved a termination of the Plan in June 2022, and all participant accounts became fully vested. Approximately \$7,500,000 of participant accounts were transferred to the Accenture United States 401(k) Match and Savings Plan in 2022 due to the termination.

#### Contributions

Participants could elect to defer from 1% to 100% of pretax annual compensation, as defined in the Plan. Participants could also make after-tax Roth contributions to the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company could make discretionary matching or profit sharing contributions. For 2022, the Company did not make any discretionary matching or profit sharing contributions to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations. Participants directed the investment of their contributions into various investment options offered by the Plan. Due to the termination of the Plan, there were no contributions made to the Plan after March 31, 2022.

#### Participant accounts

Each participant's account was credited with the participant's contributions and allocations of Company contributions, as well as Plan earnings. Participant accounts were also charged with withdrawals and an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

##### Vesting

Participants were immediately vested in their contributions and rollover contributions, plus actual earnings thereon.

Participants became vested in Company discretionary matching and profit sharing contributions in accordance with the following schedule:

Participants were immediately vested upon termination of the Plan, upon reaching normal retirement age of 65, or upon disability or death while an employee of the Plan Sponsor. Forfeitures of terminated participants' non-vested accounts were used to reduce the Company's contribution for the Plan year.

##### Forfeitures

At June 16, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0. During the period ended June 16, 2022, Company contributions were not reduced from forfeited non-vested accounts.

##### Payment of benefits

A participant was entitled to receive an amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability or death. If the vested amount was \$5,000 or less, and the participant did not elect a rollover to an IRA or a qualified defined contribution or defined benefit Plan, a lump-sum distribution was required. A participant could request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship, but the withdrawal was limited to the amount of the participant's pretax contributions and earnings thereon. Distributions could be made from a participant's rollover account at any time.

Notes receivable from participants

Participants could borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms were for a period not exceeding five years unless for the purchase of a principal residence, for which the maximum was 10 years. Notes were secured by the balance in the participant's account and bore interest at an agreed-upon percentage based on prevailing market rates. Principal and interest was paid ratably through payroll deductions. Participants were allowed one outstanding note.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation of fair value of investments.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Due to the acquisition by Accenture LLP, the Company approved a liquidation of the Plan as of June 16, 2022, and management determined that liquidation of the Plan's assets was imminent. As a result, the Plan's 2022 financial statements have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis is appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amount.

Fully benefit-responsive investment contract

Fully benefit-responsive investment contracts are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the cost

plus contributions made under the contract plus interest at the contract rates less withdrawals and administrative expenses. This specifically affects the presentation of the amounts related to the Plan's participation in the guaranteed interest account, see Note 8. The statements of net assets available for benefits present the contract value of the guaranteed interest account.

##### Investment valuation and income recognition

Investments are reported at fair value, (except for those noted in Note 8, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### Payment of benefits

Benefits are recorded when paid.

##### Use of estimates

The preparation of financial statements in accordance with liquidation basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they were incurred. No allowance for credit losses was recorded as of June 16, 2022 or December 31, 2021. If a participant ceased to make note repayments and the Plan Administrator deemed the participant note to be in default, the participant note balance was reduced and a benefit payment was recorded.

Excess contributions payable

In 2021, excess contributions were made to the Plan. This amount was included in the benefits paid to participants on the December 31, 2021 Statement of Changes in Net Assets Available for Benefits.

Risks and uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Recent legislative developments

In December 2019, Congress passed the SECURE Act which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document.

In March 2020, Congress passed the CARES Act which included optional immediate changes to distribution and loan provisions without formal amendment of the plan document.

Subsequent events

The Plan has evaluated subsequent events through July 25, 2023, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of June 16, 2022, have been incorporated into these financial statements.

Note 3 - Investments and information certified by the trustee:

Reliance Trust Company (Reliance) is the trustee for the Plan and Massachusetts Mutual Life Insurance Company (Mass Mutual) holds the Plan's guaranteed interest account investment. Reliance and Mass Mutual hold the Plan's investment assets and execute investment transactions. Management has determined that Reliance and Mass Mutual are qualified institutions and the information prepared and certified by Reliance and Mass Mutual meet the requirements of ERISA Section 103(a)(3)(C). Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and

supplemental schedule, including investments and notes receivable from participants held at June 16, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended June 16, 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance and Mass Mutual.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets and liabilities measured at fair value. There have been no changes in the methodology used at December 31, 2021.

- Mutual funds are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related-party transactions:

Certain Plan investments are managed by Reliance and Mass Mutual and, therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services and certain recordkeeping services are included in net depreciation in fair value of investments.

Note 6 - Plan termination:

The Company chose to merge the Plan with and into the Accenture United States 401(k) Match and Savings Plan, effective June 16, 2022, and all remaining assets of the Plan were transferred into the Accenture United States 401(k) Match and Savings Plan on that date.

Note 7 - Tax status:

The Plan operates under a Qualified Plans, LLC sponsored non-standardized prototype plan. The prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS non-standardized prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Group annuity contract with Massachusetts Mutual:

The Plan maintained an investment in the Massachusetts Mutual Guaranteed Interest Account, which is a guaranteed interest account provided through a group annuity contract. As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Massachusetts Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but it could not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The contract could not be terminated prior to the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. Removal of a group of participants from plan coverage as a result of temporary absence; change in position or other occurrence qualifying as a temporary break in service under the Plan.

2. Transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Company.
3. Cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business.
4. Removal from the Plan of one or more groups or classifications or participants.
5. Partial or complete Plan termination.
6. Plan disqualification.

The Plan Administrator believed that no events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.
