**Note A - Description of plan**

**1. Initial disclaimer**

The following description of the XO Holding, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**2. General**

The Plan, which was adopted on February 1, 2019, is a defined contribution plan and is intended to provide participants with future retirement benefits for those who may qualify for participation therein. The Plan covers all eligible employees of XO Holding, Inc. (the "Company"). Employees become eligible to participate in the Plan after attaining the age of 18, as defined in the Plan Document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**3. Plan administration**

The management and administration of the Plan is the responsibility of the Company and its designee. The company utilizes Fidelity Management Trust Company ("Fidelity") as the custodian of all the Plan's assets including substantially all the responsibility for investment, reinvestment, control and disbursement of the funds of the Plan.

**4. Contributions**

Each year, participants may contribute up to the maximum percentage of allowable compensation, as defined in the Plan Document. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Company, at its discretion, may contribute to the Plan a matching contribution of a percentage of the participant's elective deferral contribution. In addition, the Company may, at its discretion, contribute a varying amount on behalf of all employees that qualify as plan participants (discretionary Company contributions). The Company contributed \$1,962,929 and \$1,224,465 during the years ended December 31, 2022 and 2021, respectively. Contributions are subject to certain limitations.

**5. Participant accounts**

Each participant's account is credited with the participant's contributions, allocations of the Plan's earnings, and Company contributions, and charged with benefits payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note A - Description of plan (continued)**

**6. Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participant's account attributable to employer matching discretionary contributions vests 25% after one year of service increasing 25% each of the following years until 100% vested after four years credited service. Participant accounts become fully vested upon retirement, death or disability regardless of years of services.

**7. Investment option**

Upon enrolling in the Plan, a participant may select investments from Fidelity. Participants determine the amount to be invested and may make changes in their investment elections at any time. Plan assets are held by Fidelity, the Plan's custodian.

**8. Payment of benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals may occur upon demonstration of financial hardship, or after the participants reach age of 59.5 years.

**9. Forfeitures**

As of December 31, 2022 and 2021, there were no forfeitures held by the Plan. Forfeitures can only be used to pay expenses or reduce Company contributions in the future. \$66,166 and \$75,363 of forfeitures were used to reduce Company contributions during the years ended December 31, 2022 and 2021, respectively.

**10. Plan termination**

During the year ended December 31, 2022, the Plan was terminated and plan assets were combined with the plan administered by Vista Family of Companies Multiple Employer Plan and Profit-Sharing Plan.

**Note B - Summary of Significant Accounting Policies**

**1. Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

**2. Investment valuation and income recognition**

The Plan's investments are held primarily through pooled separate accounts, managed by Fidelity. Investments are reported at fair value. Fair value of a financial instrument is the price that would be received when selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Changes in fair value, along with realized gain and losses, are reflected as net appreciation (depreciation) in fair value of investments.

**3. Payment of benefits**

Benefits are recorded when paid.

**4. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**5. Administrative expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Administrative expenses were \$55,611 and \$59,228 for the years ended December 31, 2022 and 2021, respectively.

**Note C - Market risk**

The Plan provides for investments in a variety of investment funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonable possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**Note D - Information certified by the Plan's custodian (unaudited)**

As of December 31, 2022 and 2021, the Plan's investments were held by Fidelity, the Plan's custodian. The following is a summary of the Plan's financial information that is included in the financial statements and supplementary schedule, and is based on information certified by the custodian as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Financial Accounting Standards Board ("FASB") has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

*Level 2* - Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets

Quoted prices for identical or similar assets or liabilities in inactive markets

Inputs other than quoted prices that are observable for the asset or liability

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value of measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used

need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

*Mutual and Money Funds* - These investments are valued at the daily closing prices as reported by the fund. Mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*ETF Funds* - These investments are valued at the closing price reported on the active market on which the fund is listed. The accounts are classified within level 2 of the valuation hierarchy.

*Stable Value Fund* - These investments are public investment vehicles valued at a fixed or stable value for the NAV as the practical expedient. The accounts are classified within level 2 of the valuation hierarchy.

*Guaranteed Interest Accounts* - These investments are public investment vehicles valued using \$1 for the NAV as the practical expedient. The accounts are classified within level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth, by level within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. The Plan had no financial assets as of December 31, 2022. The Plan had no financial liabilities as of December 31, 2022 and 2021.

**Note F -Fully benefit-responsive investment contract with insurance company**

The Plan has a fully benefit-responsive guaranteed investment contract with Fidelity. Fidelity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a

specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value as it approximates contract value. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2022 and 2021, was zero and \$229,644 respectively. The crediting interest rate is based on a formula agreed upon with the issuer with interest rates reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity was provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note G - Exempt party-in-interest transactions**

Certain Plan investments are shares of pooled separate accounts and guaranteed interest contracts managed by Fidelity. Fidelity is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and distribution requests were \$55,611 and \$59,228 for the years ended December 31, 2022 and 2021, respectively.

**Note H - Tax status**

The Company has adopted a standardized prototype profit sharing plan. The Internal Revenue Service has issued an opinion letter to the Company dated March 31, 2014, that the Plan and its amendments are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and it currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken that more likely than not would not be sustained

upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2019.
