### **Report on the Audits of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

**Other Matters**

**2022 Supplemental Schedule Required by ERISA**

The supplemental schedule of reportable transactions for the year ended December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of The Smead Manufacturing Company Pension Plan (the Company) Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined benefit plan providing retirement and death benefits to eligible employees of The Smead Manufacturing Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective July 31, 2021, the Company elected to terminate the Plan. The IRS notified the Plan in November 2021 that the termination of the Plan does not impact the tax qualified status of the Plan and noted approval of the amendments submitted with the application to bring the Plan into compliance with the applicable regulatory updates. In June 2022, the Plan processed lump sum payments to participants electing such option. In addition, an annuity purchaser was secured to assume future obligations for those electing recurring pension payments. Under the agreement, the Company purchased a group annuity contract for 335 plan participants that provides for an irrevocable commitment to make annuity payments to the affected participants. The payment obligation and administration thereof for the affected participants was transferred from the pension plan to the insurance company. The transfer did not change the amount of the monthly pension benefits received by the affected participants. As of December 31, 2022, the excess assets of the Plan were transfer into the Smead Manufacturing Company Employees' Investment Plan and Trust.

**Eligibility**

All nonunion employees of the Company, except for certain employees who worked for the Company in Florence, South Carolina, became eligible for participation in the Plan upon attaining age 21 combined with one year of service, defined as a 12-month period in which an employee completed 1,000 hours or more of service. In addition, all union employees of the Company employed at the McGregor, Texas and Locust Grove, Georgia locations participated in the Plan on the first day of the month following the employee's date of employment.

The Plan excludes leased employees, independent contractors, nonresident aliens with no U.S. source income and employees covered by a collective bargaining agreement unless that agreement provides for their participation.

Effective December 31, 2012, no new participants are allowed into the Plan and benefits were frozen.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Pension Benefits**

Effective July 1, 1997, a new formula for participant benefit calculations was adopted. Benefits will continue to be calculated under both the old and new formulas with participants receiving the larger of the two. The new formula is effective retroactively to January 1, 1997 and will cover all nonunion participants.

Benefits for nonunion participants are earned and paid based upon final average earnings determined by averaging the Plan participant's highest five full consecutive years of earned compensation. Under the old formula, for each year of service, a participant accumulates a monthly benefit equal to 1.55% of monthly earnings up to \$3,333, plus for each year of service, limited to 35 years, 0.65% of monthly earnings in excess of \$1,250 and up to \$3,333.

Under the new formula, for each year of service, a participant accumulates a monthly benefit equal to 1% of the final average monthly earnings multiplied by the years of benefit accrual service. Monthly benefits for years of service credited prior to January 1, 1976 are computed on a different basis.

Union participants with five or more years of vesting service are entitled to annual pension benefits if employment is terminated for any reason other than death, or before eligibility for a normal, early or deferred retirement benefit. Benefits are determined based on age at termination, specified monthly benefit levels, and number of years of service.

Benefit payments are made in the form of a life annuity. The monthly benefit level for McGregor union participants was increased to \$28.00 per year of service effective August 29, 2008. The monthly benefit level for Locust Grove union participants was increased to \$26.00 per year of service effective May 1, 2008.

**Vesting**

Under the terms of the Plan, participants are 100% vested in the Plan after five years of service or upon reaching the age of 65, whichever comes first. Participants may elect to receive monthly benefit payments upon reaching age 55 with a minimum of 10 years of vesting service; however, benefits are reduced for retirement before age 65 (normal retirement). An employee earns a year of vesting service for each 12-month period in which at least 1,000 hours of service are completed. In order to accumulate vesting service, an employee must be at least 18 years of age.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

As discussed in Note 1 to the financial statements, the Board of Directors of the Company authorized the termination of the Plan effective July 31, 2021 and the Plan processed all Plan assets out of the Plan as of December 31, 2022. As a result, the management determined that liquidation is imminent and the Plan changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of account would include any expected costs of the disposal of asset and other costs expected to be incurred during the liquidation process.

**Fair Value Measurements**

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. U.S. government securities are valued based on yields currently available on comparable securities of issuers with similar credit ratings. Cash in escrow is valued at cost, which approximates fair value. The cash was encumbered as of December 31, 2021 pending the final audits of the associated collective trust funds. The cash was released in July 2022.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the actuarial present value of accumulated plan benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the period. Actual results could differ from those estimates.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

Certain investment management, trustee, actuarial, legal and consulting expenses are paid by the Plan. All other expenses are paid by the Company.

**Risk and Uncertainties**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions and the actuarial present value of accumulated plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates, long-term return on investments and mortality, all of which are subject to change.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 12, 2023, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION AND INVESTMENTS**

All of the investments are held by SEI Private Trust Company, the trustee of the Plan. The Company has appointed SEI Investments Management Corporation to manage the Plan's assets. The trustee has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information presented in the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, statements of changes in net assets available for benefits for the years then ended, and the schedule of reportable transactions for the year ended December 31, 2022.

**NOTE 5 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' covered compensation. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included, to the extent they are deemed attributable to employee service rendered through the applicable freeze date (no later than December 31, 2012).

The actuarial present value of accumulated plan benefits is determined by the Plan's independent consulting actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of December 31, 2021 were: (a) retirement at normal retirement age (65); (b) life expectancy of participants (PRI-2012 total dataset projected with mortality improvement scale MP-2021); and (c) investment return 2.56%. The Plan changed its investment return assumption from 6.00% used in the December 31, 2020 valuation to 2.56% used in the December 31, 2021 valuation. The rate was changed due to the election to terminate the plan and obligations will be settled currently rather than over time.

Subsequent to the valuation date, the Plan settled all obligations to participants via processing lump sums or to settling remaining annuitant obligations with an annuity contract provider.

**NOTE 6 FUNDING POLICY**

The Company's contribution to the Plan is determined by the Plan's actuary and is intended to ensure that sufficient assets are accumulated to meet the benefits to be paid to Plan participants. Contributions by the Company for 2022 and 2021 equaled or exceeded the minimum funding requirements of the Employee Retirement Income Security Act of 1974 (ERISA). Participant contributions are not permitted.

**NOTE 7 TAX STATUS**

The Plan has received a favorable determination letter dated December 20, 2013 from the Internal Revenue Service (IRS) indicating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and that the related trust is exempt from federal income taxation under IRC Section 501(a). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. The trustee, SEI Private Trust Company, is considered to be a party-in-interest as defined by ERISA as a result of investing Plan assets. However, such transactions are exempt under ERISA.
