## Independent Auditors' Report

### **Opinion**

We have audited the accompanying financial statements of LL Ark Holding Company LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of October 14, 2022 (terminated), and the related statement of changes in net assets available for benefits for the period then ended (terminated), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits of LL Ark Holding Company LLC 401(k) Plan as of October 14, 2022 (terminated) and December 31, 2021 (ongoing), and the changes in its net assets available for benefits for the period ended October 14, 2022 (terminated), in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of LL Ark Holding Company LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter—Basis of Accounting**

As discussed in Note 7 to the financial statements, the governing body of LL Ark Holding Company LLC 401(k) Plan approved a plan of termination on October 1, 2022, and management implemented plans to terminate the plan and transfer all assets to another entity related plan. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ### (1) DESCRIPTION OF THE PLAN

The following description of the LL Ark Holding Company LLC 401(K) Plan (the "Plan"), is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

#### (a) General

The Plan is a participant directed defined contribution plan sponsored by LL Ark Holding Company LLC (the "Company") under the provision of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in section 401(K) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed two months of service, as defined, are eligible to participate, provided they are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan's management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan's tax status is described in Note 5 to the financial statements. The Plan has been amended from time to time in order to comply with regulatory requirements. The Company, accordingly, believes that these amendments are in compliance with regulations.

#### (b) Plan Administration

Ascensus Trust Company is responsible for the custody and management of the Plan's assets. The Company is represented by the trustees of the Plan. The trustees of the Plan are appointed by the Company.

#### (c) Contributions

Eligible employees can contribute up to 100% of their pretax annual compensation as defined by the Plan, subject to certain limitations under the IRC. The Company may, in its discretion, make a matching contribution equal to 50% of the participant elective deferrals that do not exceed 2% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

#### (d) Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions, as well as the participant's share of the Plan's income and any related administrative expenses.

## Notes to Financial Statements, Continued

## (1) DESCRIPTION OF THE PLAN (Continued)

Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) Vesting

Effective March 1, 2019, the Plan provides immediate 100% vesting for all participant contributions including elective deferrals, employer match and plan earnings and gains. The 100% vesting provision applies to an employee that is employed on or after March 1, 2019. For participants that separated from service prior to March 1, 2019 (unless due to death, disability or normal retirement) their employer matching contributions are subject to the following 6-year graded vesting schedule:

Six or more	100%

Forfeitures may be used to reduce the employer's contribution to the Plan or to pay administrative expenses of the Plan. As of October 18, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 for both periods.

(f) Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A participant may have one Plan loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest based on the prime rate, as specified in the Wall Street Journal and range from 3.25% to 5.5%. Loans are repaid through payroll withholdings unless the participant elects to pay the loan in full, and must be repaid within five years unless the loan is used to acquire a principal residence. Loan balances unpaid upon a participant's termination are reclassified as participant deemed distributions unless paid in full. Participant loan balances were transferred to the new merged plan based on the balances at the date of transfer.

(g) Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance. For termination of service for other reasons, a

participant may elect to defer payment until normal retirement age, receive a lump-sum payment or a direct rollover to another qualified plan or IRA, provided that participant's vested account balance is greater than \$1,000.

### (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### (a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America and in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### (b) Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### (c) Investment Valuation and Income Recognition

Investments are stated at fair value determined by quoted market prices, which represents the net asset value of shares in mutual funds held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### (d) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or one half of the present value of the nonforfeitable account balance of the participant. Loans are secured by the balance in the participants account. Loan terms include a five year repayment plan unless used to acquire a personal residence. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses through the October 14, 2022 date of transfer to the merged plan. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses

The Plan's administrative expenses are paid either by the Plan, the Company or the participant, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Expenses relating to an individual participant's activity (loan fee, distribution fee, etc.) are paid by the participant and recorded as administrative expenses. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in the net appreciation (depreciation) of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

(3) INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2021 and the related termination and transfer of assets at October 14, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the short year ended October 14, 2022 and the year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, agent for Ascensus Trust Company, the custodian of the Plan.

#### (4) FAIR VALUE MEASUREMENTS OF INVESTMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures* provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at the date of transfer October 14, 2022 or the year ended December 31, 2021.

Interest bearing money market funds are valued at redemption value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain tax positions taken or expected to be taken.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (7) PLAN TERMINATION AND MERGER

The administrative committee of the Plan on October 1, 2022 approved the termination of the Plan and subsequent transfer of all plan assets to the Luther Holding Company Savings Plus Retirement Plan. In accordance with the election, all Plan assets as of the date of transfer were merged into the new plan thus terminating the LL Ark Holding Company LLC 401(k) Plan as of October 14, 2022.

### (8) TRANSACTIONS WITH PARTIES-IN-INTEREST

Under ERISA, parties-in-interest are defined to include the Plan sponsor, officers, directors, and employees of the sponsor; direct and indirect owners of the sponsor, and their relatives, if they have combined voting power of 50% or more; the Plan custodian or trustees and the Plan administrator; other parties with fiduciary responsibilities; and a person and his or her relatives to an organization that provides services to the Plan such as the Plan actuary, auditors, lawyers, investment advisors, etc.

The Plan's investments were managed by Regions Bank and Ascensus LLC, the custodians as defined by the Plan, and were subject to a plan services agreement. Therefore, Plan custodial and administrative services qualified as party-in-interest transactions. Accounts managed by the custodians totaled \$17,547,596 at December 31, 2021.

Fees paid to the Plan's custodians, which qualify as party-in-interest transactions, amounted to \$136,177 for the period ended October 14, 2022.

### (9) CONCENTRATIONS

In 2021, approximately 10% of the assets held by the Plan are accounted for in one underlying mutual fund. There are no remaining assets in the Plan as of the termination and merger date of October 14, 2022.

### (10) SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 3, 2023, which is the date the financial statements were available to be issued. Management has accepted the financial statements and did not identify any events subsequent to October 14, 2022 requiring disclosure in the financial statements.
