In connection with the Forms 5500 that Renewable Energy Group ("REG") filed via eFAST on behalf of the Renewable Energy Group, Inc. Health & Welfare Plan for each of the following years 2006-2021 under the Delinquent Filer Voluntary Corrections Program ("DFVC"), please see enclosed check in the amount of \$4,000 for the above-named plan DFVC submission.

This DFVC submission has been filed out of an abundance of caution following the due diligence review of REG's benefit plans by Chevron Corporation in connection with its acquisition of REG. From 2006 to 2021, REG contributed to and participated in the Cooperative Welfare Benefits Plan ("Co-op Plan"), a multiple employer welfare arrangement administered by Association Benefits Corporation ("ABC"). For each of these years, it was represented to REG that the Cooperative Welfare Benefits Fund (and its Board of Trustees) was both the "plan sponsor" and "plan administrator" of the Co-op Plan and that none of the employers that contributed to the Co-op Plan, including REG, was required to file the Form 5500. Of note, annual returns were filed for the Co-op Plan with the Department of Labor during this period; on these Forms 5500, the Board of Trustees of the Cooperative Welfare Benefits Fund was identified as the Co-op Plan's "plan sponsor" and signed the return as such, while ABC was identified as the Co-op Plan's "plan administrator" and similarly signed the return in that capacity. Because there is a possibility that the Cooperative Welfare Benefits Fund (or its board) may not qualify as a proper "plan sponsor" under ERISA, REG has taken the extra precaution of opting to file a DFVC submission on behalf of the above referenced plan as part of the termination of such plan.

Given REG's past understanding of the health and welfare benefits it provided and employee turnover over the last 10+ years, REG's records regarding such benefits is, unfortunately, sparse. As such, we have completed the Forms 5500 to the best of our ability based on the information available to us.
