Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Edgewood Centre 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 14, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 thru November 14, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Edgewood Centre 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of November 14, 2022 and December 31, 2021, and for the period ended January 1, 2022 to November 14, 2022, and the year ended December 31, 2021, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Edgewood Centre 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

As discussed in Note D, the Company terminated the plan on November 14, 2022. Participant contributions ceased August 12, 2022 and all participant account balances were distributed to participants as of November 14, 2022.

NOTE A DESCRIPTION OF PLAN

The following description of the Edgewood Centre 401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering employees of the Company who have completed six months and 1 hour of service and have reached their 21st birthday. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was adopted January 1, 1995.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, subject to annual IRS dollar limits (\$20,500 in 2022 and \$19,500 in 2021). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Although the Company has not made contributions to the Plan, it may, at the option of the Company's board of directors.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon less administrative expenses of the plan.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note G for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates at 4.25-5.25%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. At November 14, 2022 and 2021, the balances were \$- and \$67,995, respectively.

Allowance for Doubtful Accounts

The plan considers allowance for doubtful accounts to be amounts that would not be collectible by the plan. All participant loans are secured by vested participant balances. Therefore, there is no allowance for doubtful accounts at November 14, 2022 and 2021.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles require management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE E INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into an investment contract with John Hancock Life Insurance Company (John Hancock). John Hancock maintains the contributions in pooled separate accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by John Hancock. The contract is included in the financial statements at contract value as reported to the Plan by John Hancock. Contract value represents contributions made under the contract, plus earnings, less Plan withdrawals and administrative expenses.

NOTE F TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

NOTE G FAIR VALUE MEASUREMENTS

The Plan has implemented *Fair Value Measurements*. Accounting standards established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities:
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The Plan investment assets at fair value as of November 14, 2022 and December 31, 2021 (\$- and \$3,292,705, respectively) are not leveled because they are valued at NAV as a practical expedient. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

NOTE G FAIR VALUE MEASUREMENTS (continued)

Pooled Separate Accounts: Valued at the NAV of units of a mutual fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Subject to limitations in the Plan Document, participants may make withdrawals to make bona fide benefit payments in accordance with the plan provisions, to direct their own investments, to make participant loans, and to pay fees.

NOTE H RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The employer, Edgewood Manor, Inc. provides administrative services to the plan at no charge.

Certain plan investments are managed by John Hancock Life Insurance Co (USA). John Hancock Co (USA) is the trustee and performs recordkeeping services for the plan and therefore, these transactions qualify as party in interest transactions. John Hancock Life Insurance Co (USA) receives indirect compensation for providing these services.

NOTE I SUBSEQUENT EVENTS

The Company has evaluated subsequent events through June 30, 2023, which is the date these financial statements were available to be issued. All subsequent events requiring recognition as of November 14, 2022, have been incorporated into these financial statements herein.
