INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anderson Companies Employees 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of July 19, 2022 (liquidation date) and December 31, 2021 (in liquidation), and the related statements of changes in net assets available for benefits (in liquidation) for the period January 1, 2022 through July 19, 2022 (liquidation date), and for the year ended December 31, 2021 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Anderson Companies Employees 401(k) Plan in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution for the period from January 1, 2022 through July 19, 2022 (liquidation date), and for the year ending December 31, 2021 (in liquidation) stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Anderson Companies Employees 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter Relating to Plan Liquidation

As discussed in Note A, effective April 30, 2021, Anderson Fabrics, Inc. was bought and acquired by TSS (The Shade Store). As a condition of the sale, the Plan was merged into TSS Plan and discontinued contributions effective July 7, 2022. The plan did not make an application for termination with the Internal Revenue Service (IRS). The plan had also changed its basis of accounting to liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Anderson Companies Employees 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is

not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Anderson Companies Employees 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Anderson Companies Employees 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other

records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

A. Description of Plan

The following description of the Anderson Companies Employees 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Anderson Fabrics, Inc. (“Company”) who prior to July 1, 2021 must have a minimum of 90 days and 250 hours of service, and are age 19 or older. Effective July 1, 2021, employees must be 21 years of age or older and have minimum of 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Custodian, John Hancock Life Insurance Company, is responsible for the oversight of the Plan. They also serve as the Investment Committee and determine the appropriateness of the Plan’s investment offerings, monitor investment performance, and report to the Company’s Board of Directors.

Plan Liquidation - On April 30, 2021, the Company was acquired by TSS (The Shade Store). As a condition of the sale, the plan would be merged into the existing plan at TSS. As of July 1, 2022, all employees eligible under the Plan became eligible to participate in the plan sponsored by TSS. Accordingly, no employee deferrals and no employer matching contributions were made to the Plan for pay dates after July 7, 2022. On July 19, 2022, 100% of the Plan assets were transferred to the TSS Plan. Plan management believes it has structured the transfer in a manner that does not constitute a plan termination. Participant activity subsequent to July 7, 2022 will be transacted under the TSS Plan.

Contributions – Prior to the Company’s decision to merge the Plan, each year, participants were able to contribute, on a pretax basis, any amount of gross pay up to the applicable contribution limit. The maximum amount was \$20,500 and \$19,500 in 2022 and 2021, respectively, plus an additional \$7,500 and \$6,500 catch up contribution for participants age 50 and over in 2022 and 2021, respectively. Participants were also able to contribute certain rollover amounts representing distributions from other qualified defined benefit or contribution plans. Prior to July 1, 2021, the Company matched 50% of employee 401(k) contributions up to 4% of compensation. Thus, the maximum Company match was 2% of a participant’s gross earnings. After July 1, 2021, the Company changed to a graded scale for matching. From 0% to 3% matching was 100%, and from 3% to 5% matching was 50%. The Company could make discretionary non-elective contributions to the Plan which was allocated to each participant’s account based on their individual compensation as a percentage of total compensation, although the Company was not required to do so. During the years ended July 19, 2022 and December 31, 2021, the Company did not make any non-elective contributions. Contributions were subject to certain statutory limitations.

Participant Accounts – Each participant’s account was credited with the participant's contribution and allocations of (a) the Company’s matching contribution, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Prior to the Company’s decision to merge the Plan, participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts plus actual earnings thereon was based on years of service. A year of service was considered 1,000 hours, and a participant was 100% vested after four years of credited service according to the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of normal retirement age.

Payment of Benefits – Prior to the Company’s decision to merge the Plan, upon termination of service, or due to death, disability, or retirement, or upon request and acceptance of a hardship distribution, a participant could receive a lump-sum payment in an amount up to the value of the vested interest in his or her account, less any applicable tax withholdings and fees. Employees could elect in-service withdrawals of vested account balances upon attaining age 59 ½. Generally, certain minimum distributions were required for participants who had separated from service and had reached the required age. The Plan allowed for hardship withdrawals, subject to account balance limits and applicable laws.

As permitted by the CARES Act, participants were allowed to take special coronavirus-related distributions in an amount up to \$100,000 of the participant’s vested balance without incurring early withdrawal tax penalties regardless of age, between April 21, 2020 and December 29, 2020. For three years following the date of the CARES Act distribution, the participant had the option to repay the full amount of the distribution taken.

Prior to the Company’s decision to merge the Plan, terminated participants with account balances of \$5,000 or less received a lump-sum cash payment as soon as administratively practicable upon the participant’s employment termination.

Notes Receivable from Participants - The Plan was amended on July 1, 2021 to allow for participant loans. Subsequent to this amendment, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants were allowed to have up to two outstanding loans. The loans were issued directly from fund balances in the participant’s account. These loans were included in the statements of net assets available for benefits. All notes were secured by the balance in the participant’s account and bear interest rates equal to prime plus two percent, established by John Hancock Life Insurance Company. Principal and interest were to be paid ratably through monthly payroll deductions, amortized over a period not exceeding five years, except in the purchase of a primary residence. There were no loans outstanding at July 19, 2022 and December 31, 2021.

Forfeited Accounts – Prior to the Company’s decision to merge the Plan, if participants terminated employment with the Company prior to being 100% vested in their account balance, they forfeited the non-vested interest in such account balance. Such forfeitures were to be used to pay Plan expenses or they could be used to reduce future employer matching contributions under the Plan. At July 19, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$2,544, respectively. There were supplemental administrative service fees paid from the forfeited non-vested accounts of \$750 in 2022 and 2021.

B. Summary of Significant Accounting Policies

Basis of Accounting – Due to the decision to merge the Plan, liquidation is imminent. The financial statements of the Plan were prepared on the liquidation basis for the years ended July 19, 2022 and December 31, 2021. Prior to December 31, 2021, the financial statements were prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account, are deducted from the loan proceeds when the loan was originated. As of July 19, 2022 and December 31, 2021, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits – Benefit payments to participants were recorded when paid. At July 19, 2022 and December 31, 2021, there were no benefit claims payable for distributions to participants from the Plan prior to the end of the Plan year.

Investment Valuation and Income Recognition – Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodian. See Note F for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses – The Plan's expenses were paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. The Custodian charges fees directly to the participants' accounts equal to \$2 per month per active participant. The third-party administrator charges participant fees of \$75 for each withdrawal. These expenses along with other asset and administrative fees to maintain participants' accounts within the Plan that are paid by the Plan were recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses were included in net appreciation (depreciation) of fair value of investments.

Date of Management's Review – Subsequent events were evaluated through July 20, 2023, which is the date the financial statements were available to be issued.

C. Risks and Uncertainties

Prior to the Company's decision to merge the Plan, the Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits (In Liquidation).

D. Tax Status

The Plan was a Volume Submitter Plan sponsored by the Third-Party Administrator and adopted by the Company. The Internal Revenue Service (IRS) has informed the Third-Party Administrator by an opinion letter dated March 31, 2014, that the Volume Submitter Plan is acceptable under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan continued to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however there are currently no audits for any tax periods in progress.

E. Information Prepared and Certified by the Trustee of the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's investments were held in trust and administered by the Trustee of the Custodian, John Hancock Life Insurance Company (U.S.A.) for the years ended July 19, 2022 and December 31, 2021. Accordingly, as permitted under such an election, all investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee of the Custodian.

F. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy are defined under the FASB Accounting Standards Codification 820, *Fair Value Measurements*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- **Quoted prices for similar assets or liabilities in active markets**
- **Quoted prices identical for similar assets or liabilities in inactive markets**
- **Inputs other than quoted prices that are observable for the asset or liability**
- **Inputs that are derived principally from or corroborated by observable market data by correlation or other means**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There are no Plan assets requiring the use of Level 3 inputs for the period presented.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 19, 2022 and December 31, 2021:

Pooled Separate Accounts and Insurance Company General Account – Valued at the Net Asset Value (NAV) of units as determined by the Insurance Company based on the underlying investments held by the separate account. NAV is a readily determinable fair value and is the basis for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair market value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended July 19, 2022 and December 31, 2021, there were no transfers between Level 1 and 2, and no transfers into or out of Level 3.

G. Related Party and Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others.

Prior to the Company's decision to merge the Plan, certain Plan investments were shares of mutual funds which were offered by John Hancock Retirement Plan Services, which is an affiliate of the Plan Custodian. John Hancock Insurance Company (U.S.A.) is the Plan Custodian and, therefore, these transactions and the Plan's payment of custodian fees qualify as party-in-interest transactions.

Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses for the Plan were paid directly by the Company and amounted to \$14,562 and \$14,200 for the years ended July 19, 2022 and December 31, 2021, respectively.

All of the party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.
